

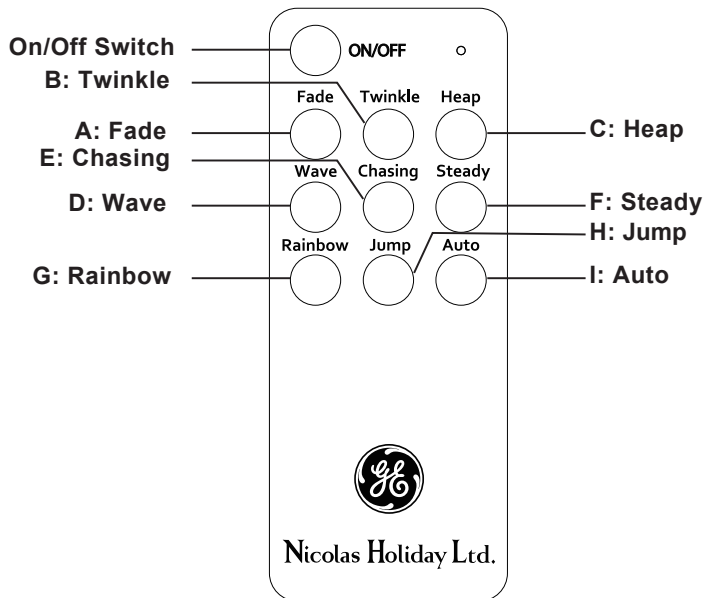

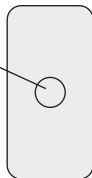

Control Box

The Remote Control for indoor use only.

The Power ON/OFF functions and lighting modes can be controlled with either the remote control or the control box.

Letters A to I : correspond to the 9 function keys identified on the remote control, which correspond to the functions list below. For example, press the key A to cycle the function of A switch in the list. Press the key B to cycle the function of B switch in the list, the corresponding function is twinkle.

Function Switch: Some functions of the product can be shown through the Function Switch of the Control box. The corresponding function order is Key A, Key B, Key C, Key D, Key E, 1-8 of the Key F, Key G, Key H, Key I, and OFF function.

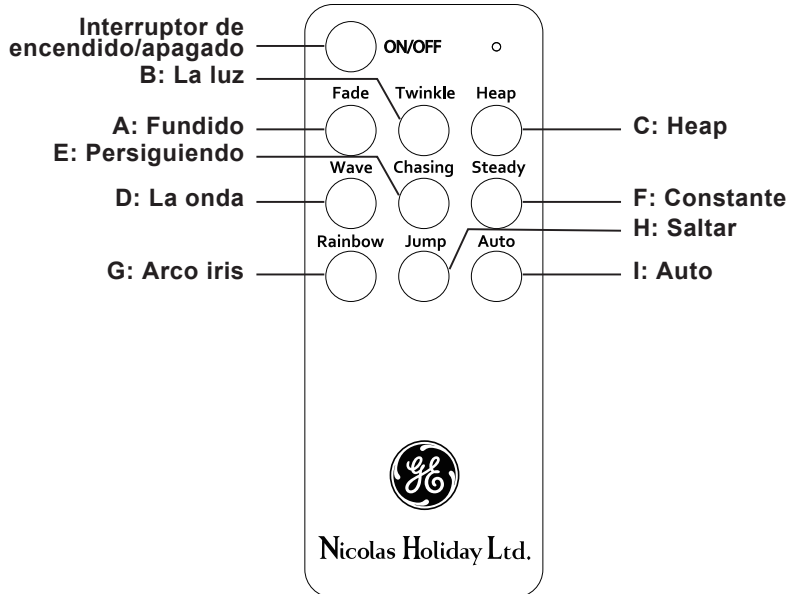

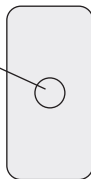
El mando a distancia sólo para uso en interiores.

Las funciones de encendido/apagado de la alimentación y los modos de iluminación se pueden controlar con el mando a distancia o la caja de control.

Letras A A I: corresponden A las 9 teclas de función identificadas en el control remoto, que corresponden A la lista de funciones A continuación. Por ejemplo, pulse la tecla A para mover la función de un interruptor en la lista. Pulse la tecla B para ciclo de la función de interruptor B en la lista, la función correspondiente es Twinkle.

Interruptor de función: algunas funciones del producto pueden ser mostradas a través del interruptor de función de la caja de Control. El orden de función correspondiente es clave A, clave B, clave C, clave D, clave E, 1-8 de la clave F, clave G, clave H, clave I, y función OFF.
