## 2. Antenna requirement

The antenna is a **Rod Antenna**, and the best case gain of the antenna is **3.06dBi**. It complies with the standard requirement.



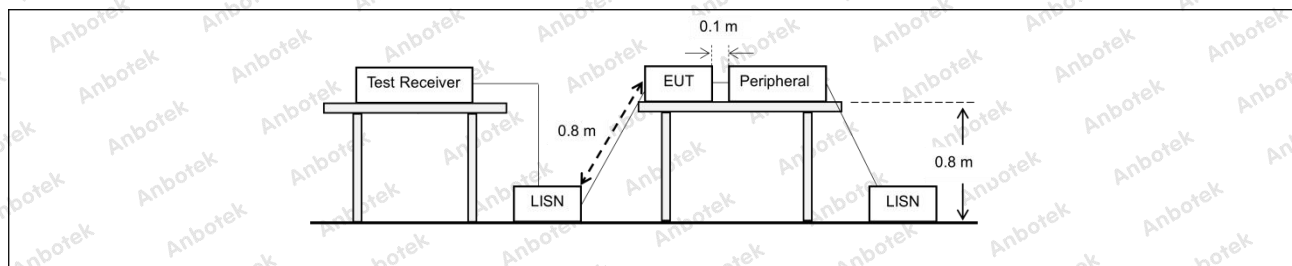
