Test Graph for Average Measurement



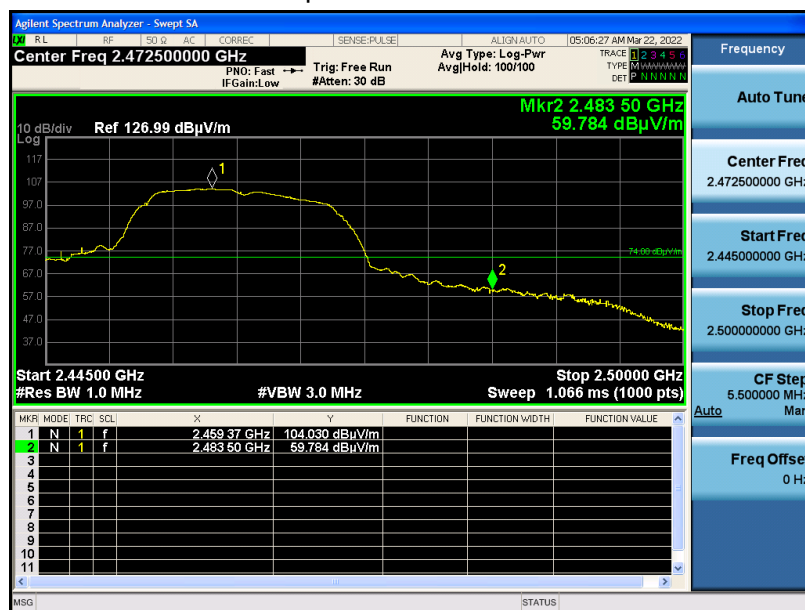
