


Before connecting, enable bluetooth of cellphone.</p> <p>Make sure you're connecting to a 2.4GHz Wi-Fi network. (It can't connect to 5GHz networks)</p> <p>Turn on the bulb 3 times(on-off-on-off-on), confirm light bulb is flickering rapidly. (2 times per second). Note: if network configuration takes more than 8 minutes or fails. Reset the bulb(turn on the bulb 3 times again as mentioned above).</p> <p>There are two ways to connect with the bulb, one is Add manually, the other is Auto scan</p> <p>4</p>
