GENERAL INFORMATION

1.INSTALLING RECEIVER IN CEILING FAN

A. Safety precautions:

WARNING: HIGH VOLTAGE! Disconnect power by removing fuse or switching off circuit breaker.

Do not use with solid state fans.

Electrical wire must meet all local and national electrical code requirements.

B. Electrical rating: 110/120V 50/60Hz

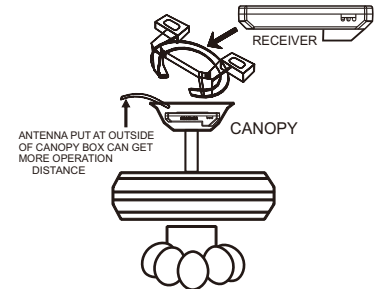
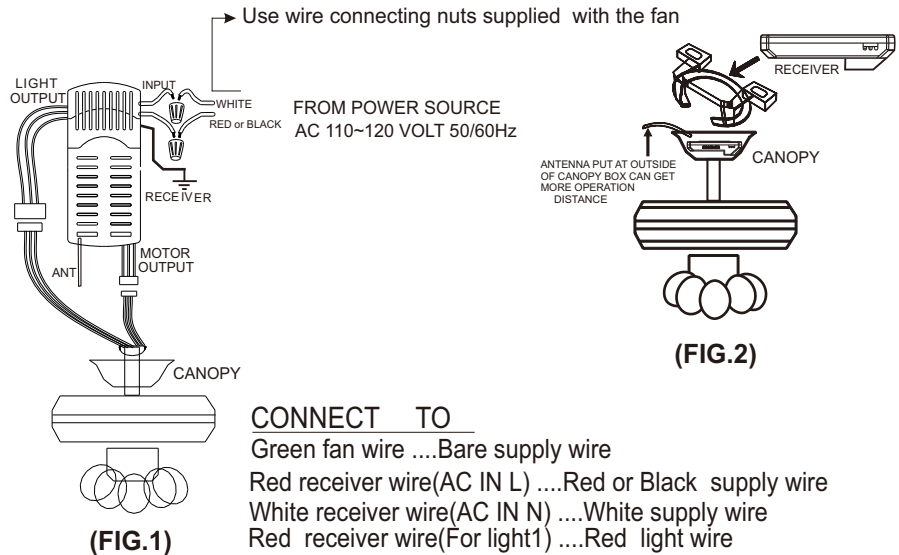
MAX. Motor watts: 40W

MAX. Light watts: 20W

Otherwise power can cause serious injury or death.

C. Installing receiver in fan: **(FIG.2)**

- Remove power from the circuit.
- Remove ceiling fan canopy from the mounting bracket.
- Disconnect existing wiring between ceiling fan and Supply in electrical junction box.
- Make connections as follows, using the wire nuts supplied: **(FIG.1)**



CONNECT TO

Green fan wireBare supply wire

Red receiver wire(AC IN L)Red or Black supply wire

White receiver wire(AC IN N)White supply wire

Red receiver wire(For light1)Red light wire

Yellow receiver wire(For light2)yellow light wire

White receiver wire(For light3)white light wire

White/Blue receiver wire(TO MOTOR 1)White/Blue fan wire

Black/Brown receiver wire(TO MOTOR 2)Black/Brown fan wire

Red receiver wire(TO MOTOR3)Red fan wire


2. OPERATING TRANSMITTER :

A. Install 203 2 3 volt battery.

(To prevent damage to transmitter, remove the battery if not used for a long time).

B. Store the transmitter away from excessive heat or humidity.

C. Operating the buttons on the panel of the transmitter. (FIG.3)

D. Keep pressing the light button  in excess of 0.7 second and it becomes a dimmer.

D. Setting the codes on the receiver:

The Learn Key must be pressed within 5 seconds, after pressing the Power button.

If not, please press the Power button to restart.

Keep pressing the button LEARN key in excess of 3 seconds it becomes a LEARN status.

The receiver can remember the last codes status.

The ceiling fan light flash two times. (FIG.4)
