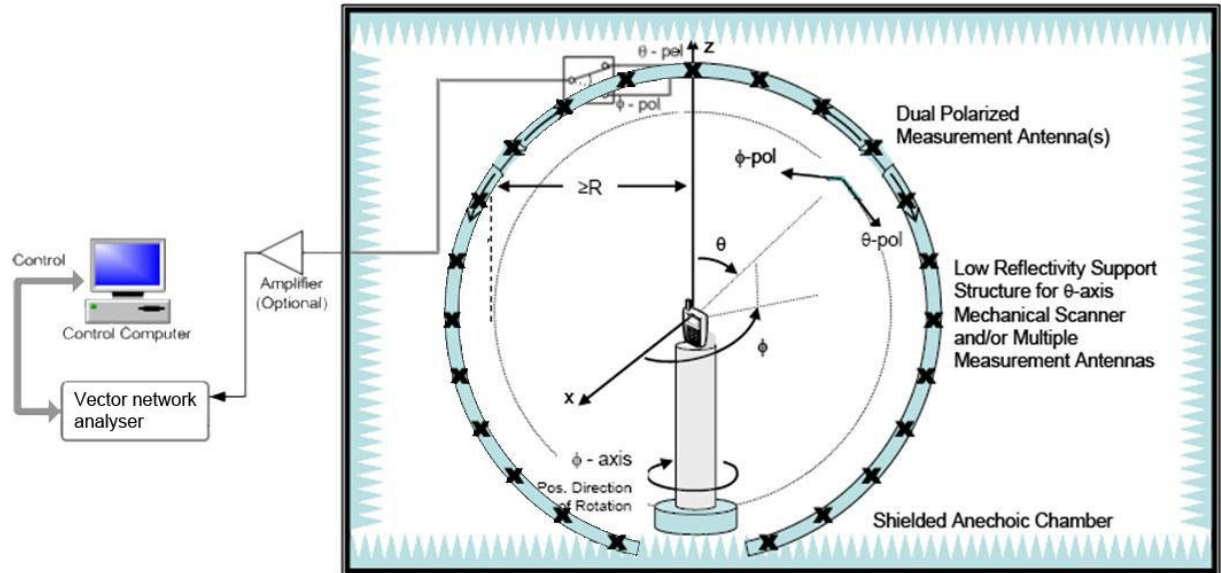

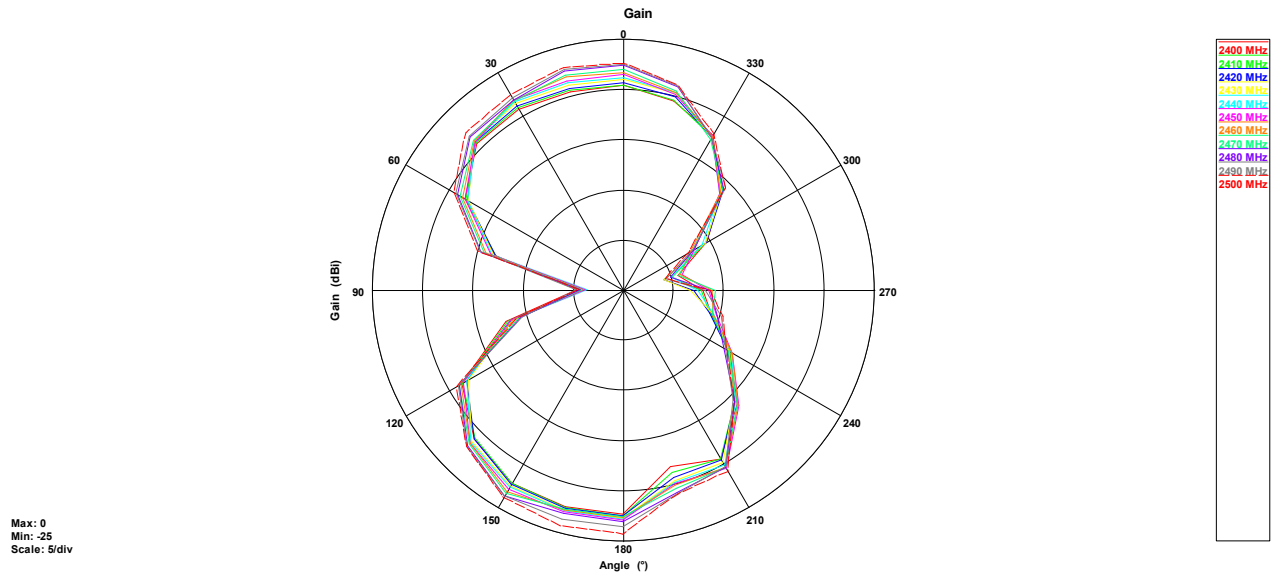

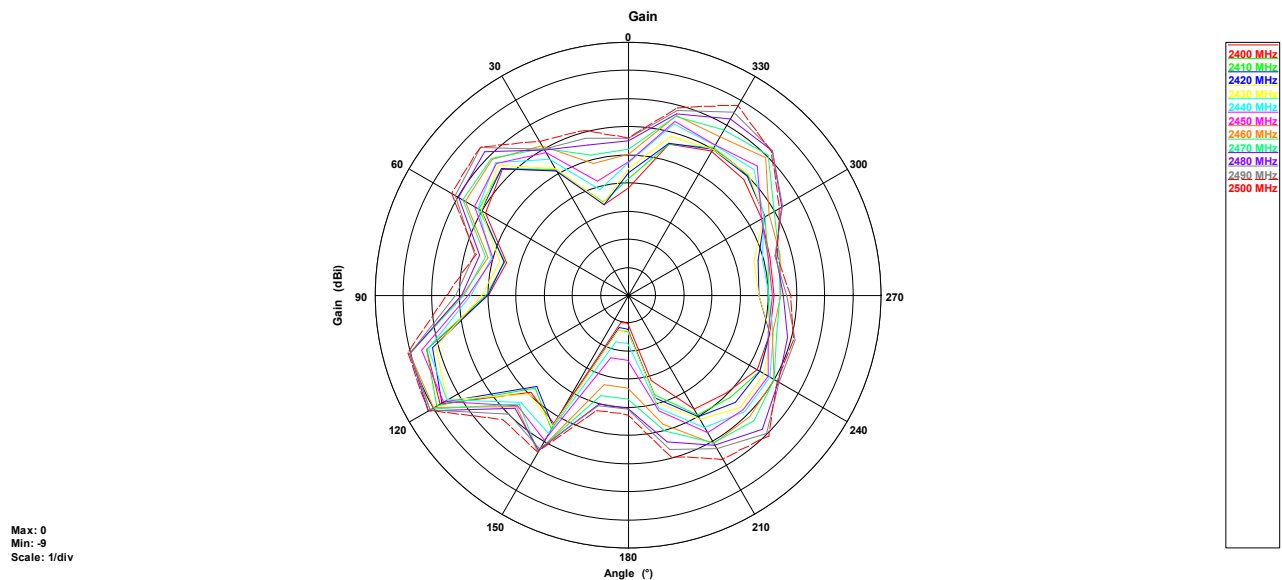

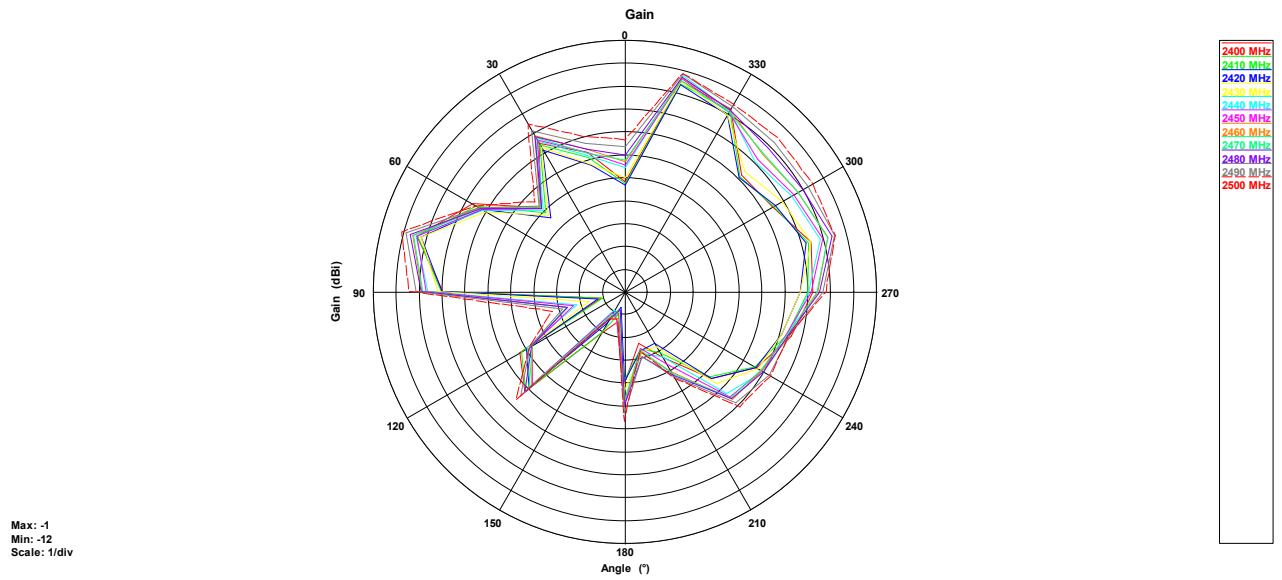
1. 2D Radiation Pattern



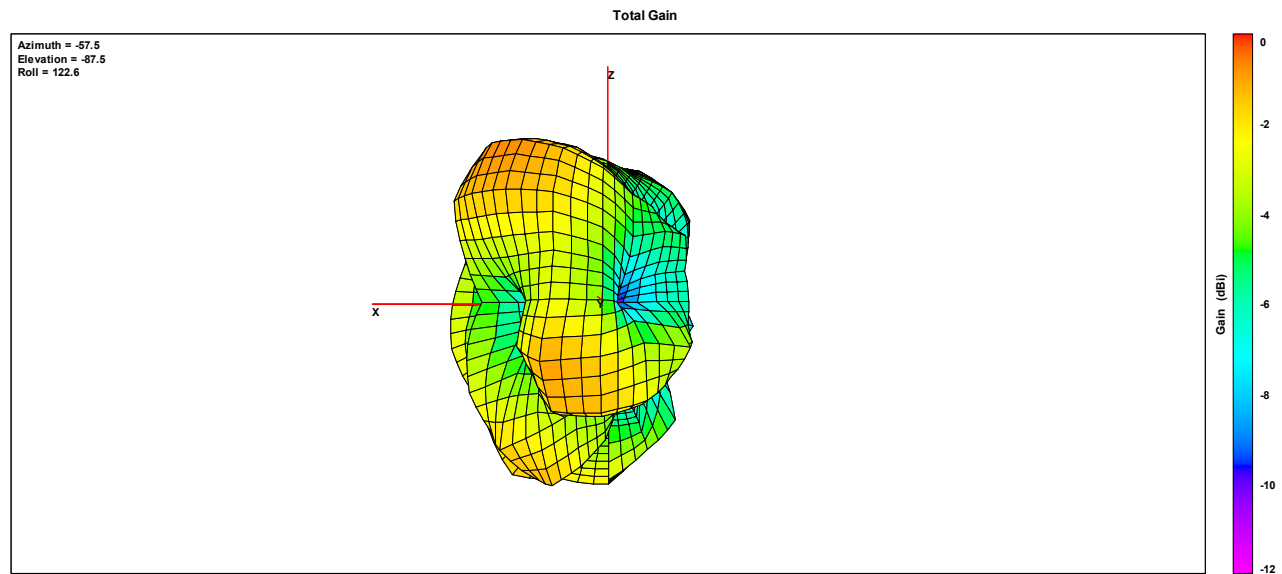

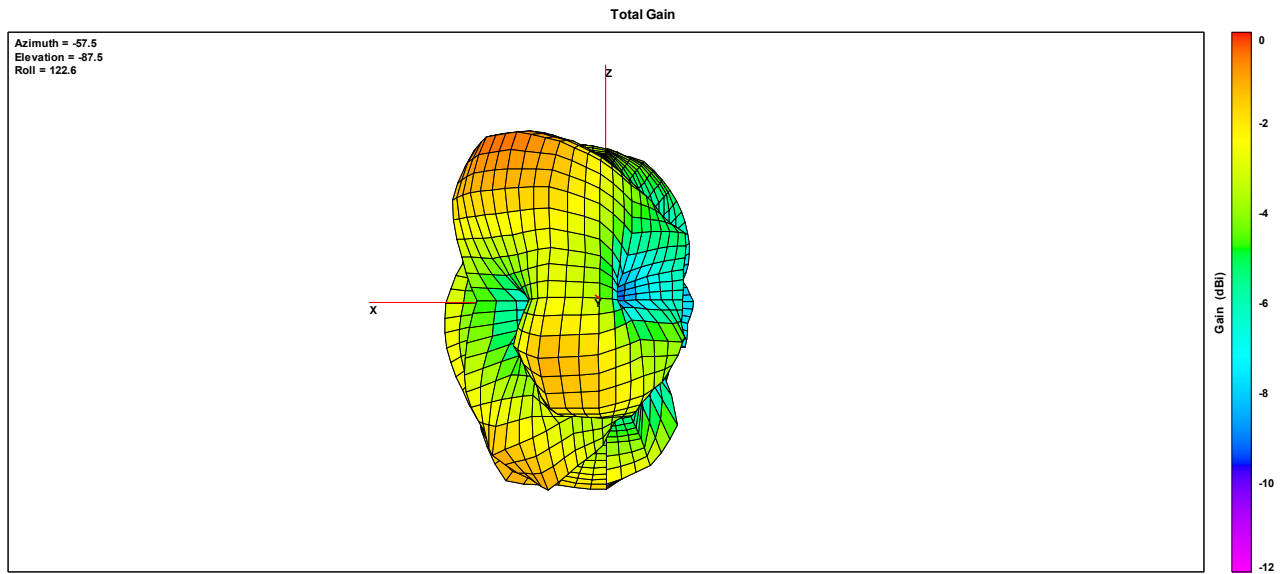

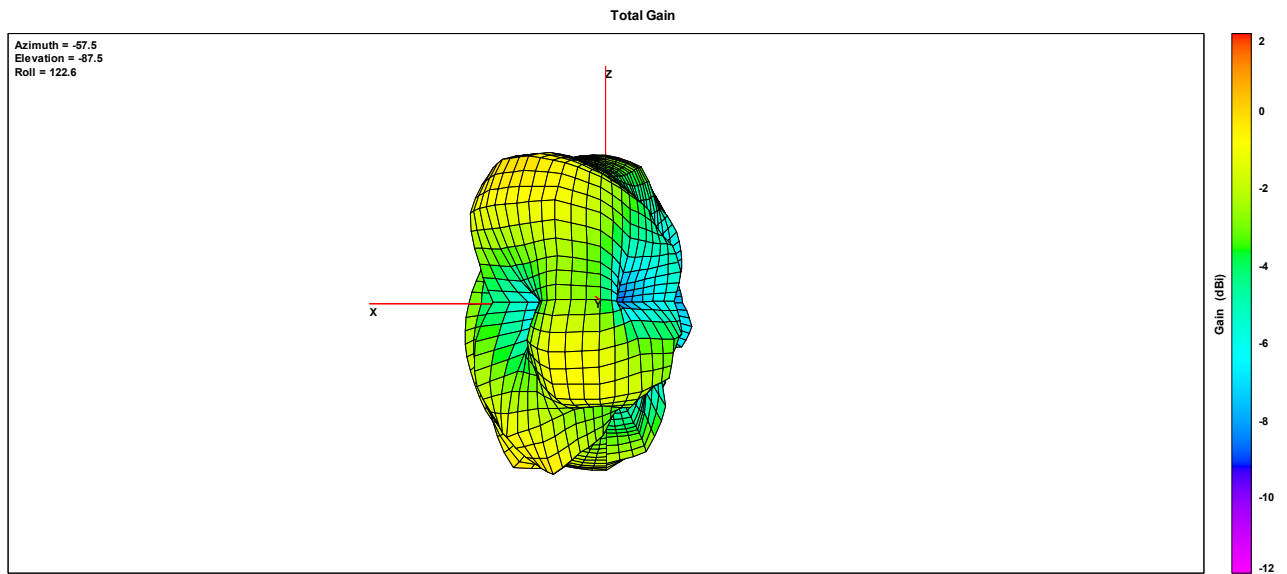
2. 3D Radiation Pattern
