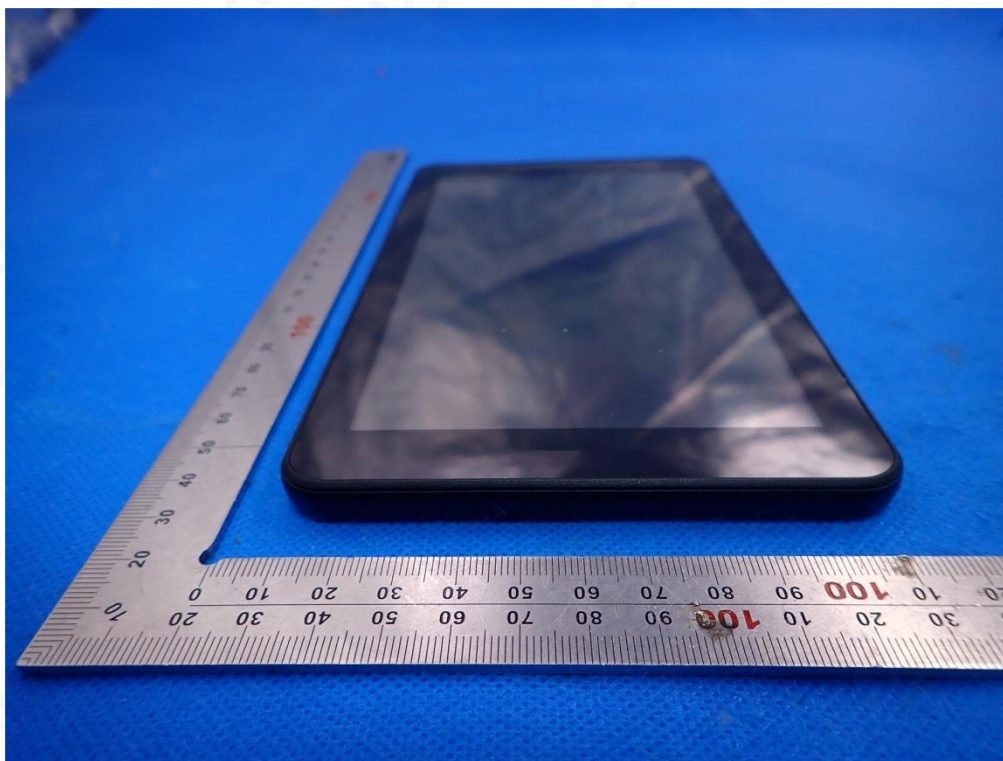
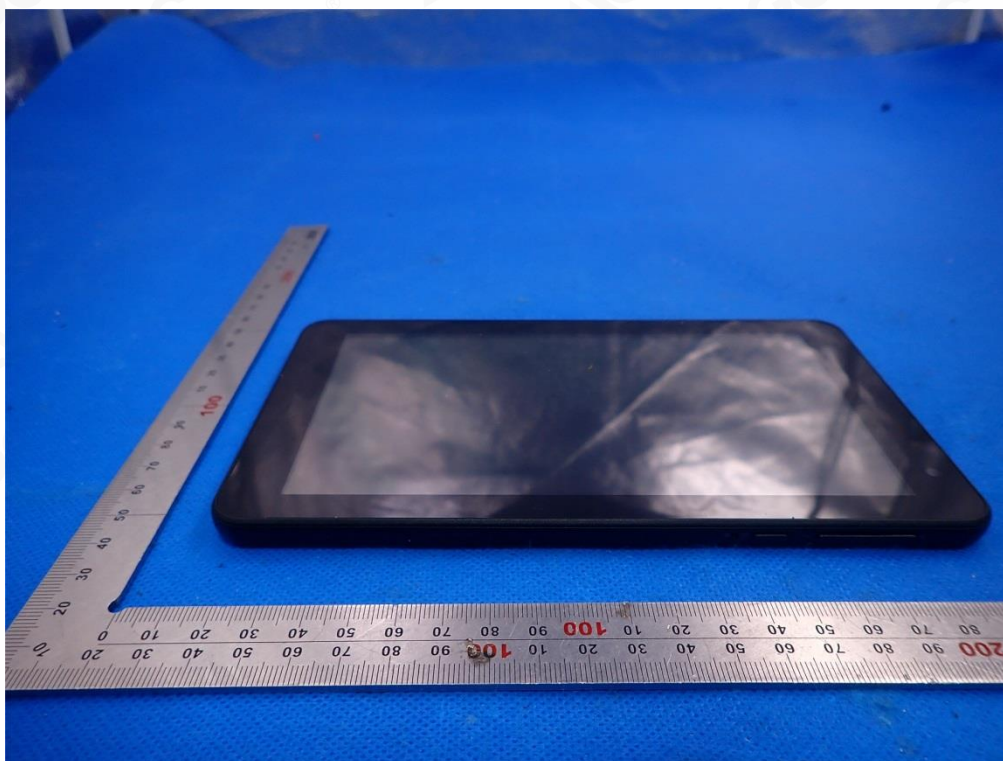

LEFT VIEW OF EUT

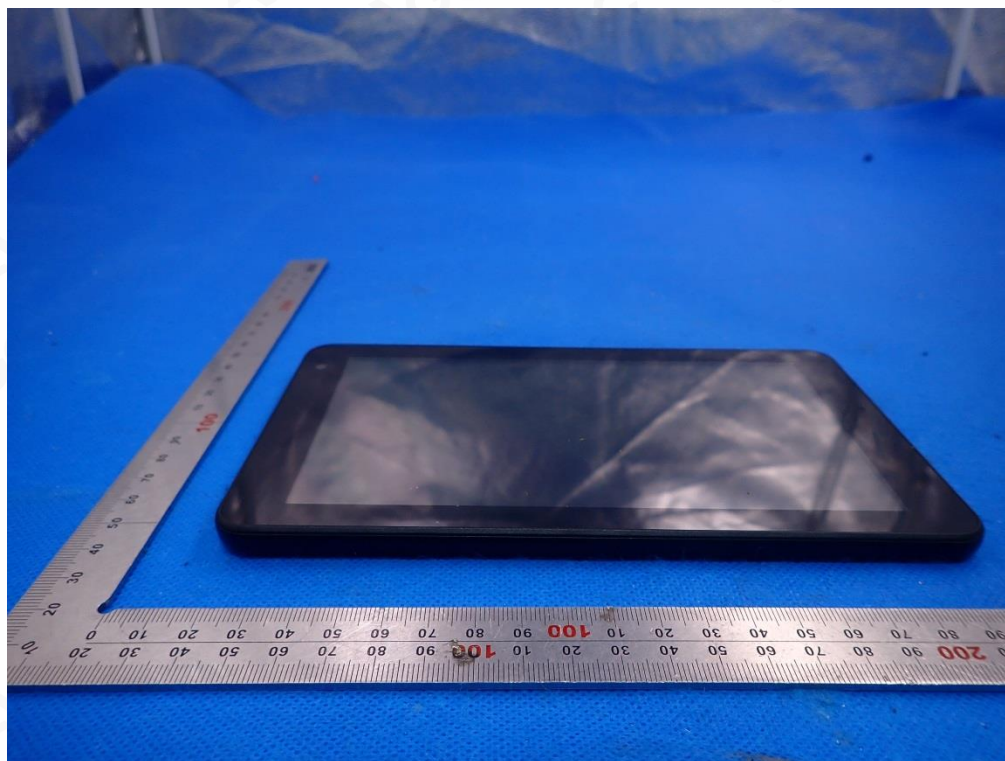

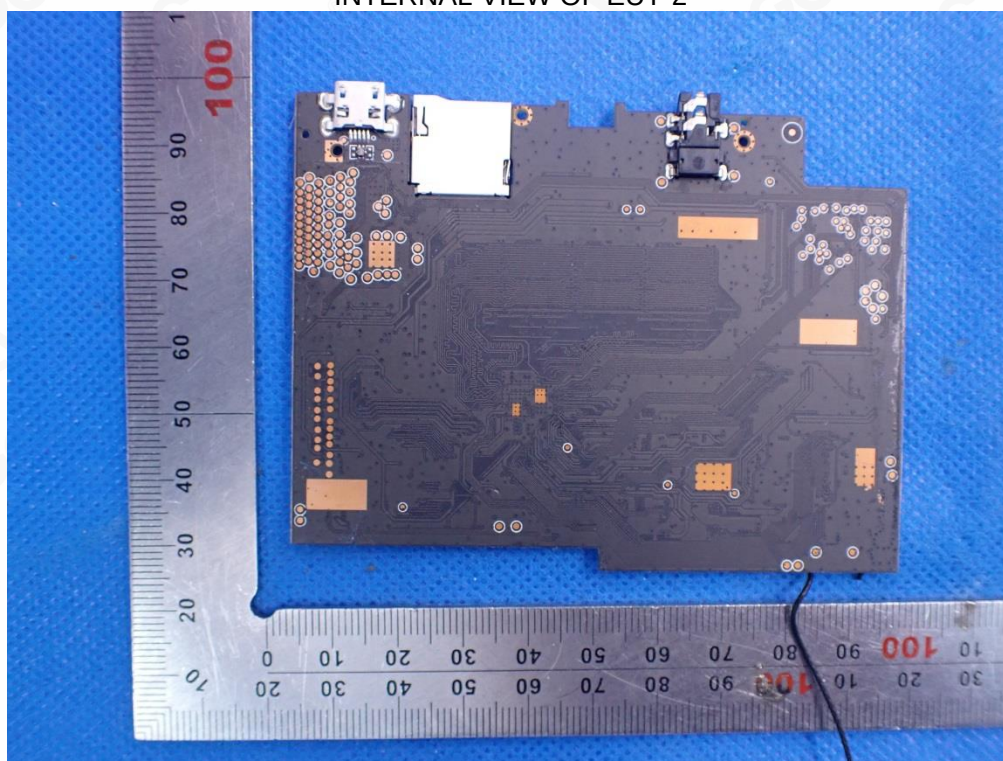

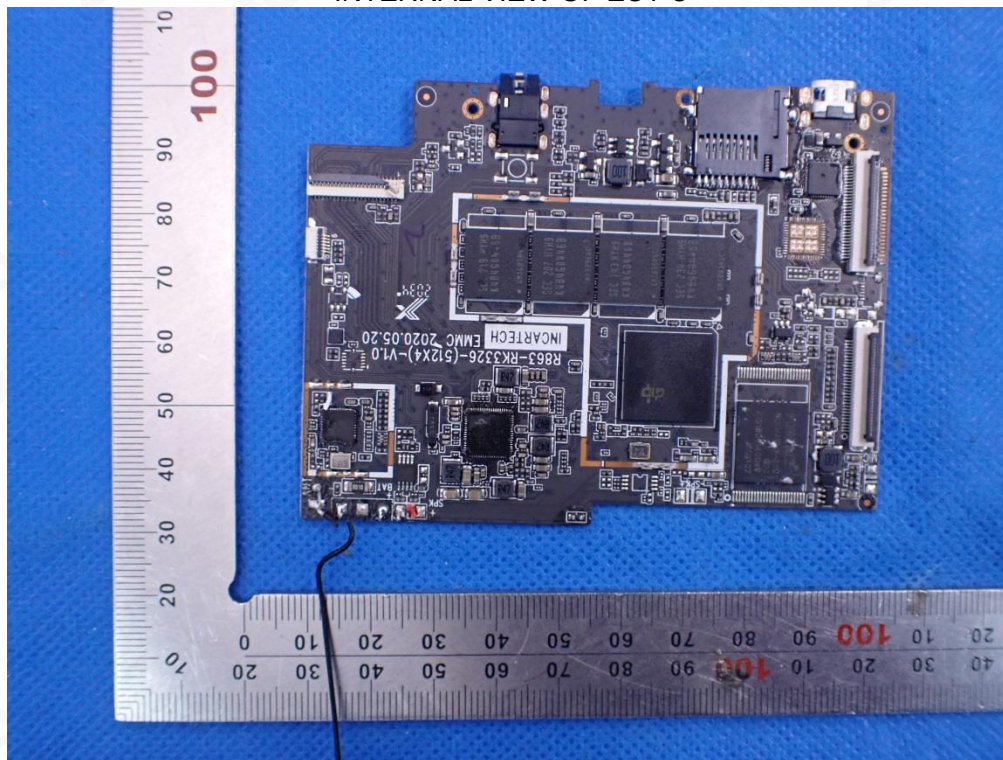

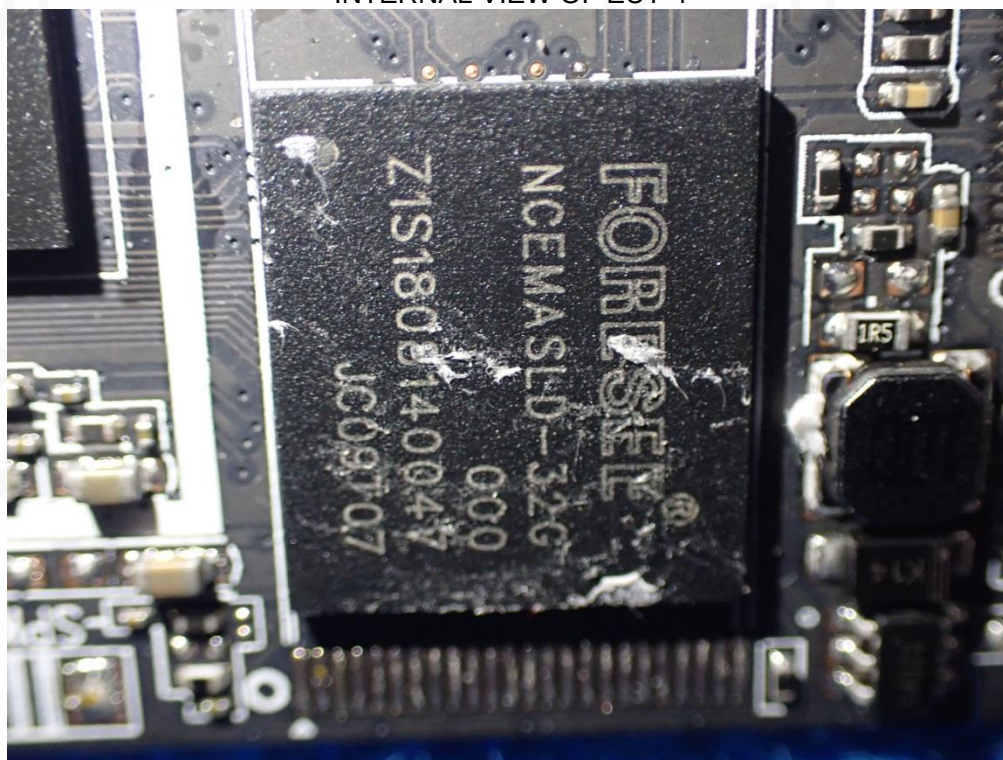

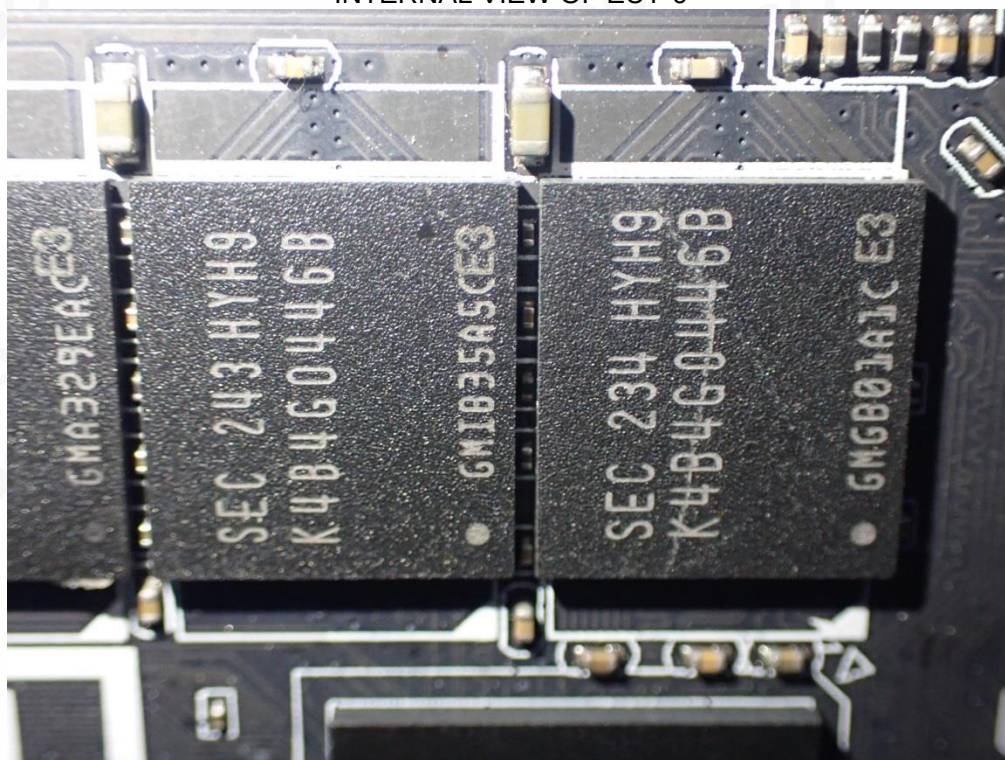

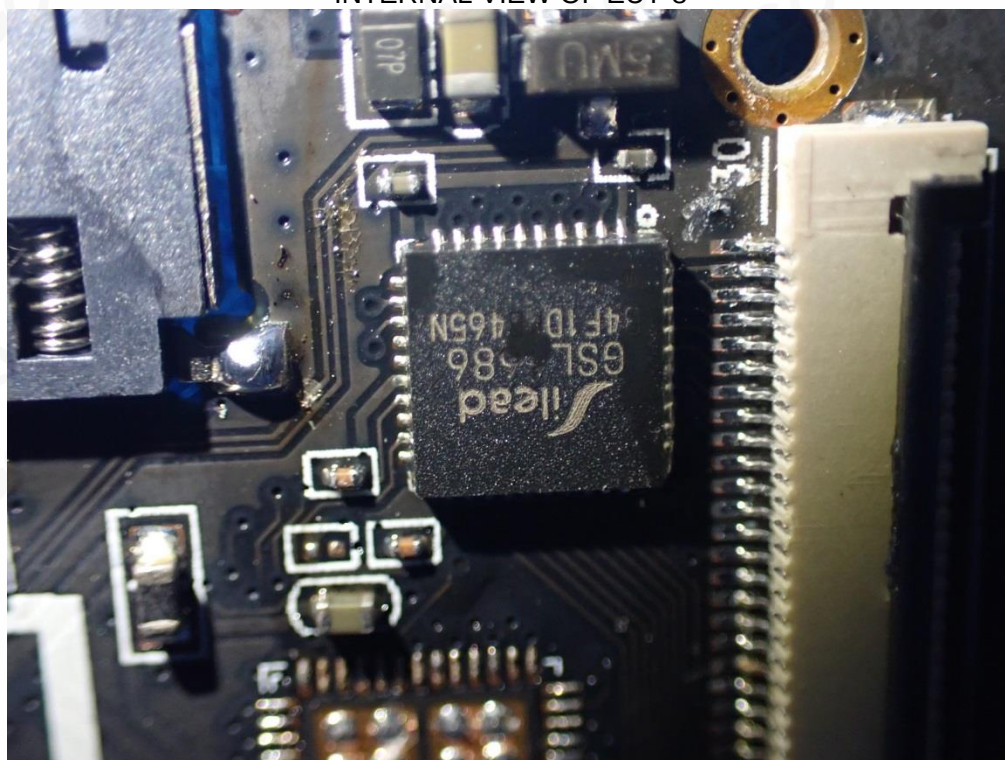

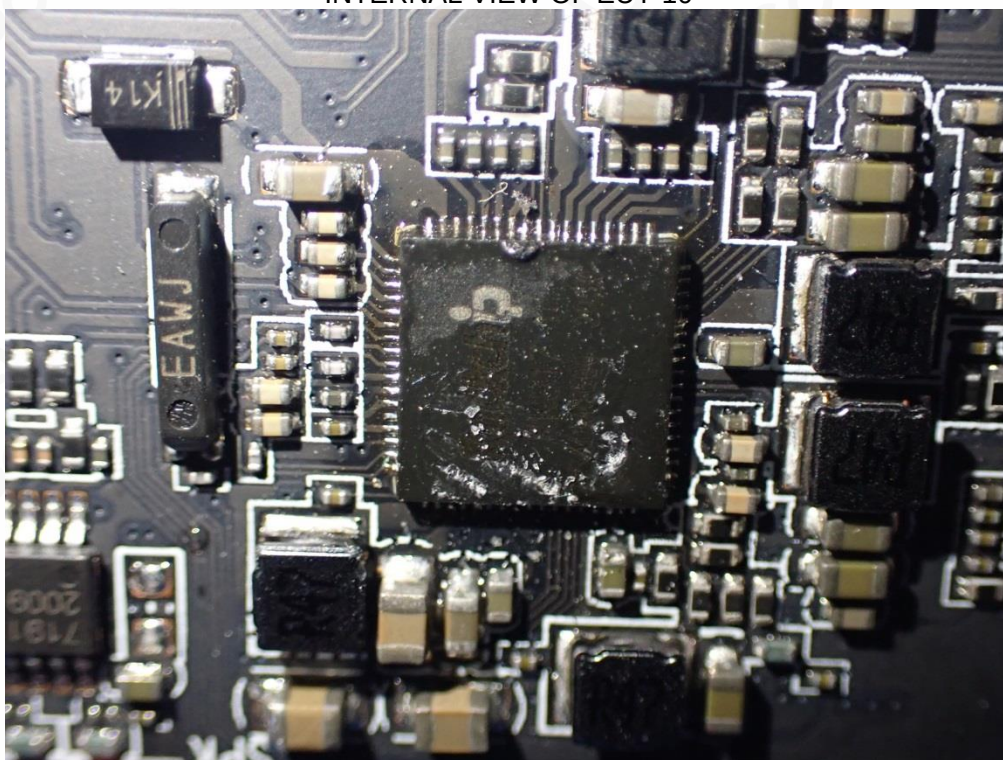
