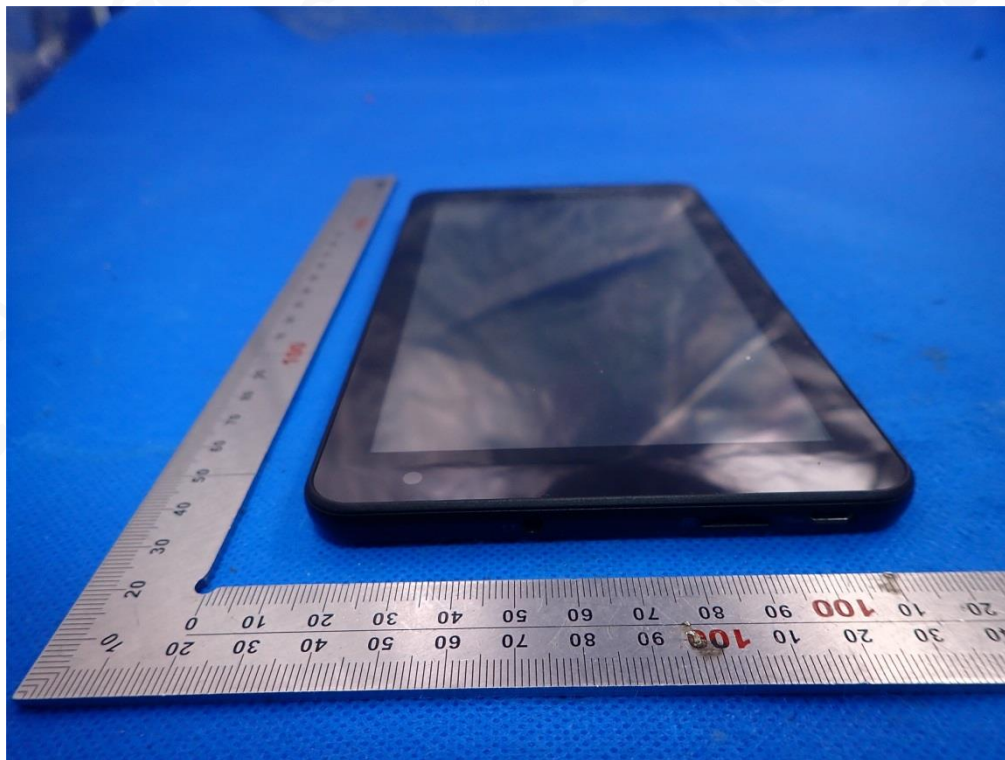

FRONT VIEW OF EUT

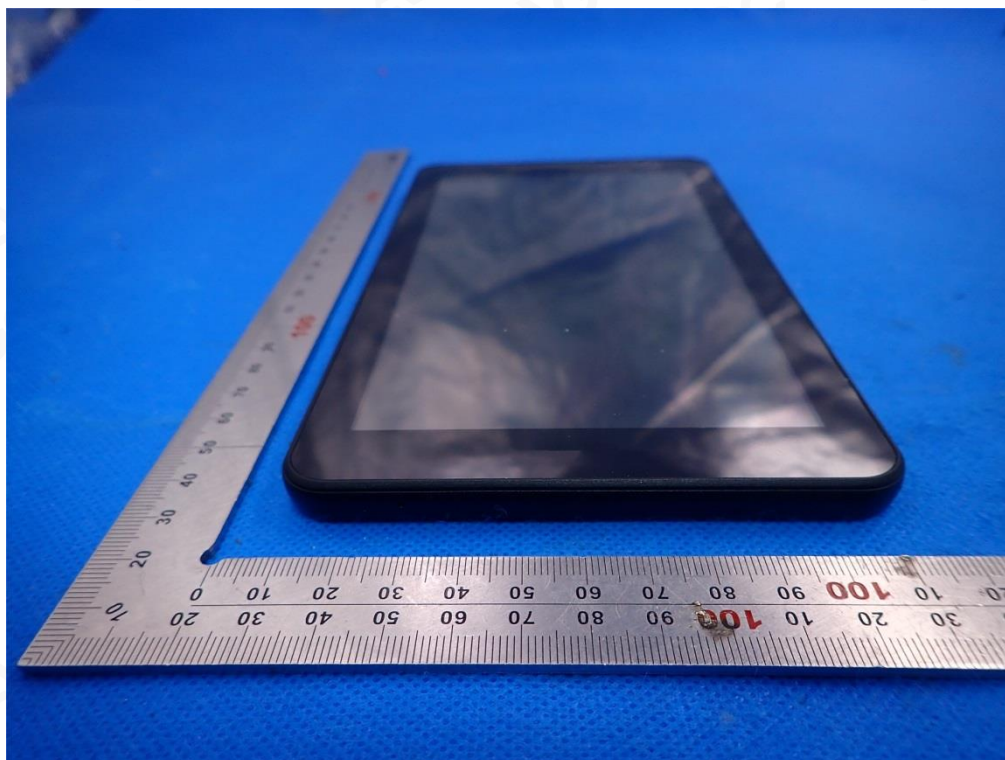

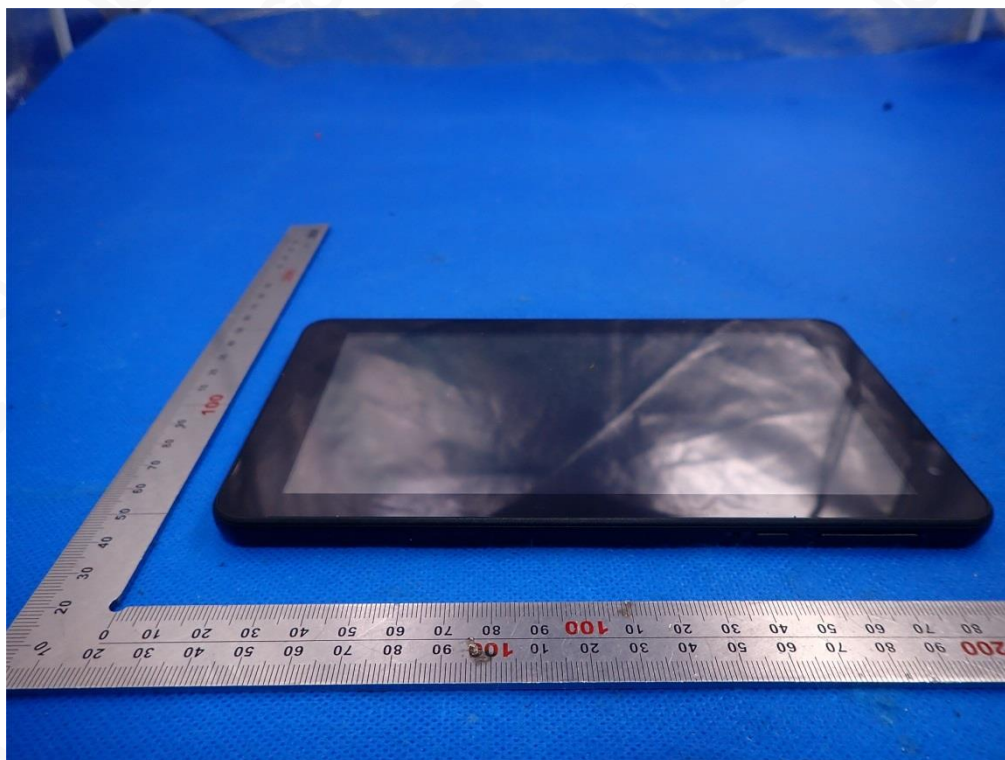

LEFT VIEW OF EUT

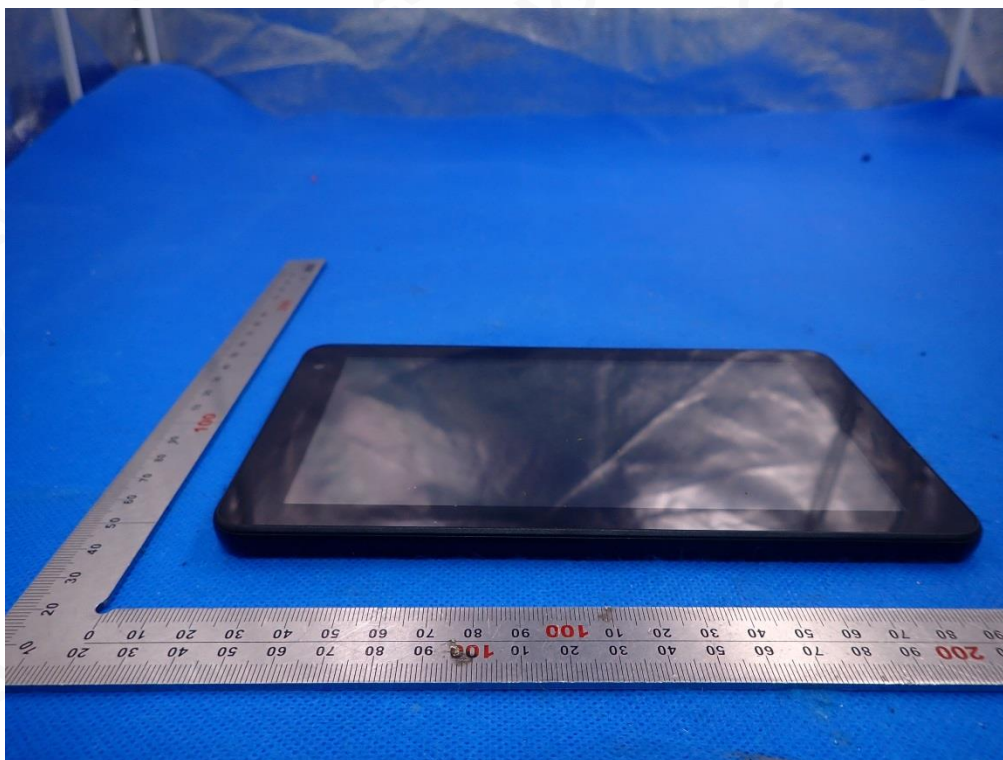

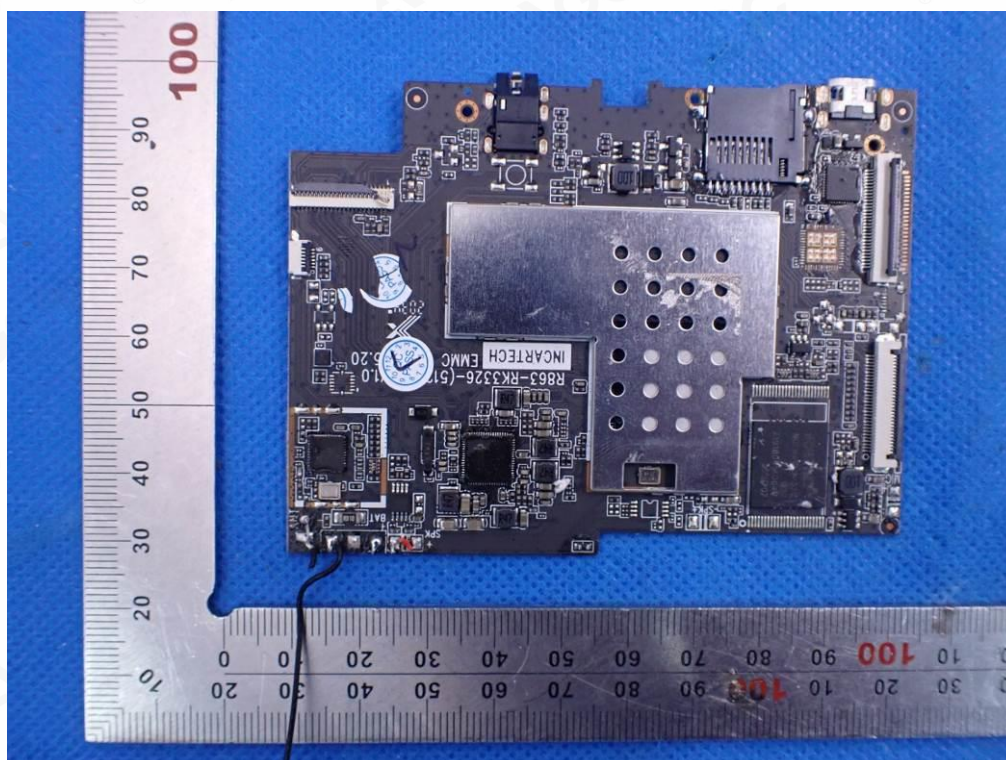

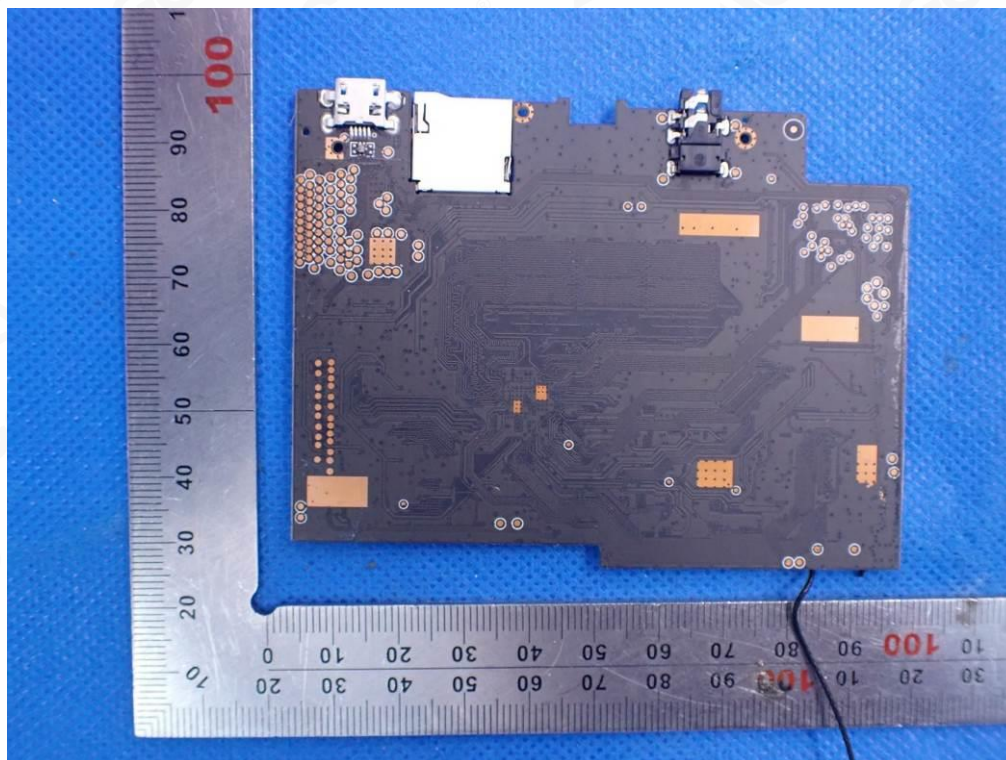

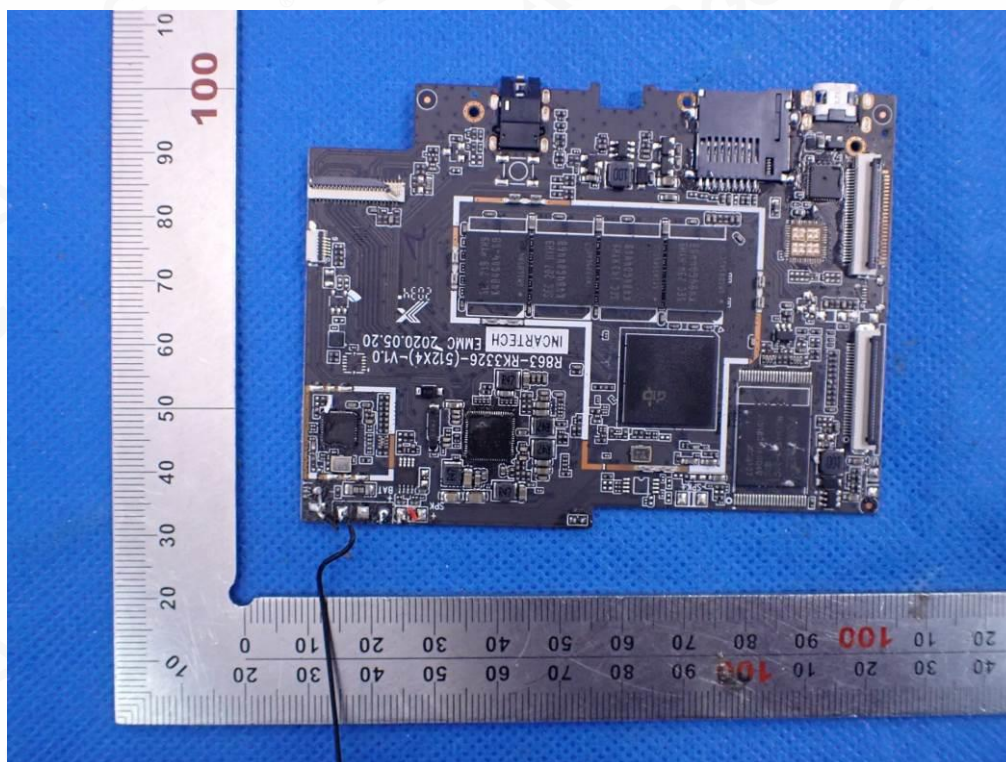

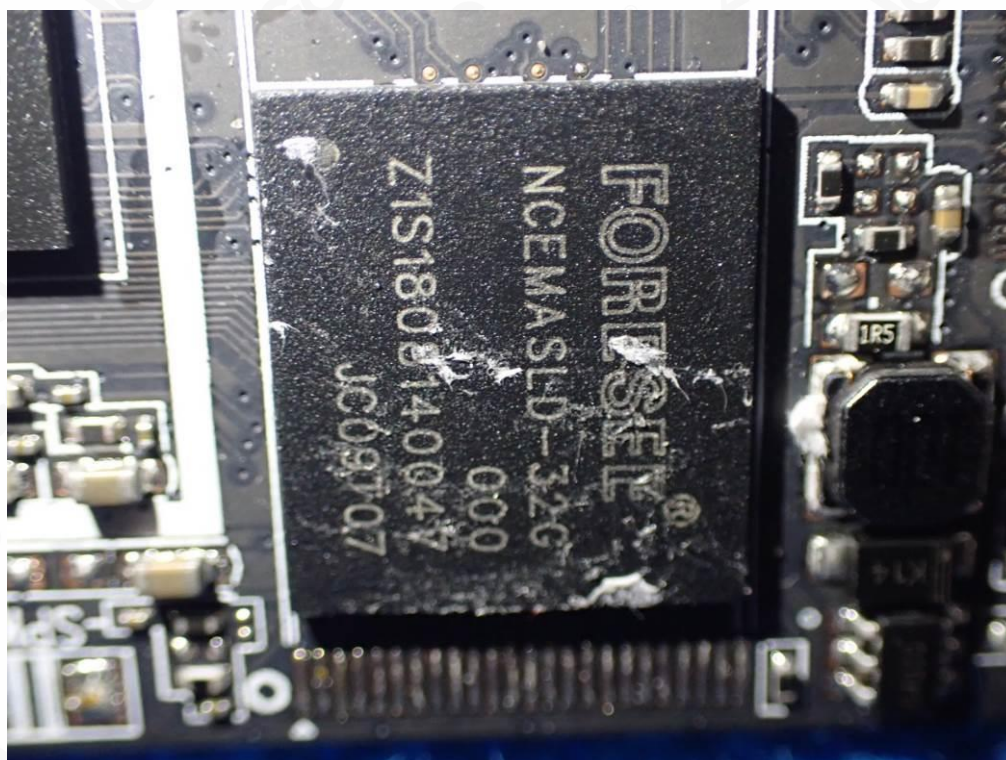

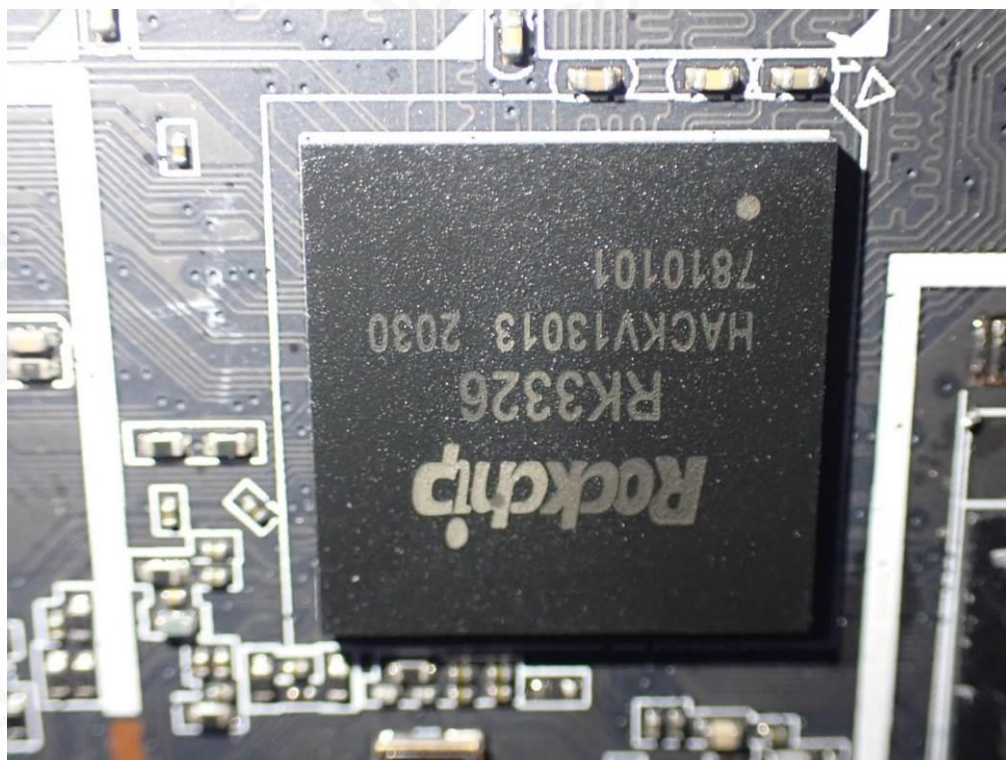

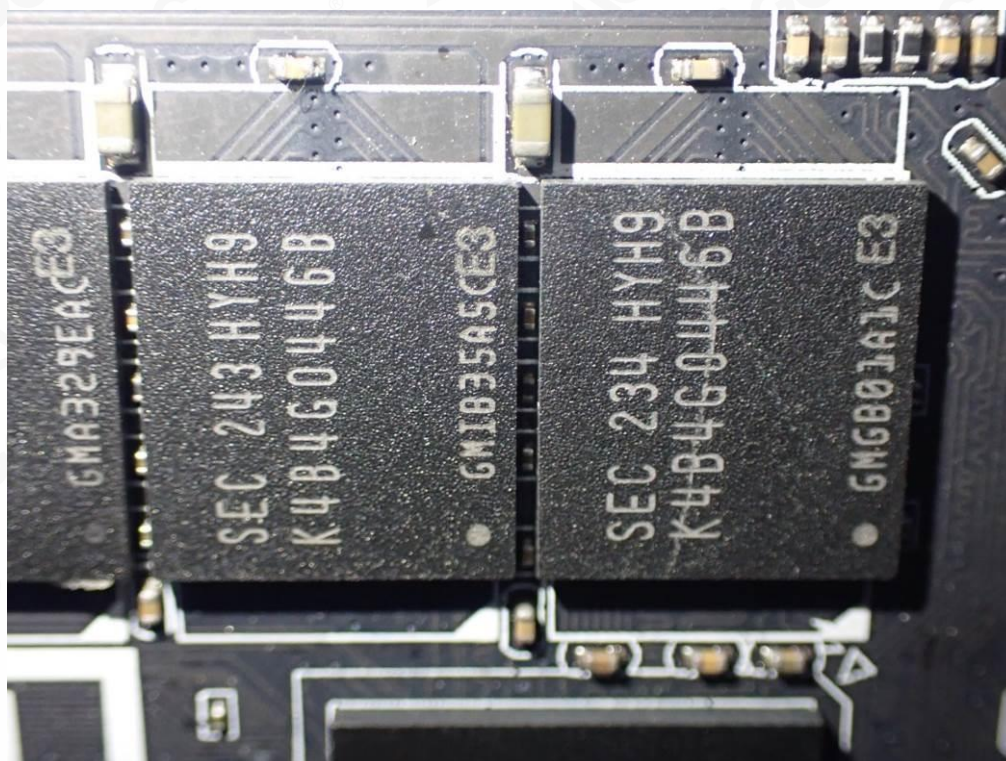

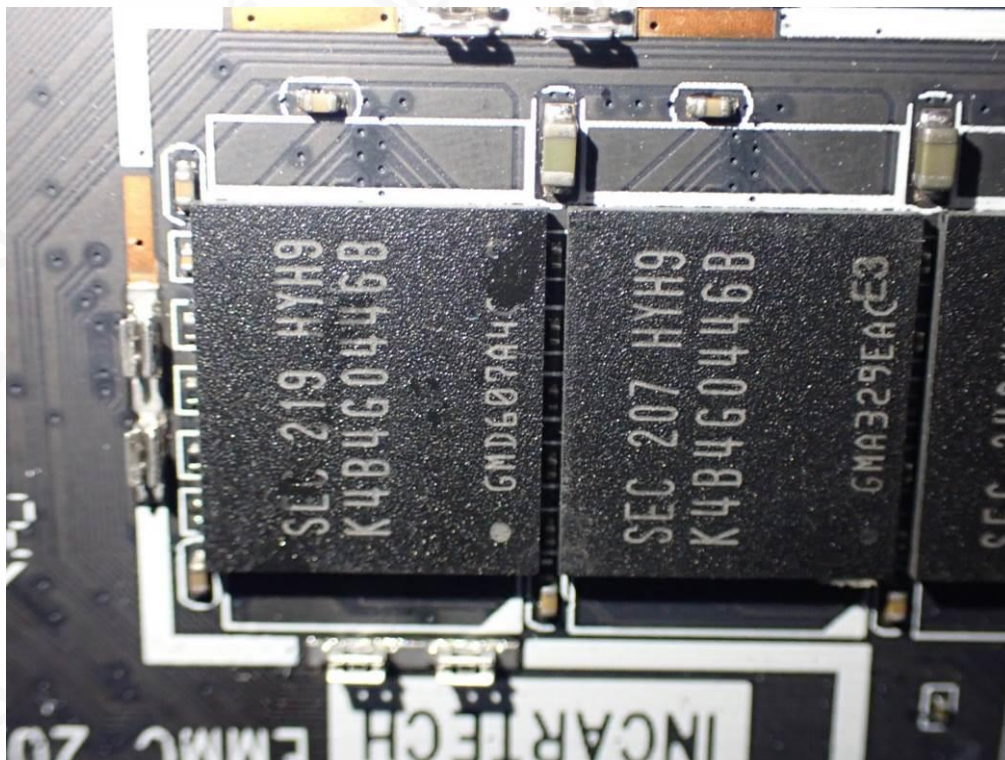

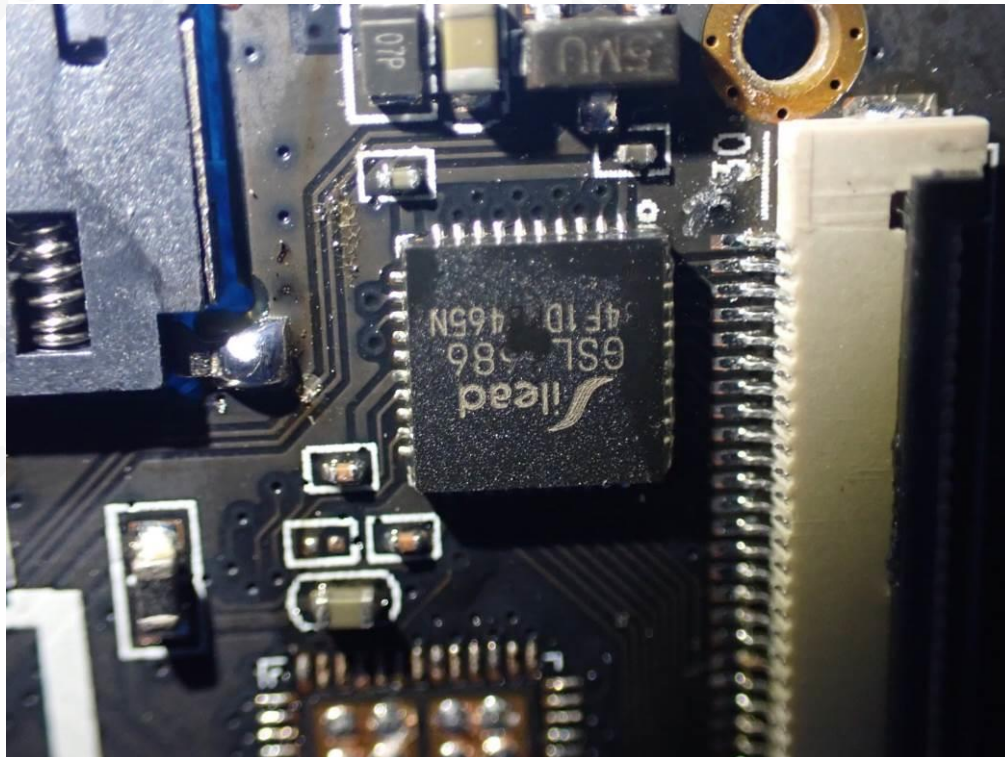

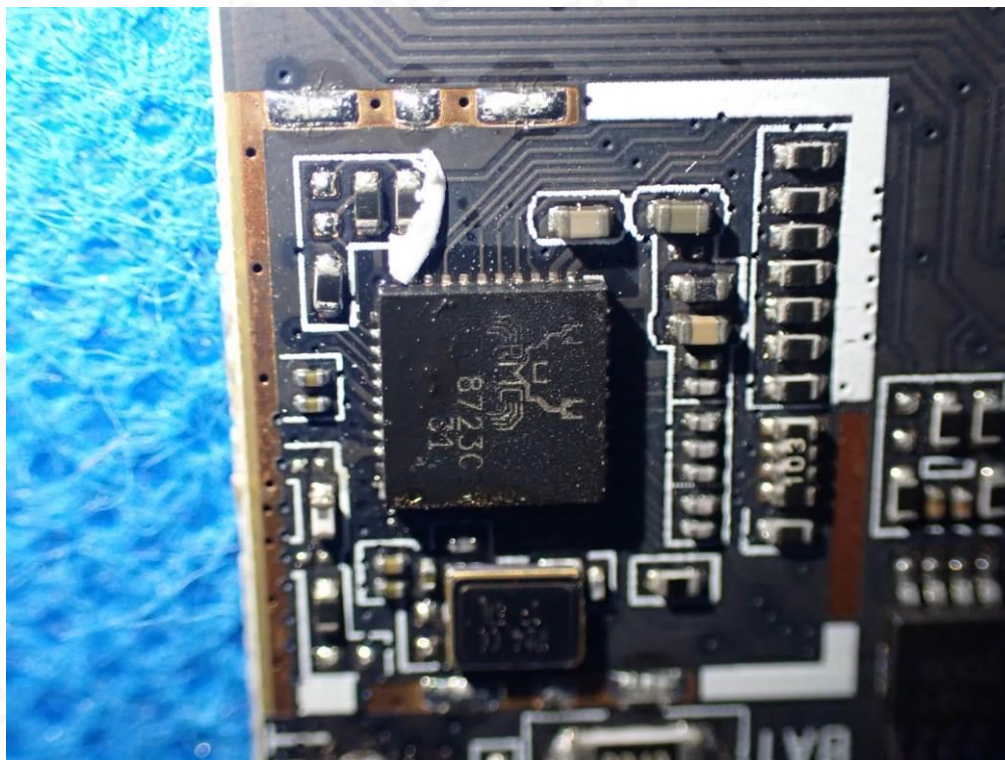

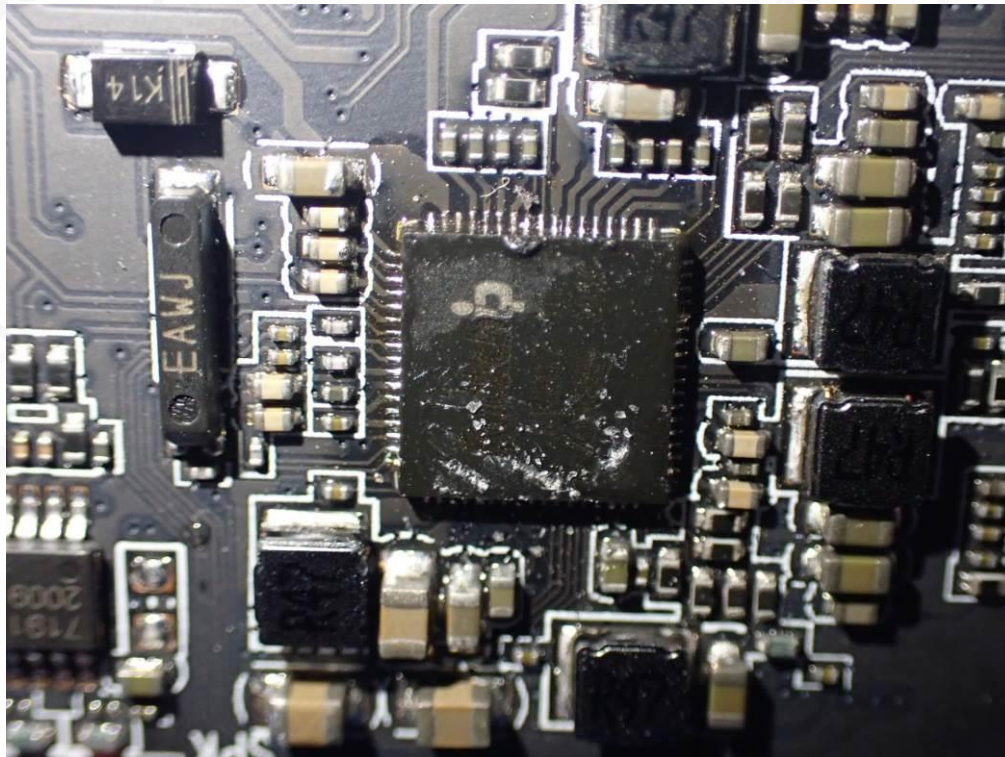

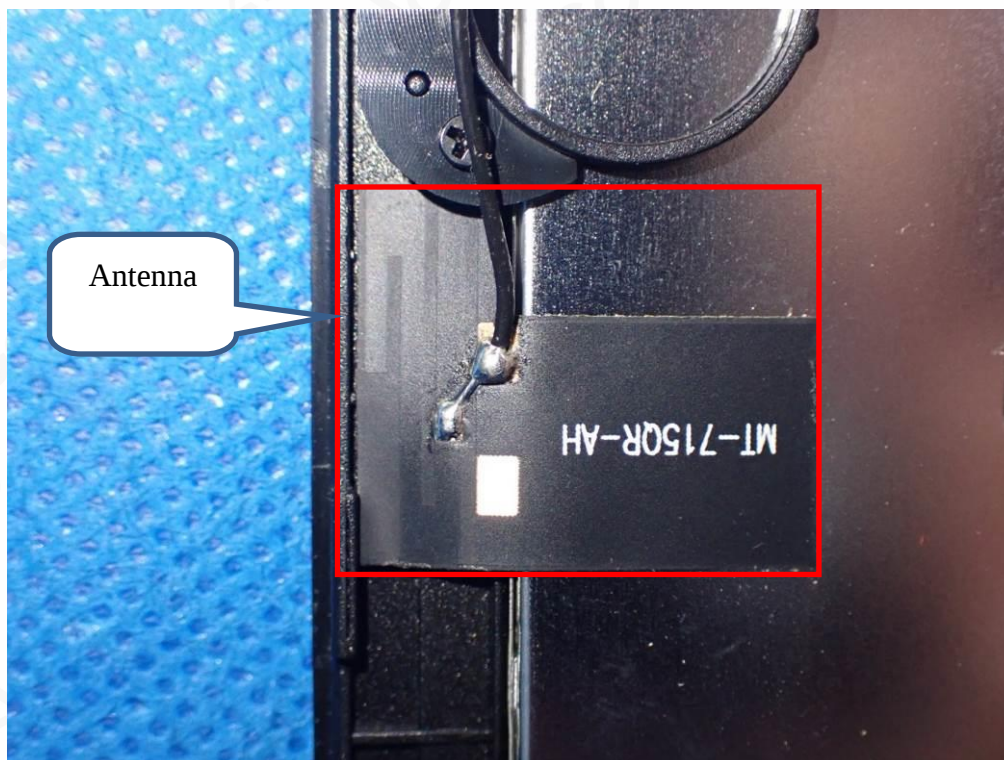
