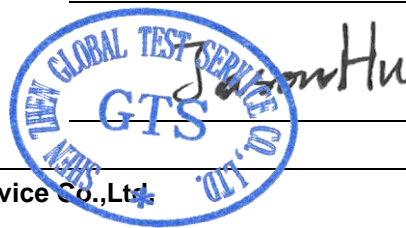

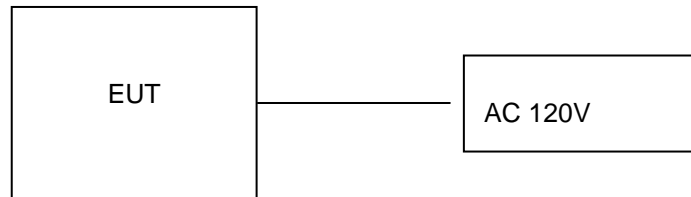

AC main conducted emission pre-test at charge from PC modes, recorded worst case;

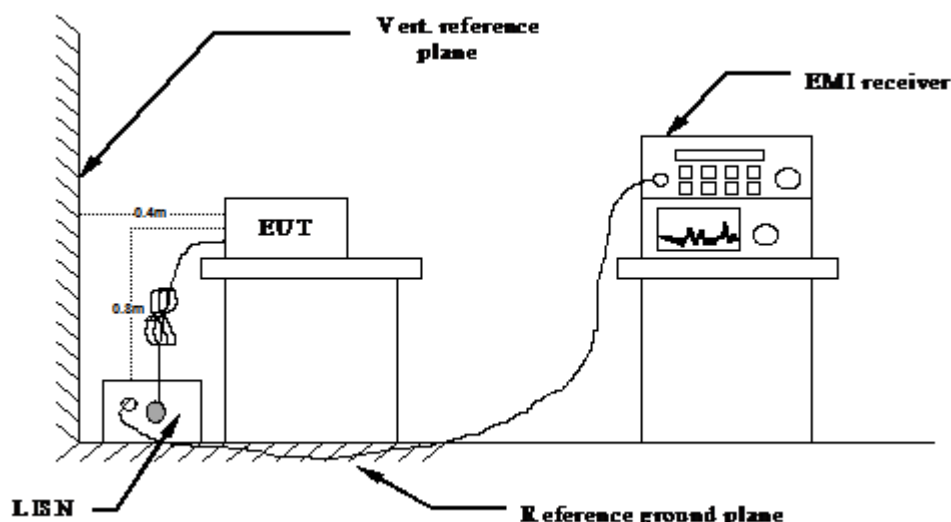

4. TEST CONDITIONS AND RESULTS

4.1. AC Power Conducted Emission

TEST CONFIGURATION



TEST PROCEDURE

- 1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2020.
- 2 Support equipment, if needed, was placed as per ANSI C63.10-2020
- 3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2020
- 4 The EUT received AC 120V power, the received AC120V/60Hz or AC 240V/50Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5 All support equipments received AC power from a second LISN, if any.
- 6 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8 During the above scans, the emissions were maximized by cable manipulation.

DISTURBANCE Calculation

The AC mains conducted disturbance is calculated by adding the 10dB Pulse Limiter and Cable Factor and Duty Cycle Correction Factor (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$CD \text{ (dBuV)} = RA \text{ (dBuV)} + PL \text{ (dB)} + CL \text{ (dB)}$$

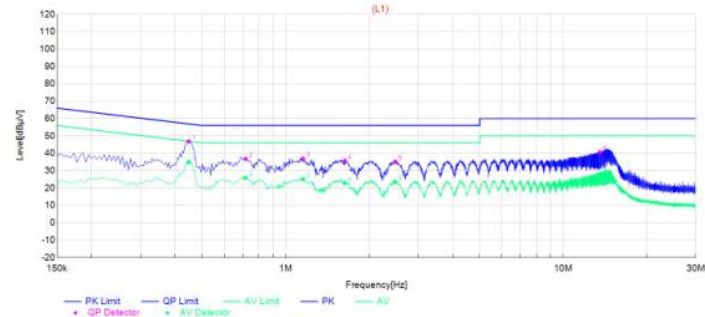

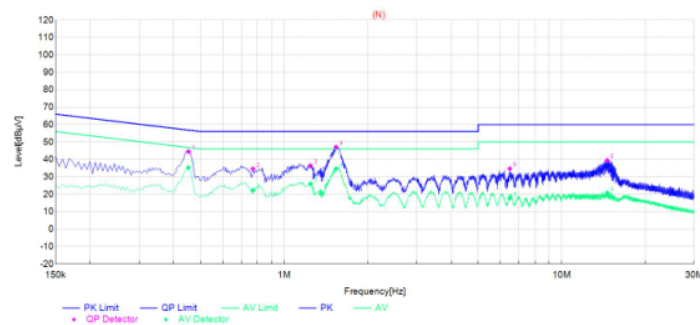

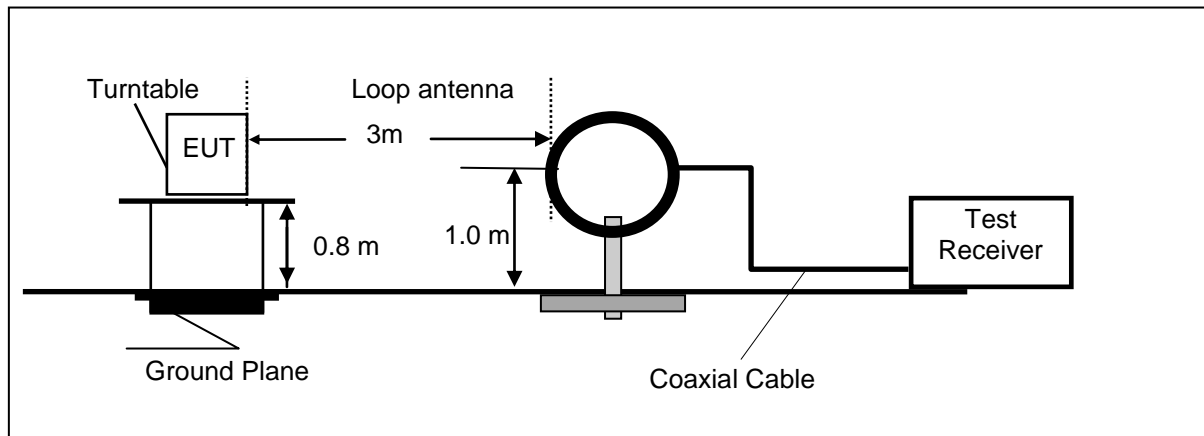

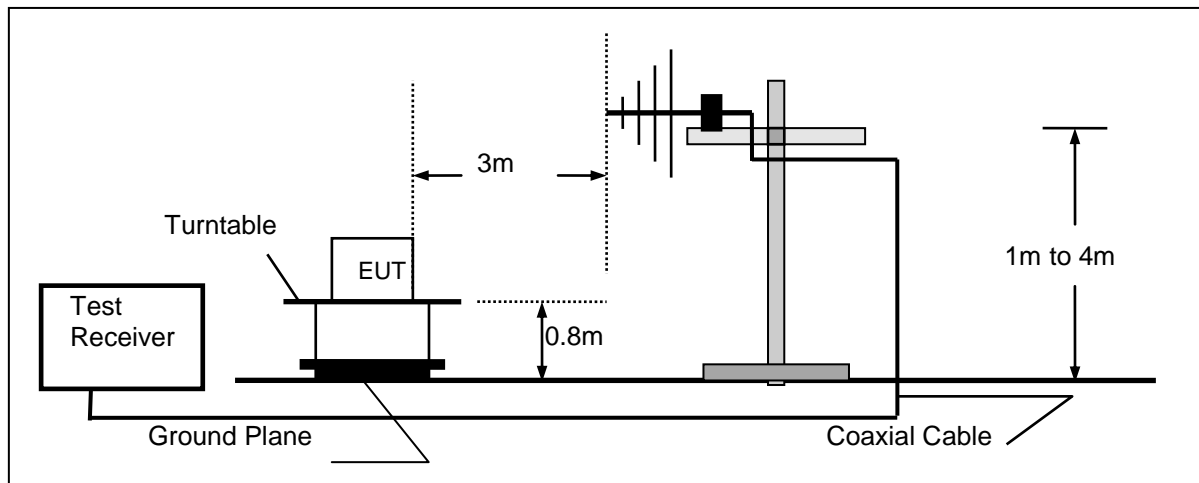

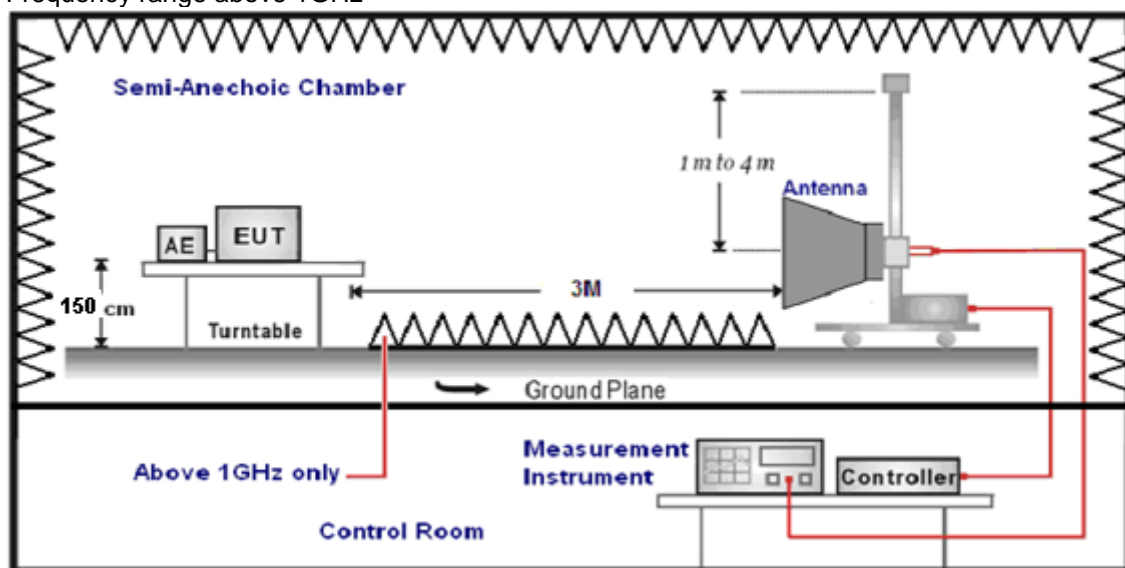
Frequency range 9 KHz – 30MHz

1. The EUT was placed on a turn table which is 0.8m above ground plane when testing frequency range 9 KHz –1GHz;the EUT was placed on a turn table which is 1.5m above ground plane when testing above 1GHz.

 - If Method SA-2 or SA-2 Alternative was used, add $10 \log(1/x)$, where x is the duty cycle, to the peak of the spectrum.
 - If Method SA-3 Alternative was used and the linear mode was used in step II.E.2.g)(viii), add 1 dB to the final result to compensate for the difference between linear averaging and power averaging.
- The result is the Maximum PSD over 1 MHz reference bandwidth.
- For devices operating in the bands 5.15-5.25 GHz, 5.25-5.35 GHz, and 5.47-5.725 GHz, the above procedures make use of 1 MHz RBW to satisfy directly the 1 MHz reference bandwidth specified in § 15.407(a)(5). For devices operating in the band 5.725-5.85 GHz, the rules specify a measurement bandwidth of 500 kHz. Many spectrum analyzers do not have 500 kHz RBW, thus a narrower RBW may need to be used. The rules permit the use of a RBWs less than 1 MHz, or 500 kHz, “provided that the measured power is integrated over the full reference bandwidth” to show the total power over the specified measurement bandwidth (i.e., 1 MHz, or 500 kHz). If measurements are performed using a reduced resolution bandwidth (< 1 MHz, or < 500 kHz) and integrated over 1 MHz, or 500 KHz bandwidth, the following adjustments to the procedures apply:
 - Set $RBW \geq 1/T$, where T is defined in section II.B.I.a).
 - Set $VBW \geq 3$ RBW.
 - If measurement bandwidth of Maximum PSD is specified in 500 kHz, add $10\log(500\text{kHz}/RBW)$ to the measured result, whereas RBW (< 500 KHz) is the reduced resolution bandwidth of the spectrum analyzer set during measurement.
 - If measurement bandwidth of Maximum PSD is specified in 1 MHz, add $10\log(1\text{MHz}/RBW)$ to the measured result, whereas RBW (< 1 MHz) is the reduced resolution bandwidth of spectrum analyzer set during measurement.
 - Care must be taken to ensure that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.
