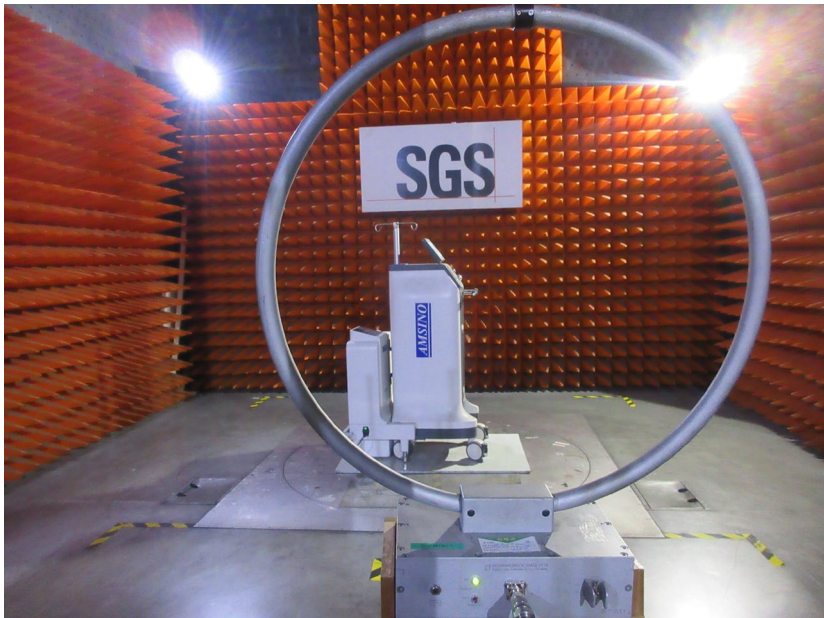

### 2.1 Conducted Emission Test Setup



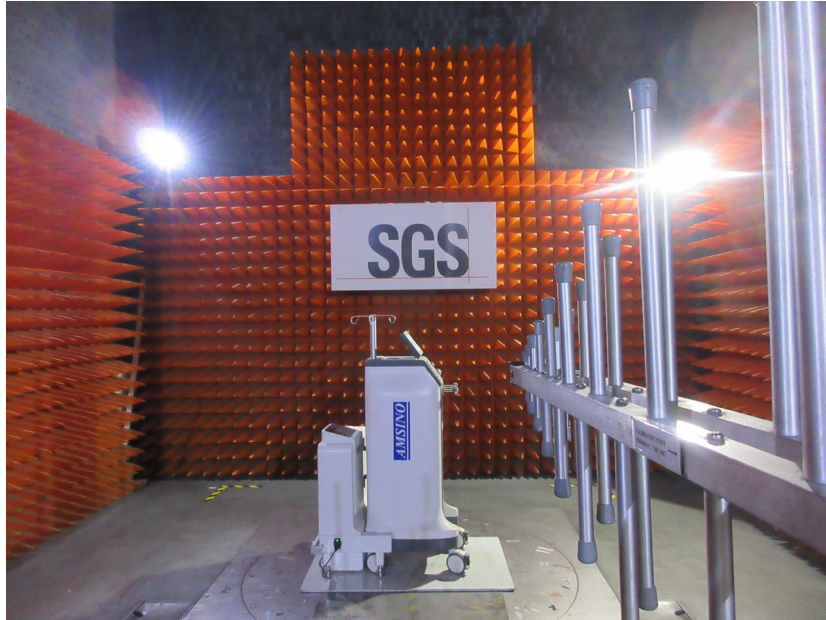
### 2.2 Radiated Emission Test Setup
