

As TCB, we have checked the information of CELLT INC in several previous projects. We have saved the information in TCB's database. In the following text, we will explain how TCB verifies the new agent information:

1- Is the address of the agent a valid physical US mailing address (not a US post office box, not a virtual mailbox, not P.O. Boxes, not a vacant lot, not a public building, etc.)

o We have checked if the address exists in a real and potential building (Google maps) + official US register, after this verification and the evidence as below:

- not a US post office box
- not a virtual mailbox
- not P.O. Boxes
- not a vacant lot
- not a public building(note)

► We checked the FCC FRN Search based on the information provided by the grantee.



Then, if we are focus on the ASOP definition in FCC Report and Order

23. What are the responsibilities of the agent for service of process? An agent for service of process for the particular equipment certification authorization has the obligation to accept the service of process and other legal process documents on behalf of the grantee of the authorization (the responsible party) and to swiftly and dutifully deliver them to that party. Service of process includes, but is not limited to, delivery of any correspondence, notices, orders, decisions, and requirements of administrative, legal, or judicial process related to Commission proceedings. See FCC 22-84, paragraph 63. However, service of process on the grantee of the equipment authorization is deemed to be complete when the document is sent to the U.S. physical address, U.S. mailing address (if different), or e-mail address of the U.S.-based agent for service of process.

► **CONCLUSION by TCB:** The ASOP defined and provided by grantee is VALID and confirmed. Therefore the exhibit "US Agent for Service of Process LETTER OF ATTESTATION" included in the file is ok.
