Start Here

To Power On

Press and hold the power button to power on. Device will boot up automatically.

To Power Off

During use, press and hold the power button for about 5 seconds to power off; a system window will appear. Select "power off" followed by "ok." Device will shut down.

Sleep Mode

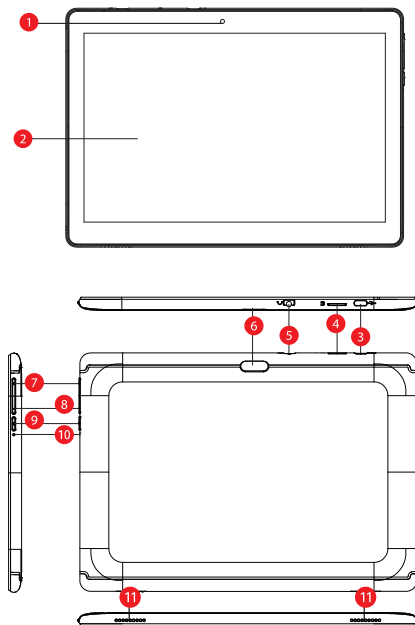
Tap the Power button to enter/exit sleep mode.
