

## 2 RF EXPOSURE EVALUATION FOR PORTABLE CONDITIONS

### 2.1 FCC Standard Applicable:

According to §1.1307(b)(1), systems operating under the provisions of this section shall be operated in a manner that ensure that the public is not exposed to radio frequency energy level in excess of the Commission's guideline.

#### 2.1.1 As per KDB 447498 D01 4.3.1,

**Step a:** For 100 MHz to 6 GHz and test separation distances  $\leq 50$  mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [f(\text{GHz})] \leq 3.0 \text{ for 1-g Head \& Body SAR and} \leq 7.5 \text{ for 10-g extremity Hand SAR, where}$

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison
- The values 3.0 and 7.5 are referred to as numeric thresholds in **step b)** below

**Step b:** For 100 MHz to 6 GHz and test separation distances  $> 50$  mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following (also illustrated in Appendix B):

- 1)  $\{[\text{Power allowed at numeric threshold for 50 mm in step a}] + [(\text{test separation distance} - 50 \text{ mm}) \cdot (f(\text{MHz})/150)]\} \text{ mW, for 100 MHz to 1500 MHz}$
- 2)  $\{[\text{Power allowed at numeric threshold for 50 mm in step a}] + [(\text{test separation distance} - 50 \text{ mm}) \cdot 10]\} \text{ mW, for} > 1500 \text{ MHz and} \leq 6 \text{ GHz}$

**Step c:** For frequencies below 100 MHz, the following may be considered for SAR test exclusion (also illustrated in Appendix C):

- 1) For test separation distances  $> 50 \text{ mm and} < 200 \text{ mm, the power threshold at the corresponding test separation distance at 100 MHz in step b) is multiplied by} [1 + \log(100/f(\text{MHz}))]$
- 2) For test separation distances  $\leq 50 \text{ mm, the power threshold determined by the equation in c) 1 for 50 mm and 100 MHz is multiplied by} \frac{1}{2}$
- 3) SAR measurement procedures are not established below 100 MHz

## 2.2 Measurement Result:

### Step a:

This is a portable device and the max. output power including tune-up tolerance is 5.012 (mW), lower than the threshold given and derived as formula given above, where

$$=5.012(\text{mW})/5(\text{mm})^2\sqrt{2.48(\text{GHz})} = 1.579 < 3.0$$
