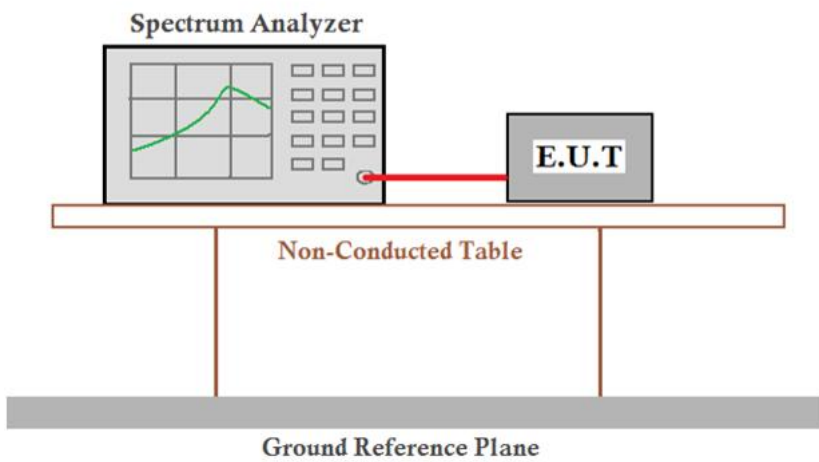

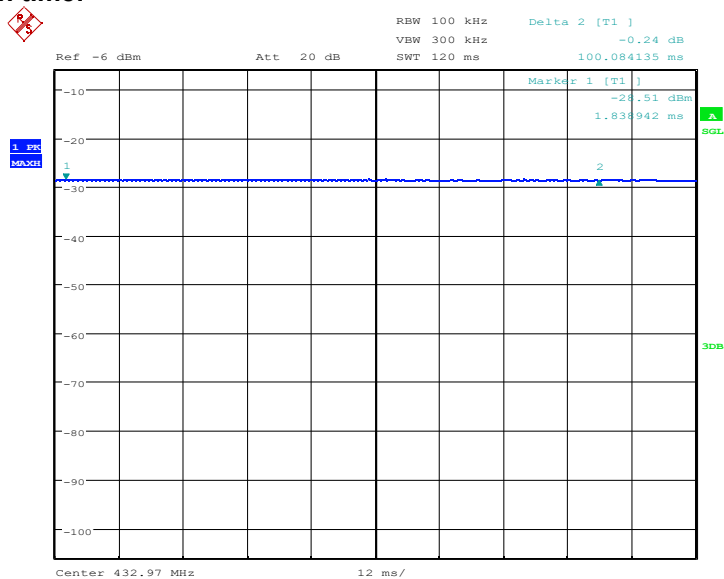

Both horizontal and vertical polarizations of the antenna are set to make the measurement. - For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading. - The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode. - If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet. - The radiation measurements are performed in X, Y, Z axis positioning. And found the Z axis positioning which it is worse case, Only the test worst case mode is recorded in the report.

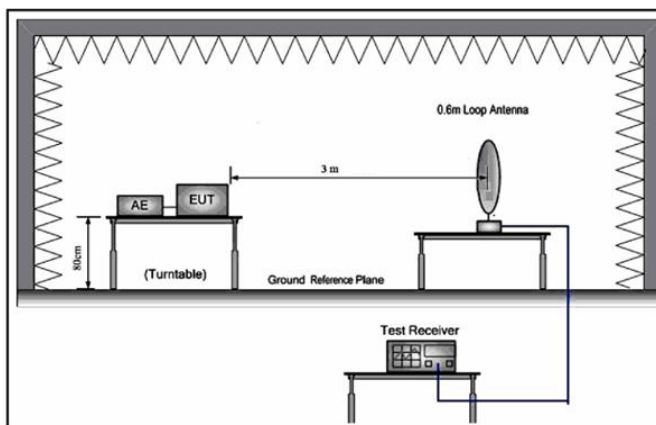


Figure 1. Below 30MHz

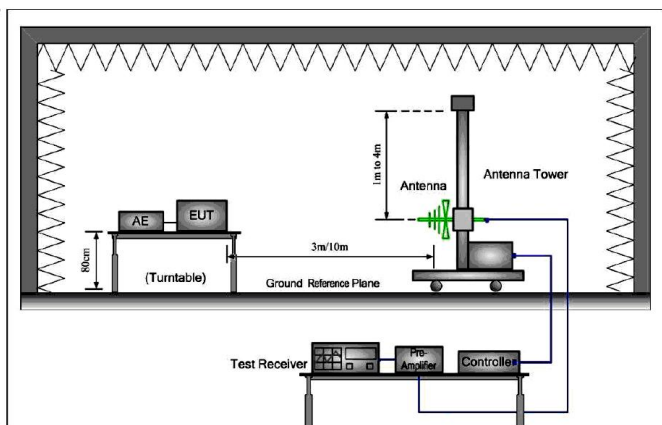


Figure 2. 30MHz to 1GHz

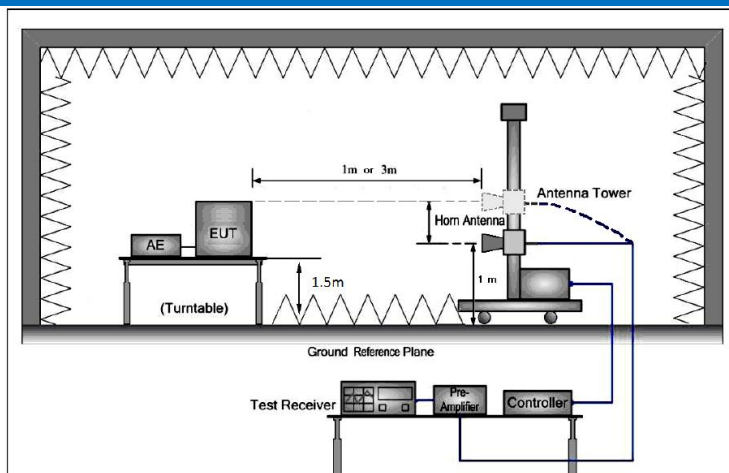


Figure 3. Above 1 GHz

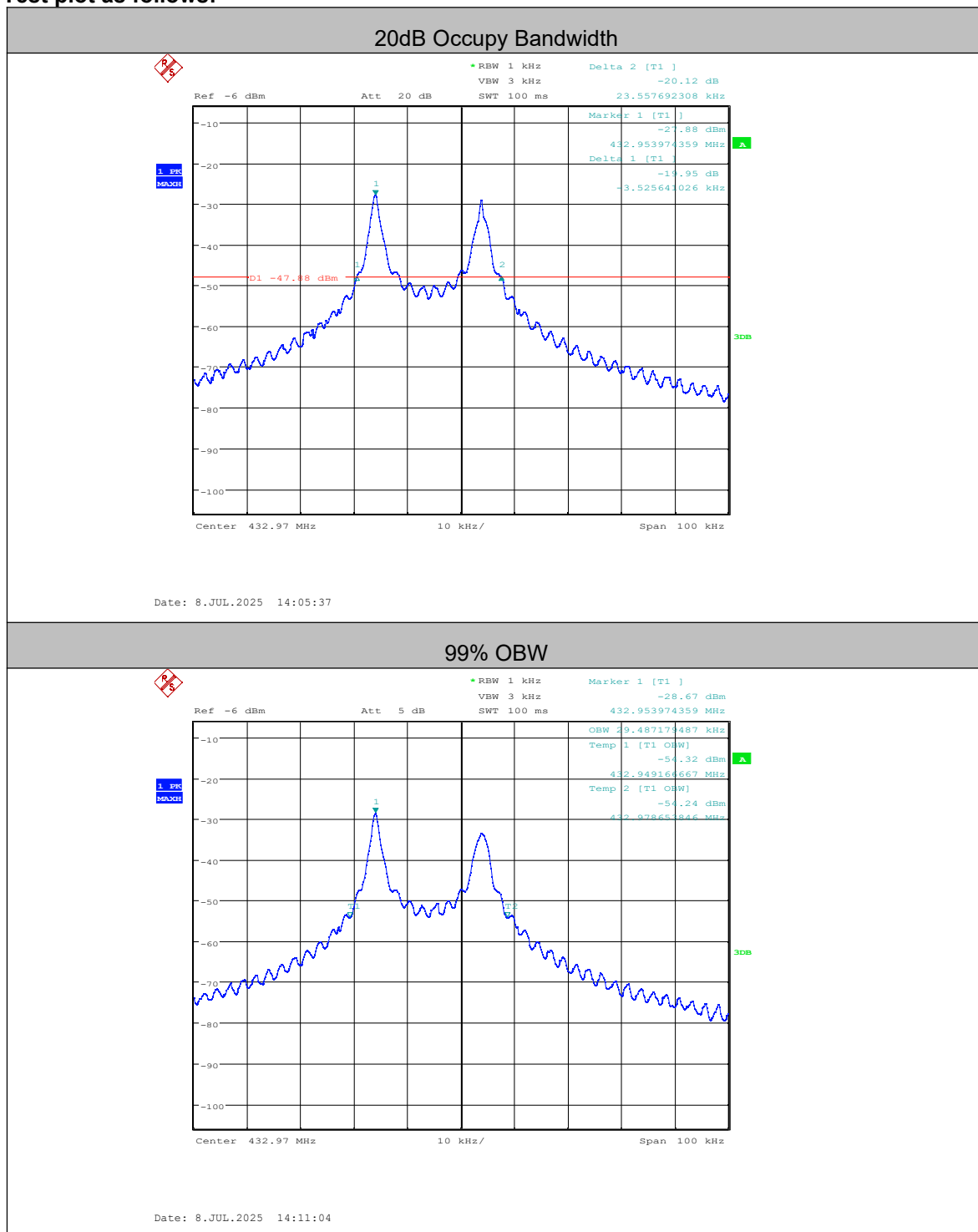

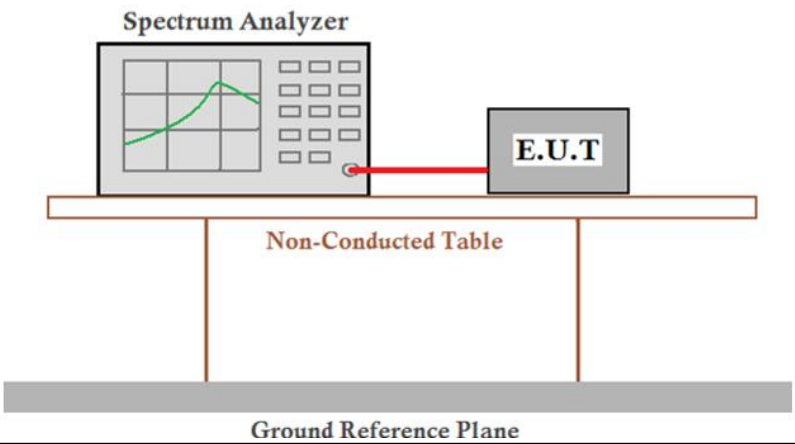

3. Regulation 15.231 (a2) A transmitter that has been activated automatically shall cease transmission within 5 seconds of activation.

Result:

The EUT does not have automatic transmission.

4.Regulation15.231 (a3)

Periodic transmissions at regular, predetermined intervals are not allowed, except as specified in section A.1.5. Nonetheless, polling or supervision transmissions that determine system integrity of transmitters used in security or safety applications are permitted as long as the total duration of transmission does not exceed 2 seconds per hour for each transmitter.

In addition, devices operated under the provisions of this section shall be capable of automatically limiting their operation so that the duration of each transmission is not greater than 1 second and the silent period between transmissions is at least 30 times the duration of the transmission, but not less than 10 seconds under any circumstances. However, devices that are designed for limited use for the purpose of initial programming, reprogramming or installing, and not for regular operations, may operate for up to 5 seconds provided such devices are used only occasionally in connection with each unit being programmed or installed.

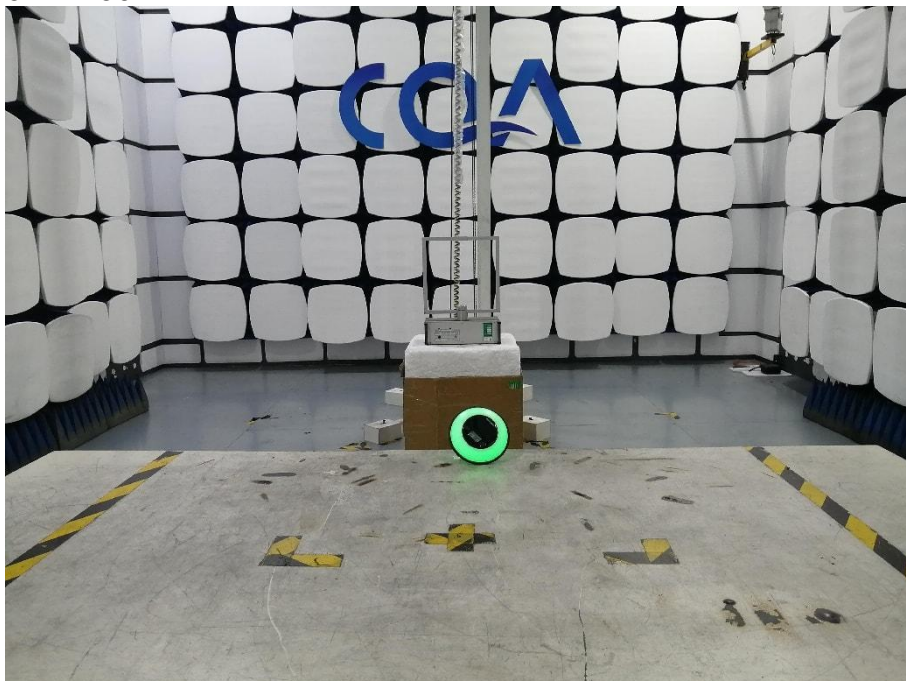

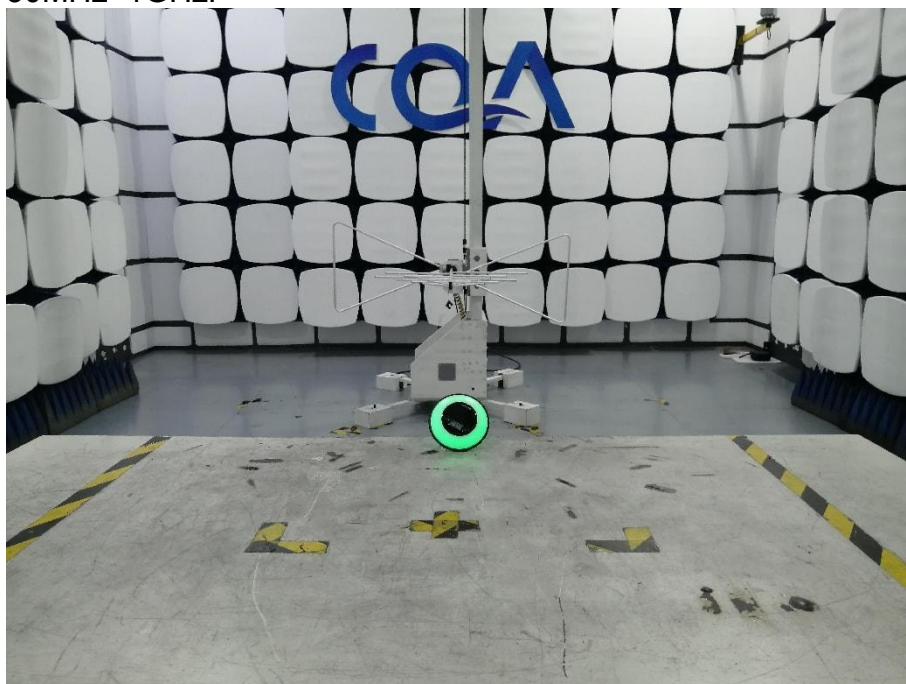
