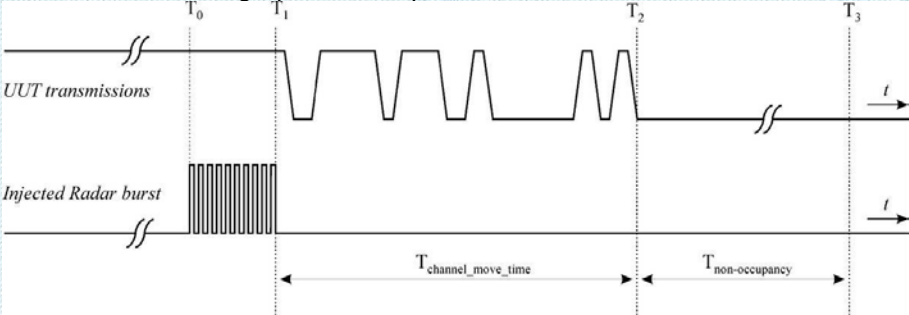

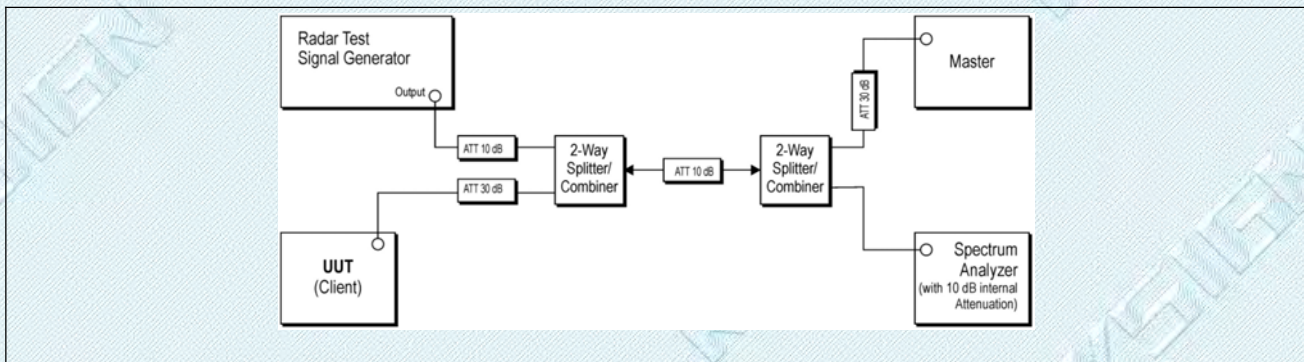

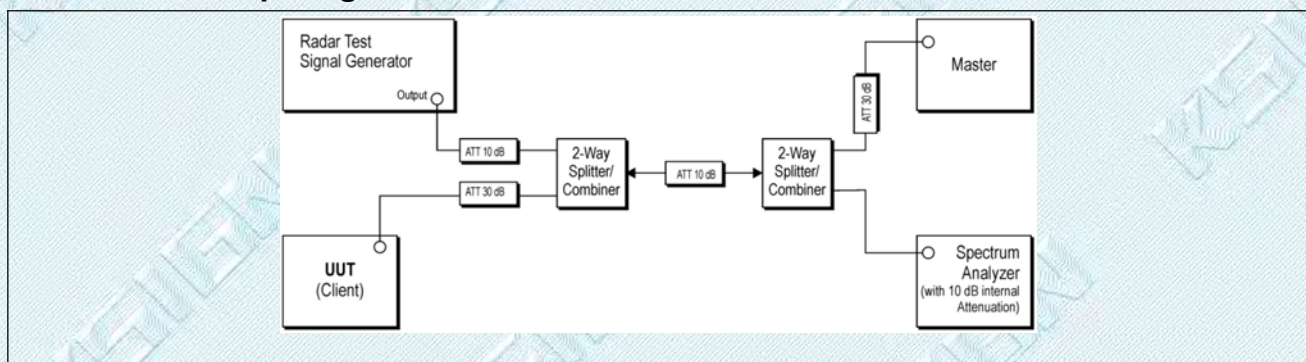

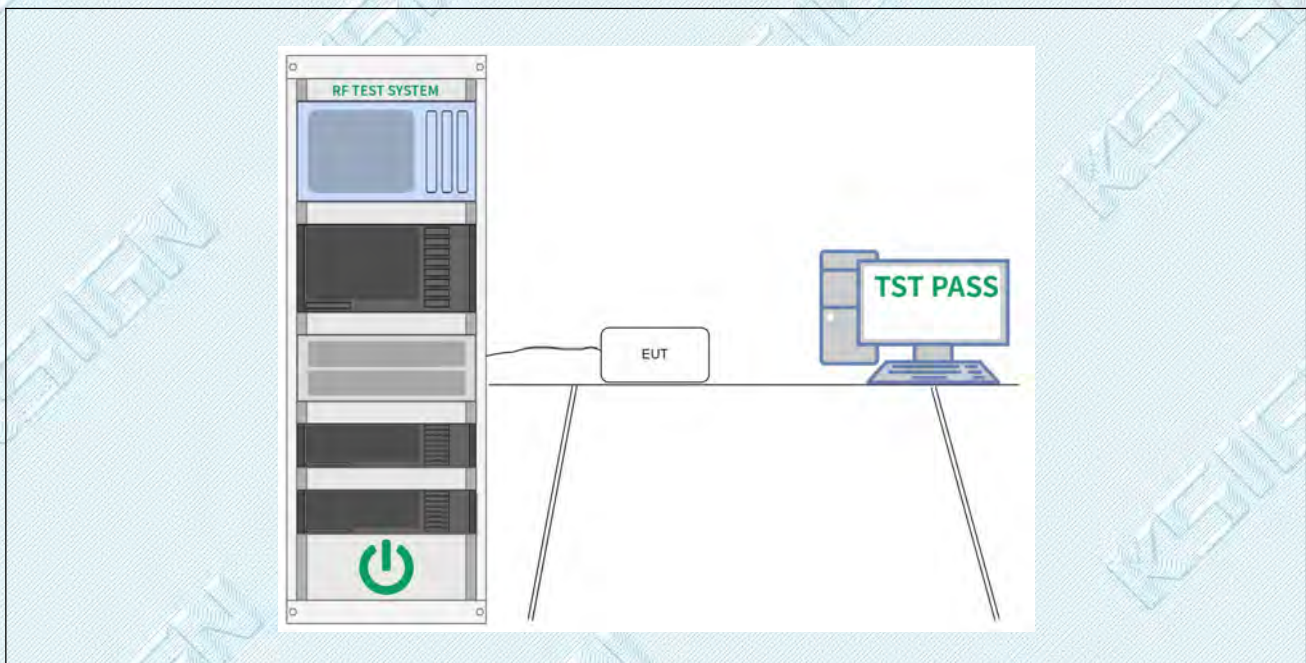

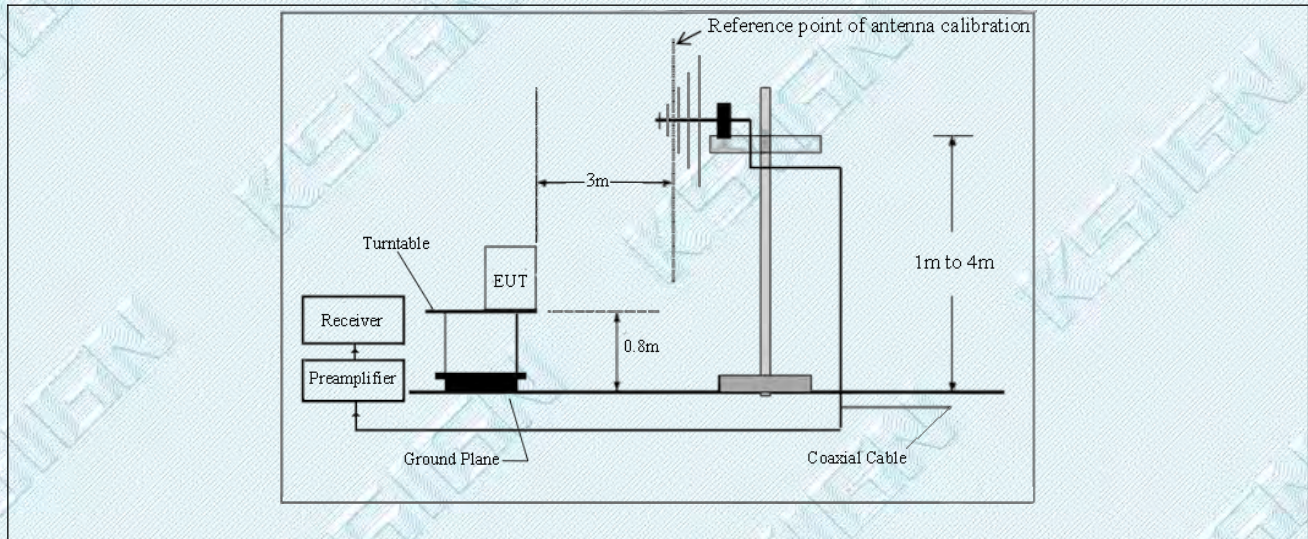

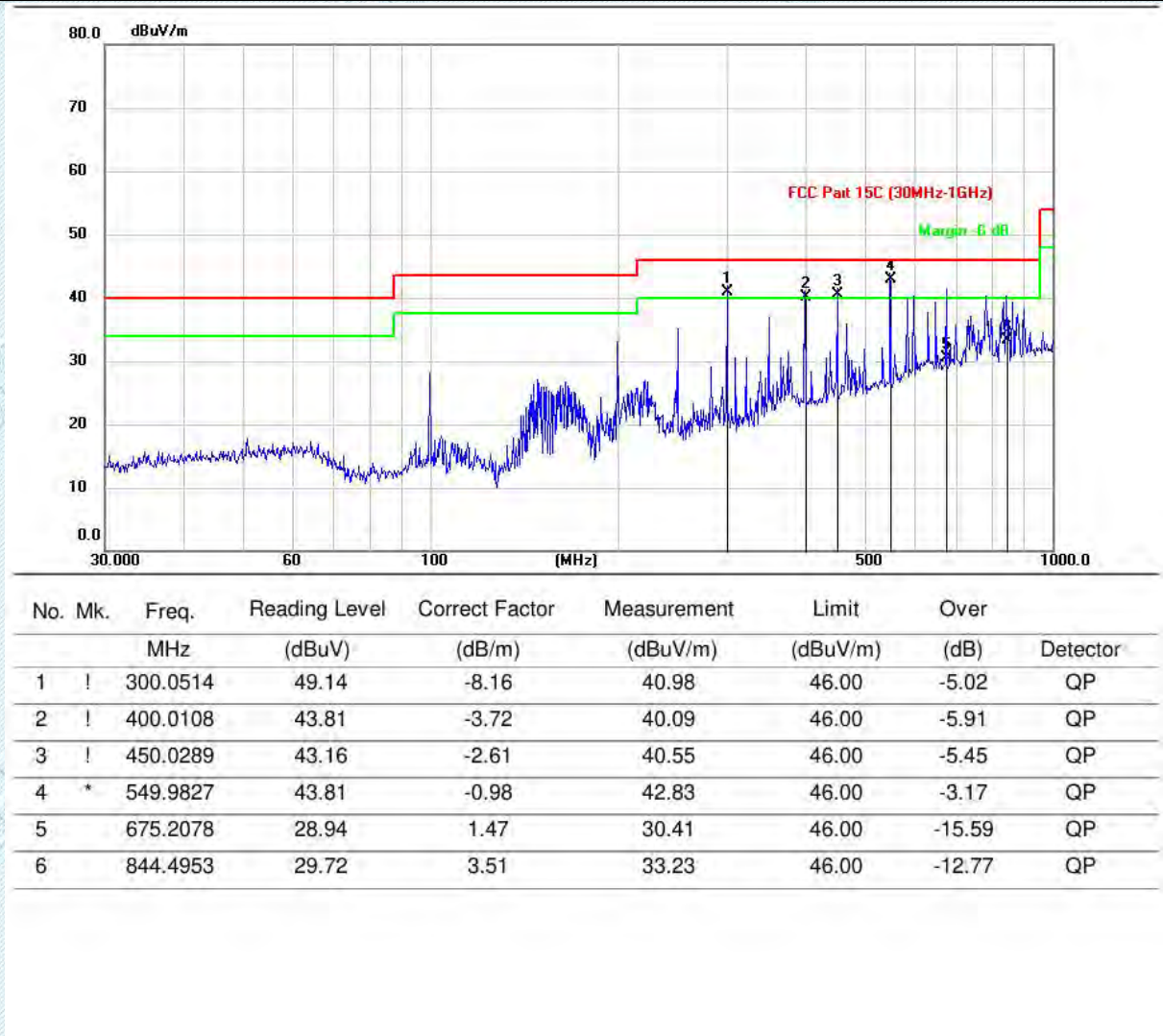
3.11.2. Test Setup Diagram:

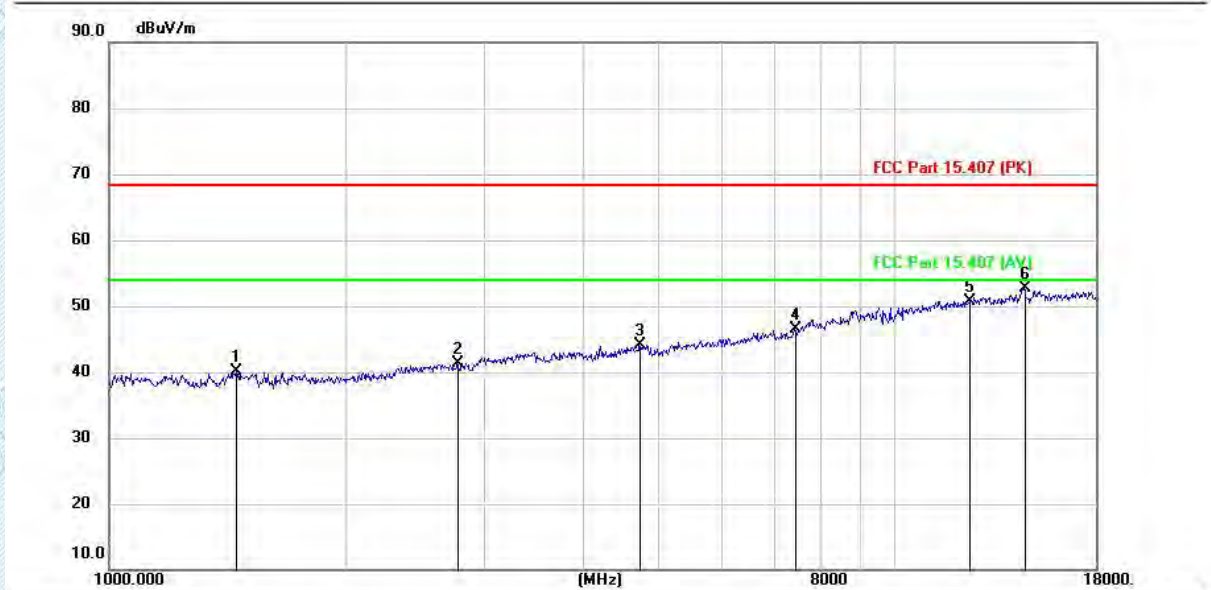

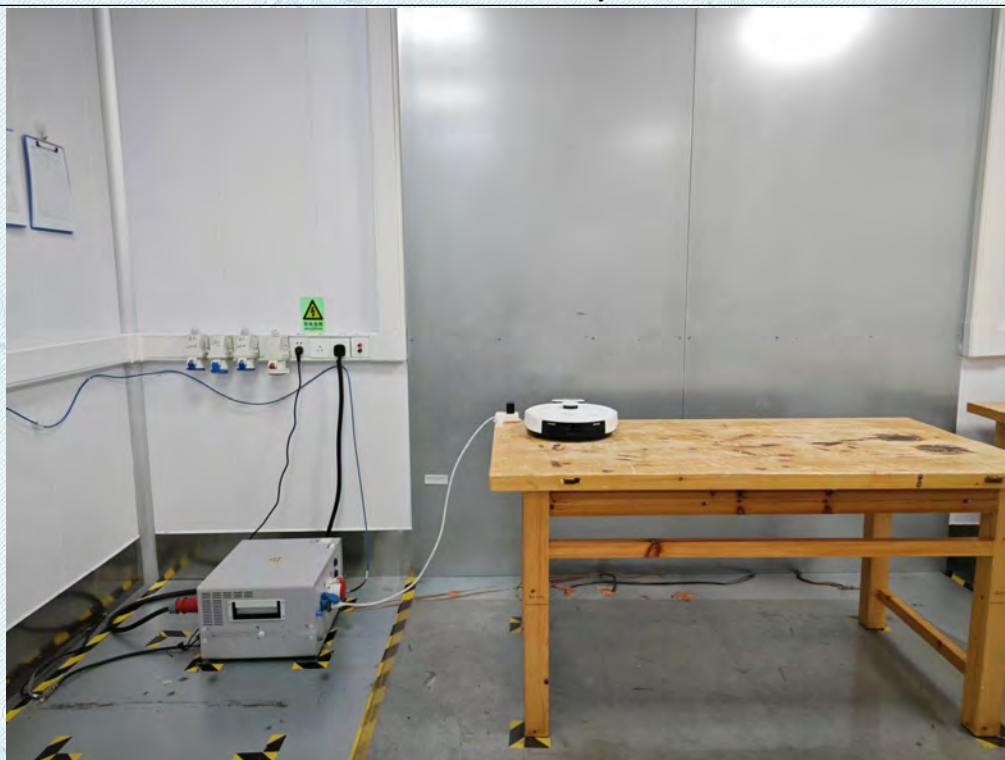
