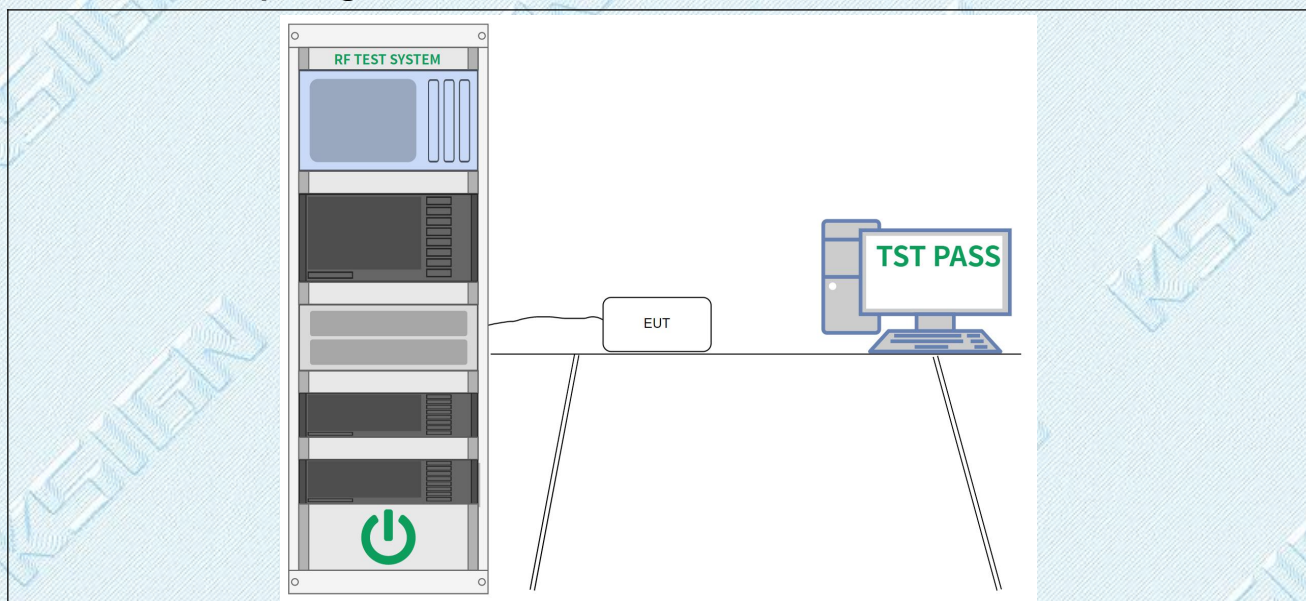

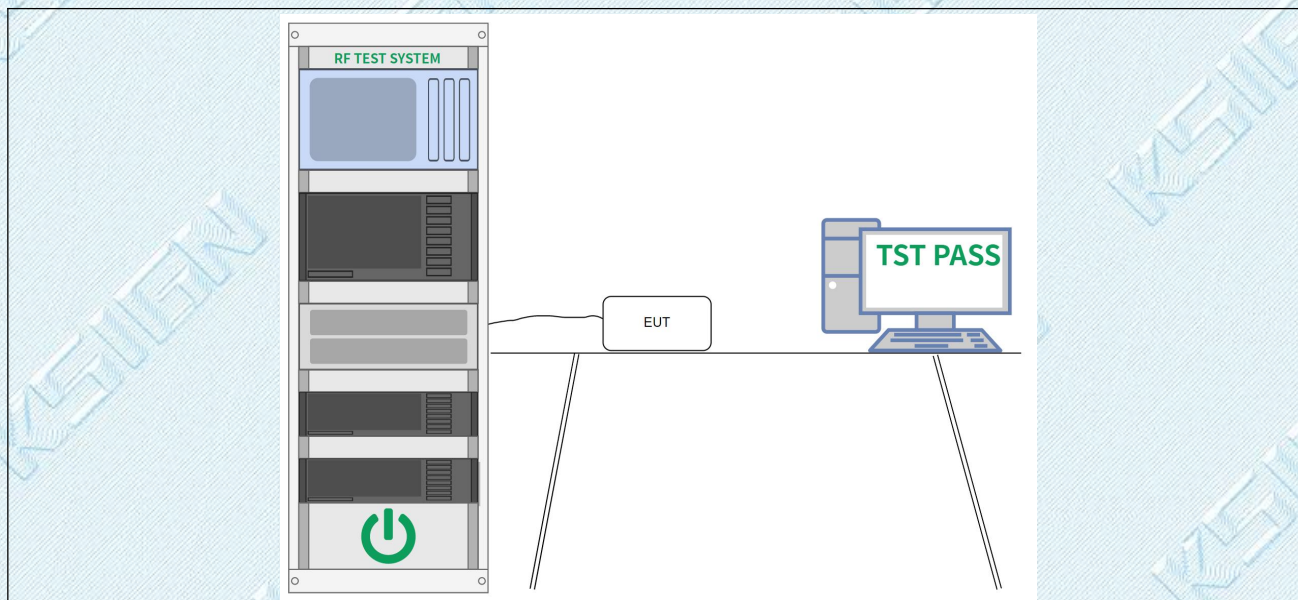

Procedure:	Emission bandwidth: - Set RBW = approximately 1% of the emission bandwidth. - Set the VBW > RBW. - Detector = peak. - Trace mode = max hold. - Measure the maximum width of the emission that is 26 dB down from the peak of the emission. Compare this with the RBW setting of the instrument. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%. Occupied bandwidth: - The instrument center frequency is set to the nominal EUT channel center frequency. The frequency span for the spectrum analyzer shall be between 1.5 times and 5.0 times the OBW. - The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW, and VBW shall be approximately three times the RBW, unless otherwise specified by the applicable requirement. - Set the reference level of the instrument as required, keeping the signal from exceeding the maximum input mixer level for linear operation. In general, the peak of the spectral envelope shall be more than $[10 \log (OBW/RBW)]$ below the reference level. Where practical, a sample detection and single sweep mode shall be used. Otherwise, peak detection and max hold mode (until the trace stabilizes) shall be used. - Use the 99% power bandwidth function of the instrument (if available) and report the measured bandwidth. - If the instrument does not have a 99% power bandwidth function, then the trace data points are recovered and directly summed in linear power terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5% of the total is reached; that frequency is recorded as the lower frequency. 	99.5% of the total is reached; that frequency is recorded as the upper frequency. 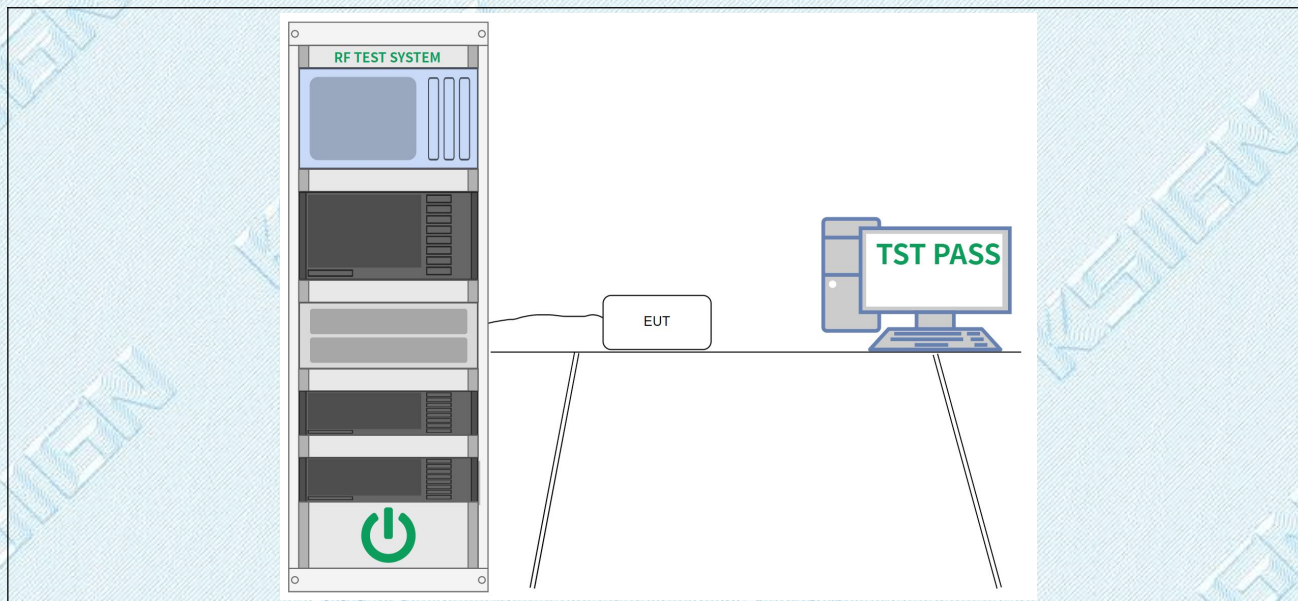

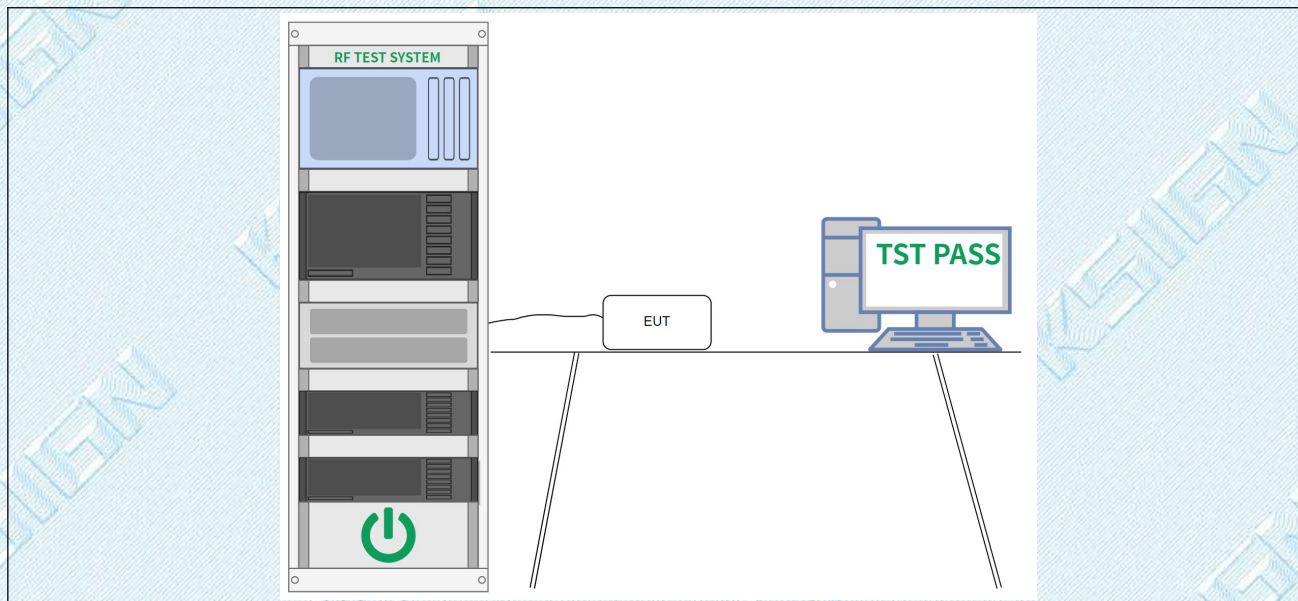

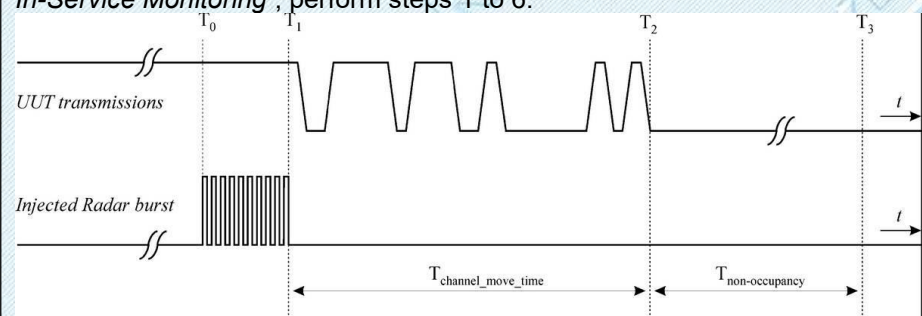

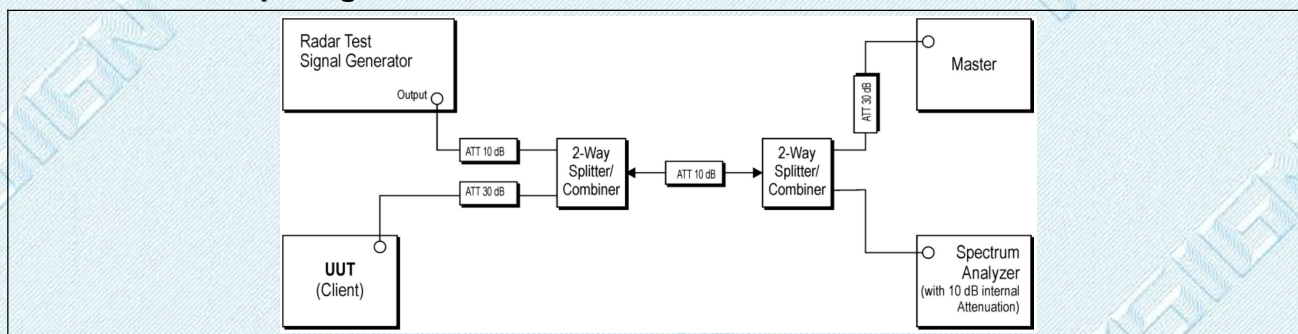

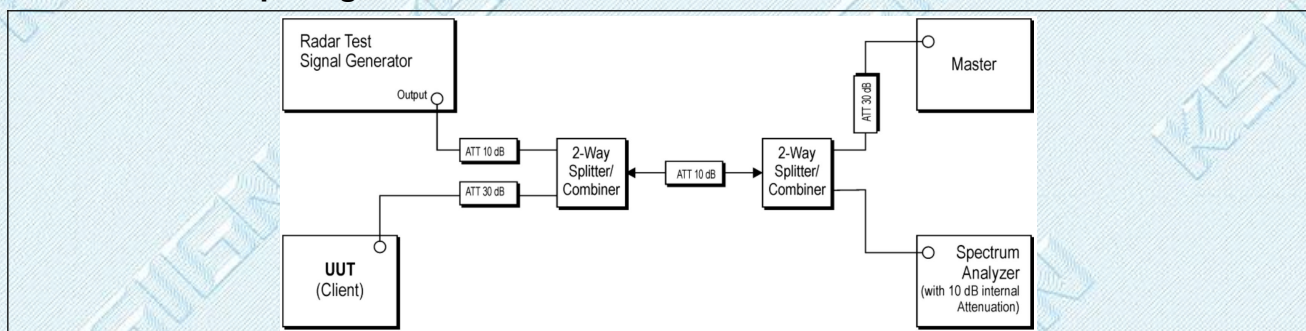

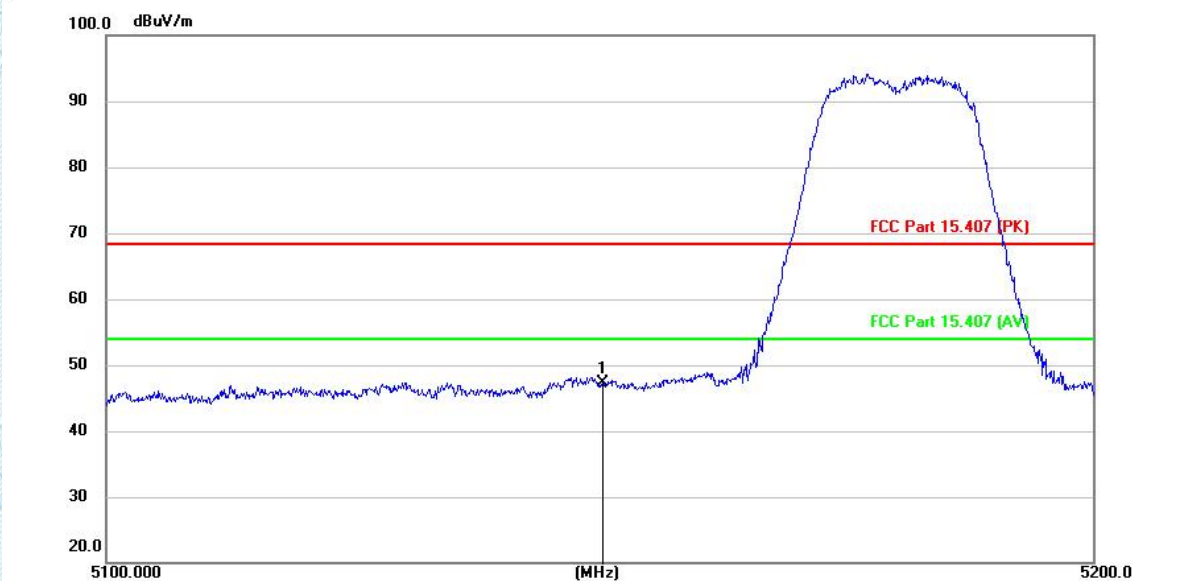

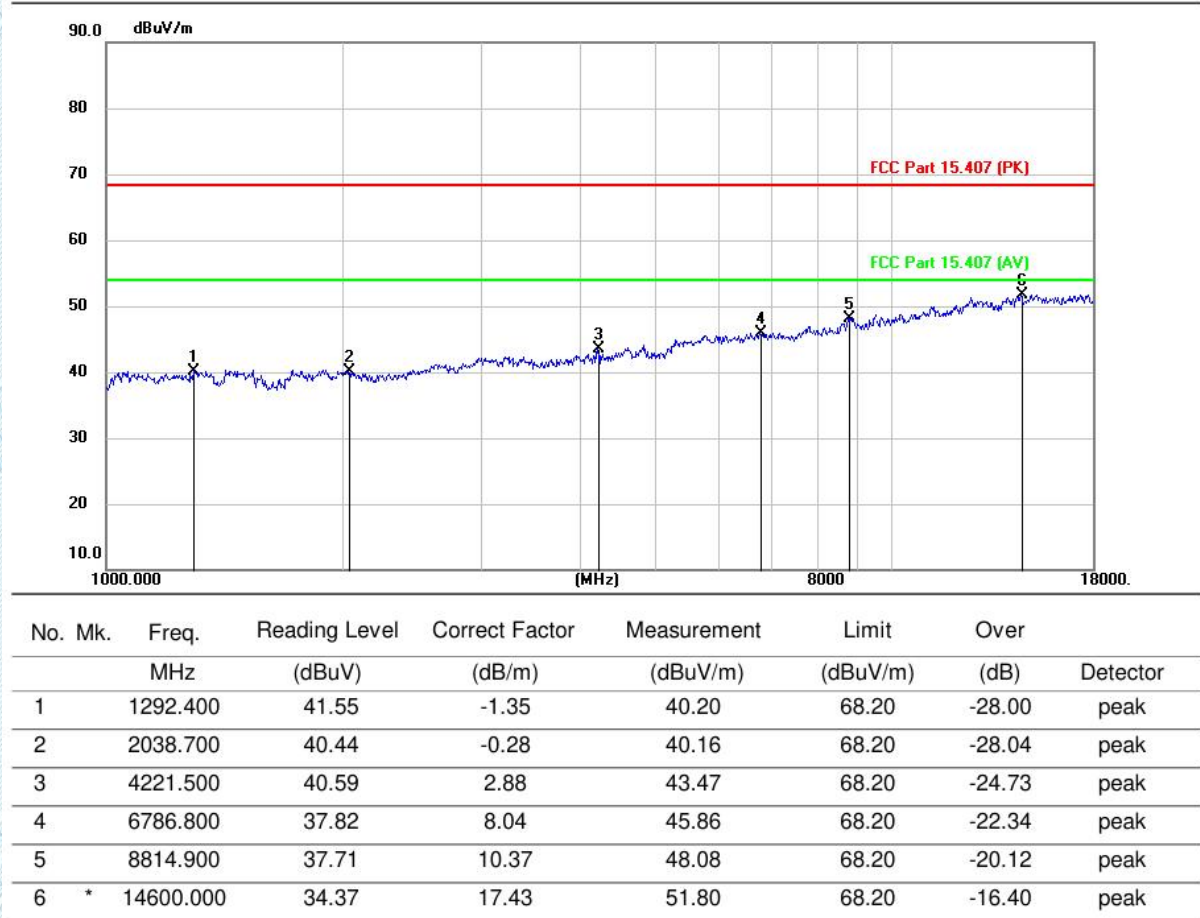

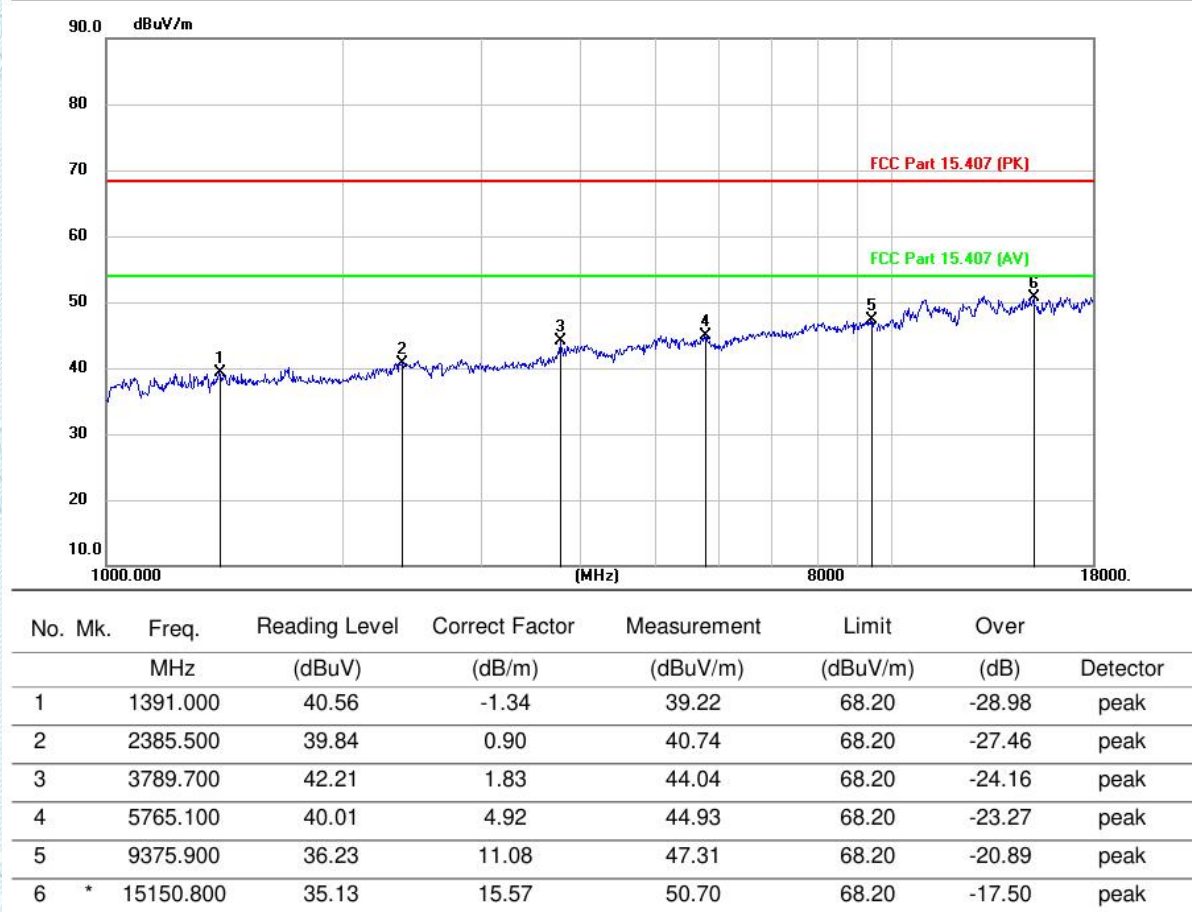
