







Front Surface, 0mm**






**Photograph 5. Product specific 10-g SAR,




Photograph 9. Product specific 10-g SAR,
Right Edge, 0mm




Photograph 10. Product specific 10-g SAR,






Photograph 15. Product specific 10-g SAR, Left Edge, 0mm







Photograph 19. Body, Horizontal-Up, 5mm




Photograph 20. Body, Horizontal-Up, 5mm




Photograph 21. Body, Horizontal-Down, 5mm








Photograph 25. Body, Vertical-Back, 5mm


