

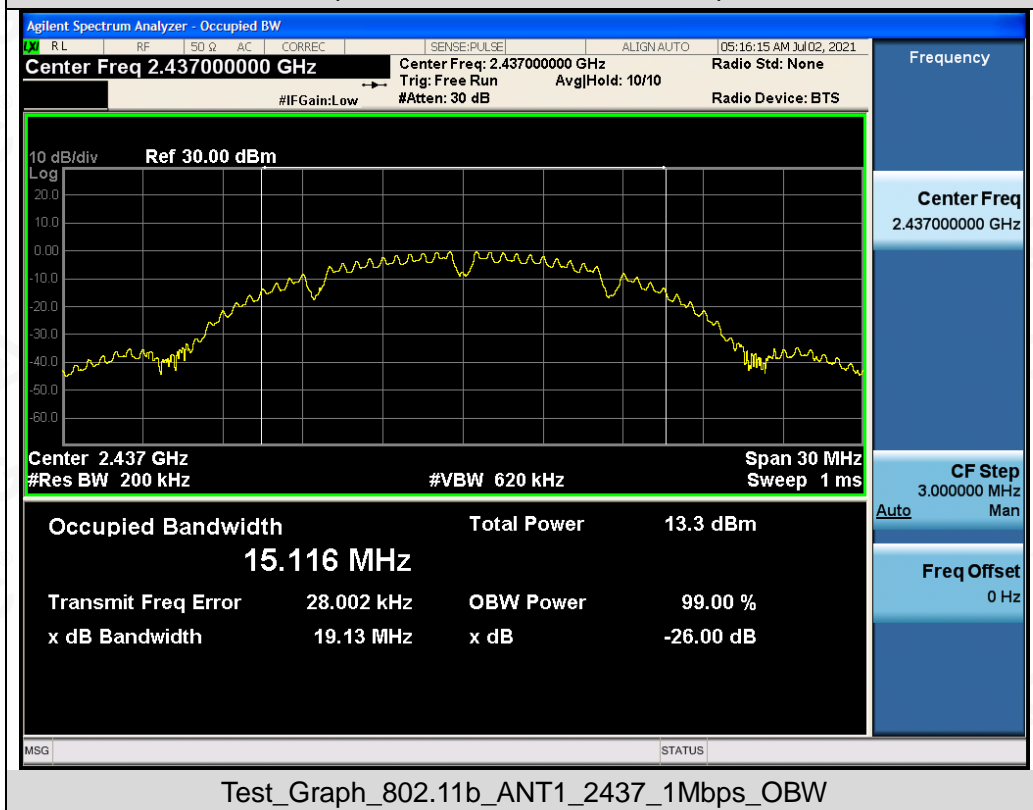




### Test Graphs of Occupied Bandwidth



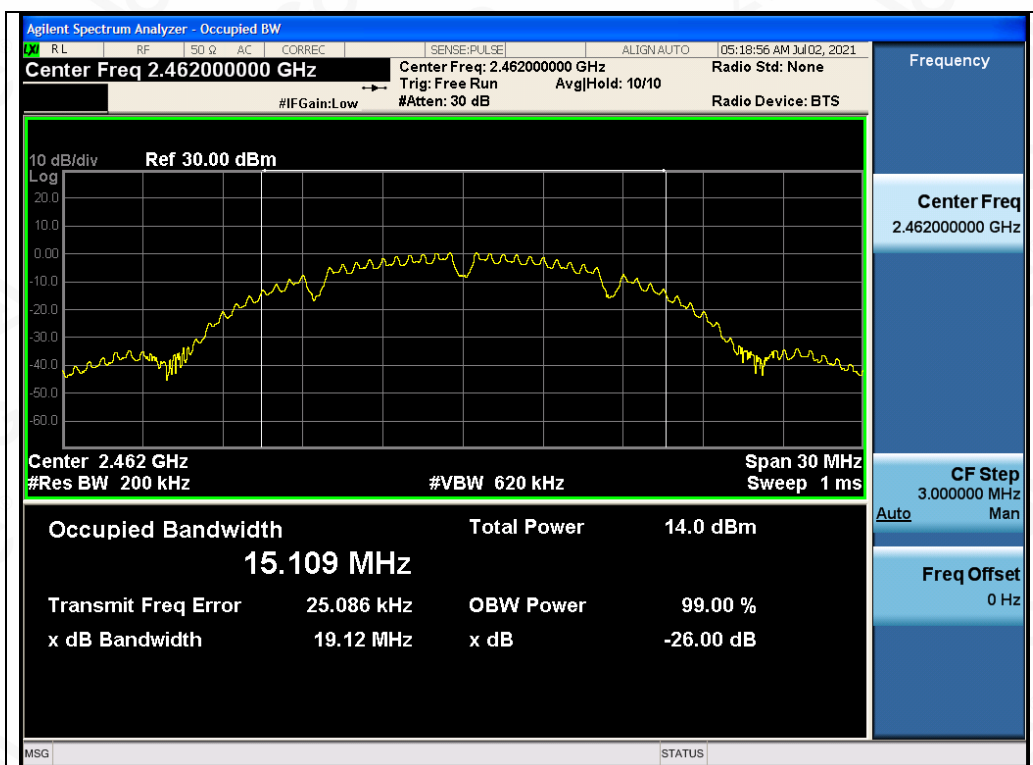

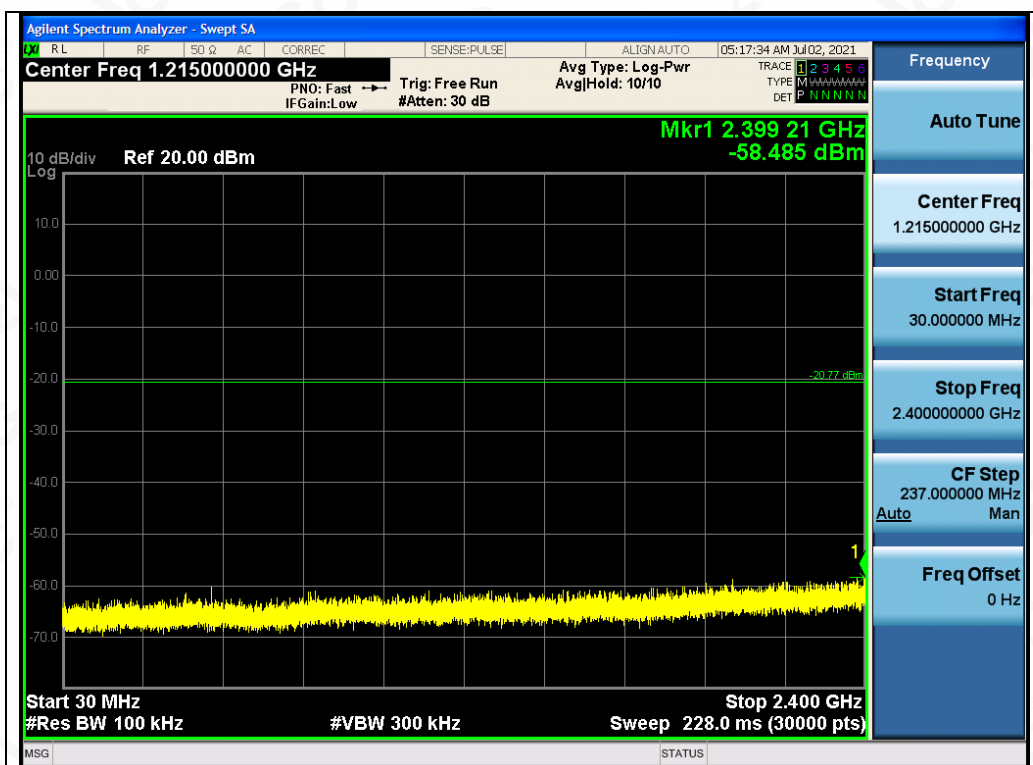

Test\_Graph\_802.11n20\_ANT1\_2437\_MCS0\_Lower Band Emissions

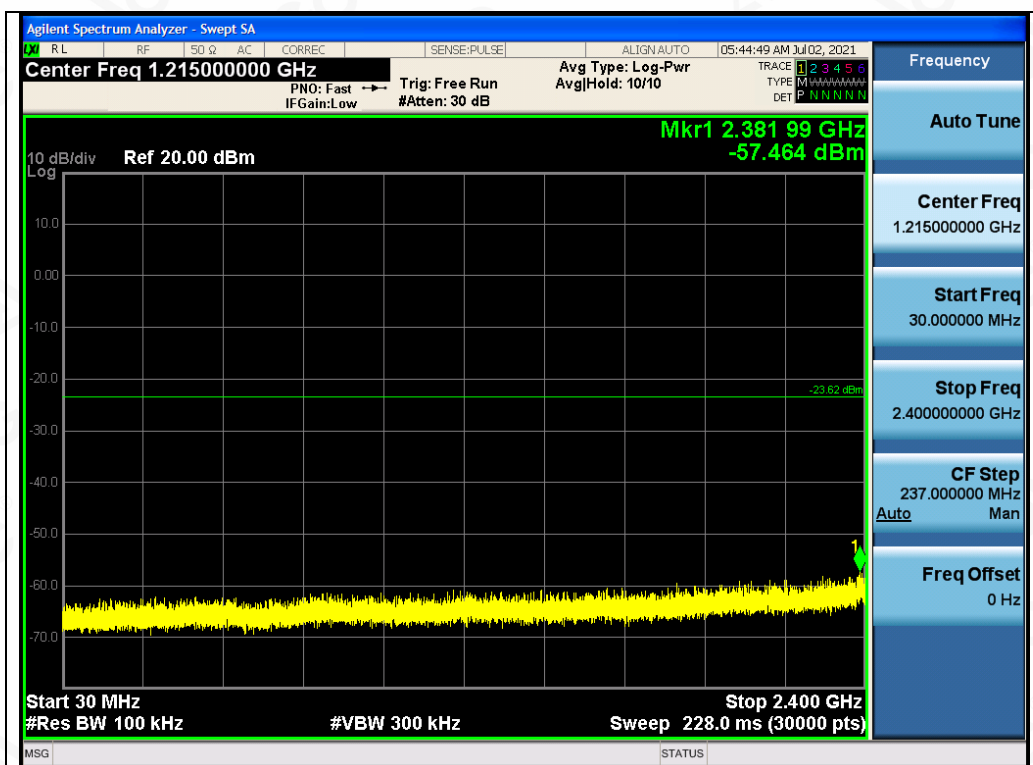

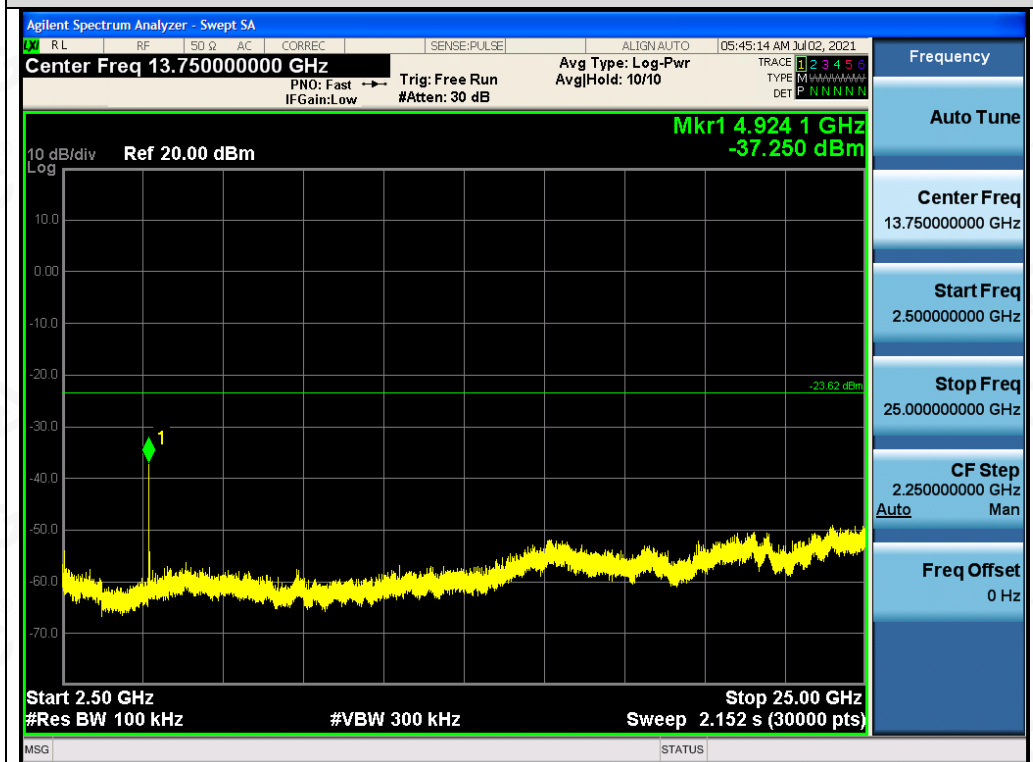
