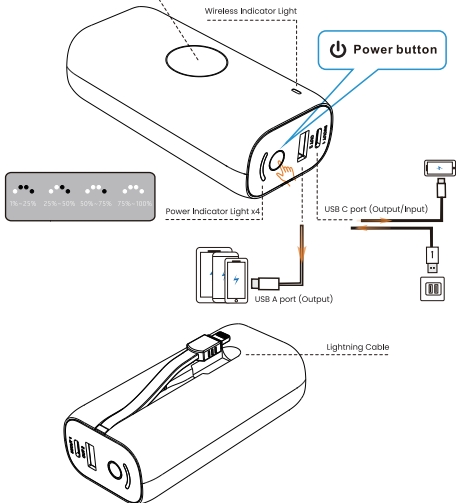

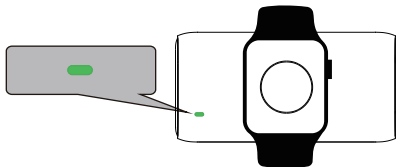

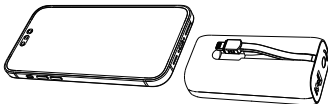
Charge Your iPhone by Lightning Cable

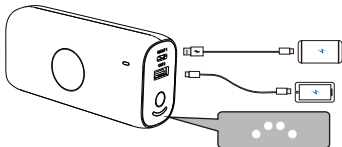

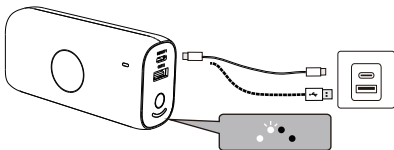
Recharge your power bank. (Use PD/QC adapter to achieve faster charging.)

Wireless Charging Safety Protection

When the metal touches its wireless charging pad, the green light will flash and the other lights will stay on white.

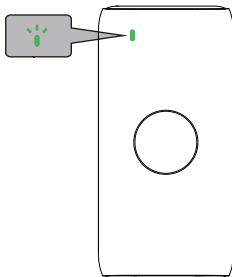
