Important Note:


Before using the product, it is critical for the user to fully charge the product with the provided USB cable for 2 hours. While charging, the Red LED indicator will be lighted and upon fully charged, it will be automatically switched off. When inflate or deflate, do not plug the cable into the USB, to prevent the USB from being crushed.

How to Use Bluetooth working

- Press & hold the Bluetooth Button for 3 seconds to switch on Bluetooth: "Bluetooth device is ready to pair"
- Open the Bluetooth on your phone, search for "effatables" and connect: "Bluetooth device is connected successfully"
- Play the music on your phone
- Press & hold the Bluetooth Button for 3 seconds: "Bluetooth Power Off"




Charging

- Charge the product directly with the USB cable provided. The charging time is about 2 hours.
- Solar charging: expose the solar panel to the sunlight for 20-24h to fully charge the product.

Notice: The USB charging port needs to be plugged when not in charging, so as to avoid water.

USB Output

The product comes with a USB output cable for using the Dry Bag as a power bank in emergency. Connect the USB output cable to the USB port on the solar panel, and connect the other end of the USB output cable with your USB charging cable, then you can use the bag as a power bank.



Special attention:

when the product is charged and deflated, it is necessary to pinch the bottom of the valve to open the valve in or out of the air, and then pull or press it down evenly and slowly to make the product inflate or deflate slowly. It is necessary to avoid the product from being pulled or pressed by brutality to cause product damage.
