


PO光·颈部美容仪

Thank you for purchasing our product. Please read this instructions carefully before using it.



The manual operation method is as follows:
For manual operation, please tap the switch button to turn on the device, and switch to other modes by continuing to press the switch button.



Instructions for mode selection:
1. Press the switch button to power the device.
2. Press the switch button to shift modes:
① Professional mode: red light, the unit run time of the device is 20 mins;
② Daily mode: red light and left-right alternating vibration, the unit run time of the device is 20 mins;
③ Stress-free mode: red light and left-right simultaneous vibration, the unit run time of the device is 20 mins;
(Different types of devices have slightly different modes.)
3. Hold on the switch button to turn off the device.

Indicator light description:
Indicator light - Red light flashes means low battery.
During charging - white light always on,
The indicator goes off when product is fully charged.

Tips

- * It is recommended to use it every other day, and do not use it during menstruation.
- * This device should be placed in a ventilated and dry place after use.
- * Do not put other heavy objects on the device.

Care and maintenance

- * When cleaning this device, please turn off the power first, then use wet tissue paper to clean its surface. Do not clean it with alcohol or put it in water.
- * Please use neutral detergent and soft cloth for cleaning.
- * Please do not let liquid flow into the device during cleaning.

Notes:

- * If you feel uncomfortable after using the device, stop using it and consult a doctor.
- * This device contains a lithium battery, so please do not disassemble or modify the device, or immerse the device in water or place the device in fire; otherwise it may be damaged or

even explode.
 * Do not use the device for purposes other than those described in the instructions; otherwise it may cause discomfort or the device may be damaged.

* Please do not disassemble, repair or modify this device without authorization; otherwise it may fail to function normally.

* Do not plug and unplug the USB charging cable with wet hands; otherwise it may cause electric shock or accident.

* Do not let children use the device.

* Do not use the device in the bathroom and other places with high humidity, or use the device while taking a bath; otherwise it may cause discomfort or it may be damaged.

* Do not use the device while sleeping; otherwise the device may fail to function normally.

* Please wear this device in a correct way.

* When the device works for a long time, the surface will be heated, which is a normal phenomenon.

* Please confirm that the main switch button works properly before use.

* When discarding this device, please dispose of it according to the urban regulations on environmental protection; otherwise it may cause environmental pollution.

* Please do not use or store this device in the following places: places with direct sunlight, high temperature and humidity; places with water and a lot of dust; places vulnerable to vibration and shock; places near fireworks; places in strong electromagnetic fields

* Do not use this device while exercising.

Contraindication:

- * Users who are allergic to light or suffering from porphyria, autoimmune diseases (such as systemic lupus erythematosus) should not be exposed to light therapy.
- * Those who have taken photosensitizers within 4 weeks;
- * Ladies during pregnancy, lactation and menstruation;
- * Those with hypertension or uncontrolled blood pressure. People with severe cardiovascular and cerebrovascular diseases (such as multiple cerebrovascular sclerosis) should use the product with caution;
- * Patients with high fever;
- * Those using pacemakers;
- * Those with malignant tumors in skin or other parts of body, or those with precancerous lesions
- * Patients with severe chronic diseases, endocrine diseases, major infectious diseases and acute inflammation (such as fever and skin suppurative inflammation);
- * Patients within 2 weeks after invasive cosmetic surgery and facial filling surgery.
