Test Procedure

1. The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram above.

2. DTS Spectrum Setting:

- (1) Set RBW = 100 kHz.
- (2) Set the video bandwidth (VBW) ≥ 3 RBW.
- (3) Detector = Peak.
- (4) Trace mode = Max hold.
- (5) Sweep = Auto couple.

OCB Spectrum Setting:

- (1) Set RBW = 1% ~ 5% occupied bandwidth.
- (2) Set the video bandwidth (VBW) ≥ 3 RBW.
- (3) Detector = Peak.
- (4) Trace mode = Max hold.
- (5) Sweep = Auto couple.

NOTE: The EUT was set to continuously transmitting in each mode and low, Middle and high channel for the test.

Test Procedure

1. The maximum conducted output power may be measured using a broadband Peak RF power meter.
2. Peak power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor.
3. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter.

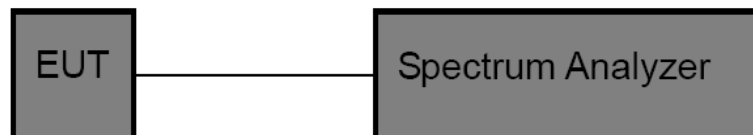

1. The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram above.
2. The EUT was directly connected to the Spectrum Analyzer and antenna output port as show in the block diagram above. The measurement according to section 10.2 of KDB 558074 D01 DTS Meas Guidance v05r02.
3. Spectrum Setting:
Set analyzer center frequency to DTS channel center frequency.
Set the span to 1.5 times the DTS bandwidth.
Set the RBW to: 3 kHz
Set the VBW to: 10 kHz
Detector: Avg
Sweep time: Auto
Allow trace to fully stabilize. Then use the peak marker function to determine the maximum amplitude level.

3.8. Antenna Requirement

Requirement

FCC CFR Title 47 Part 15 Subpart C Section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

FCC CFR Title 47 Part 15 Subpart C Section 15.247(c) (1)(i):

(i) Systems operating in the 2400~2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.
