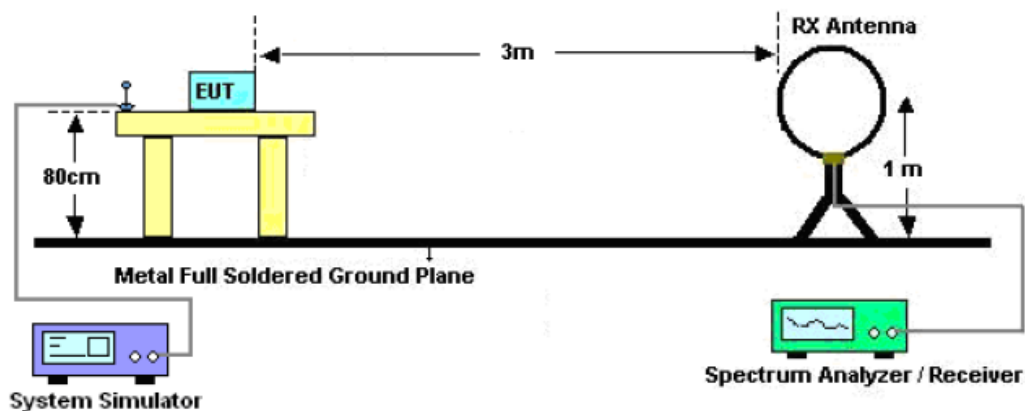
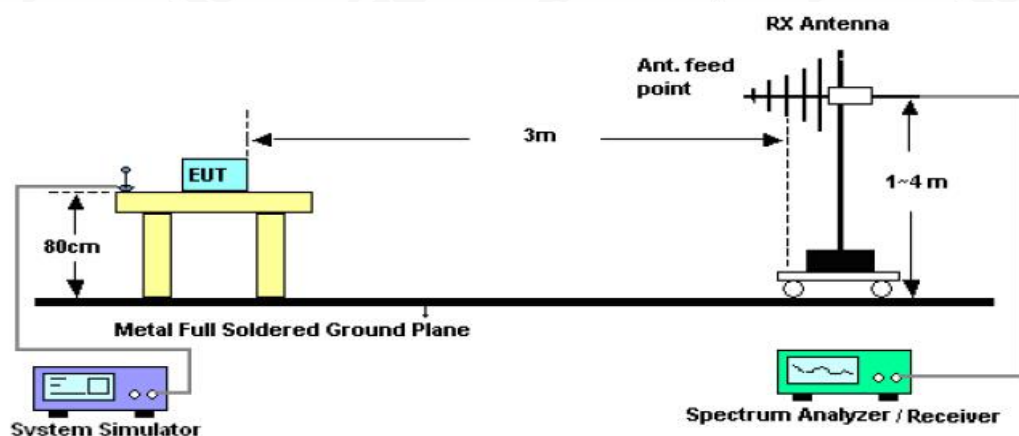

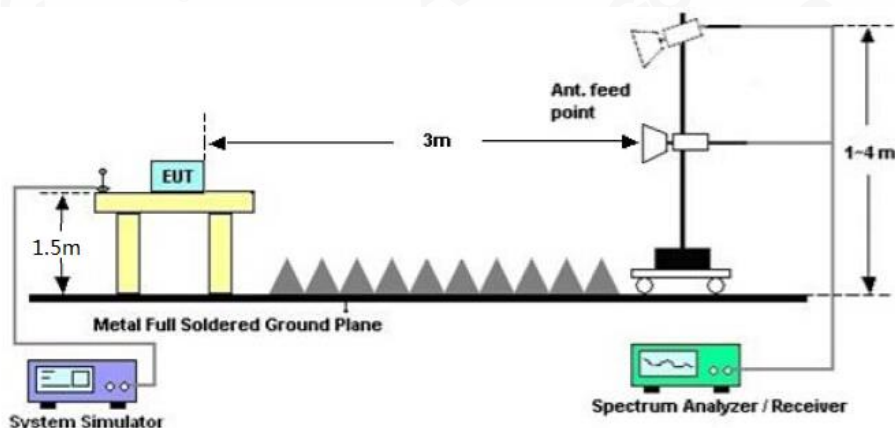
### Radiated Emission Test-Setup Frequency Below 30MHz

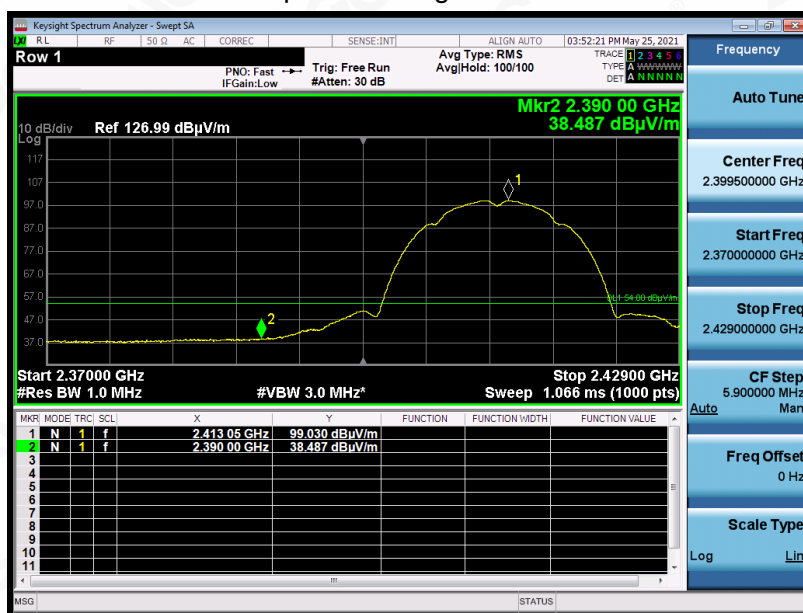

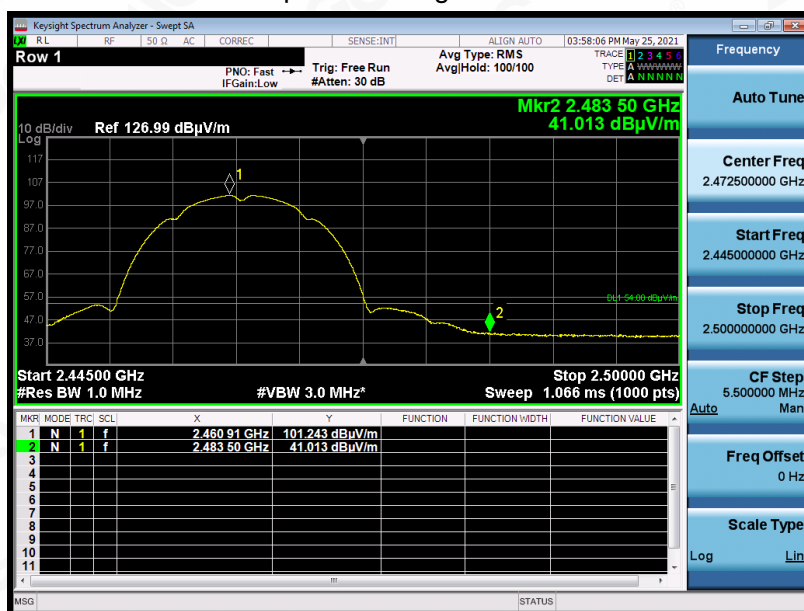

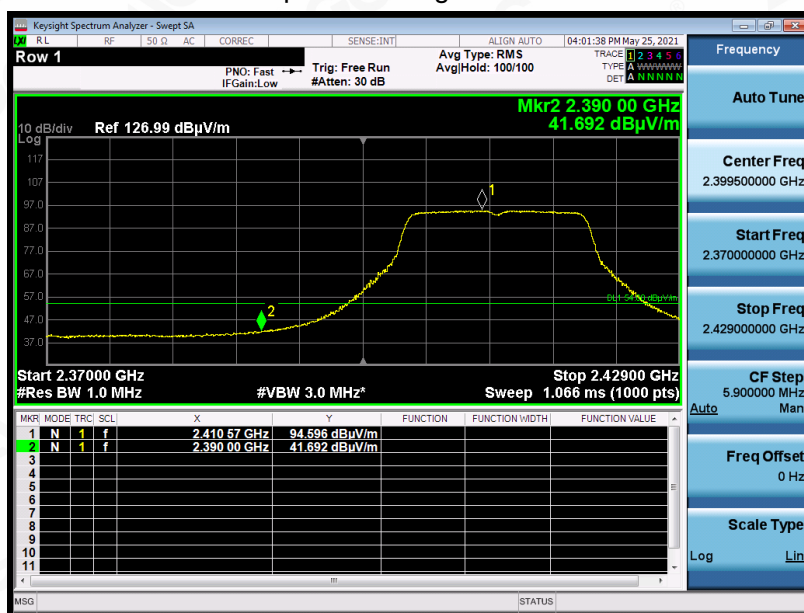

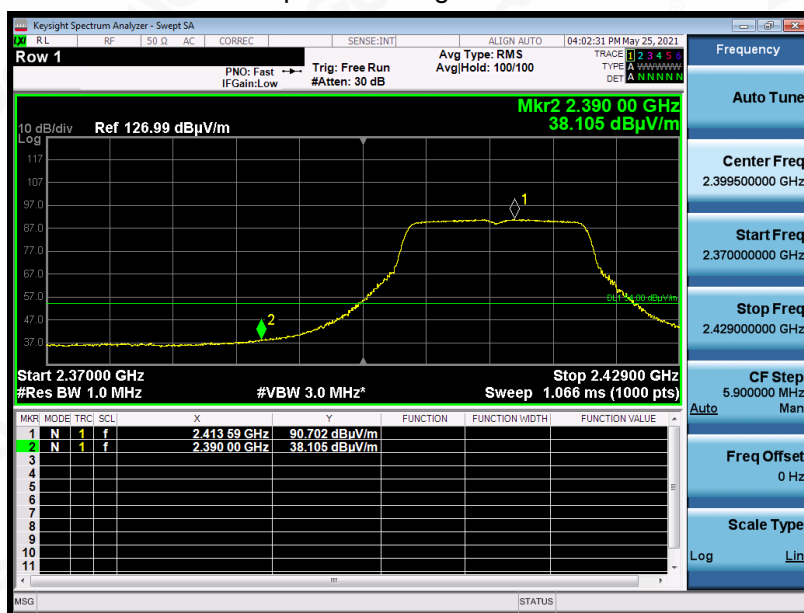

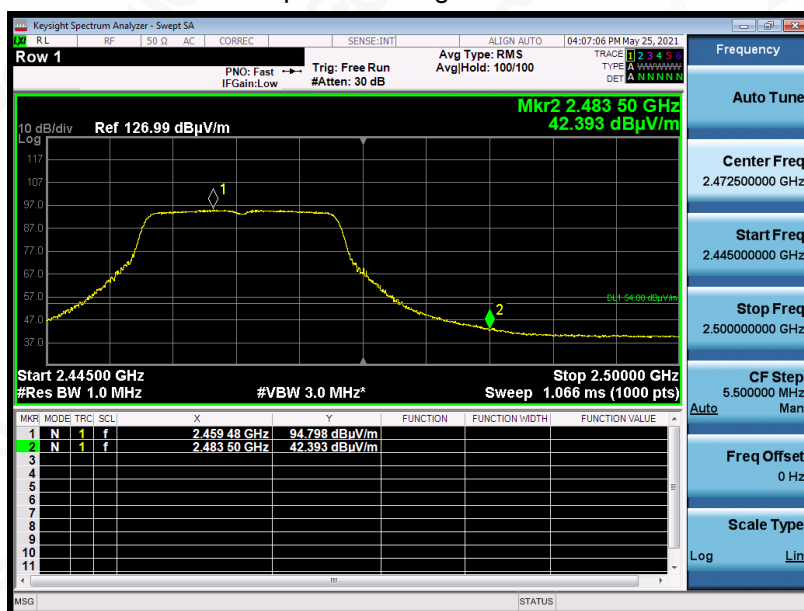

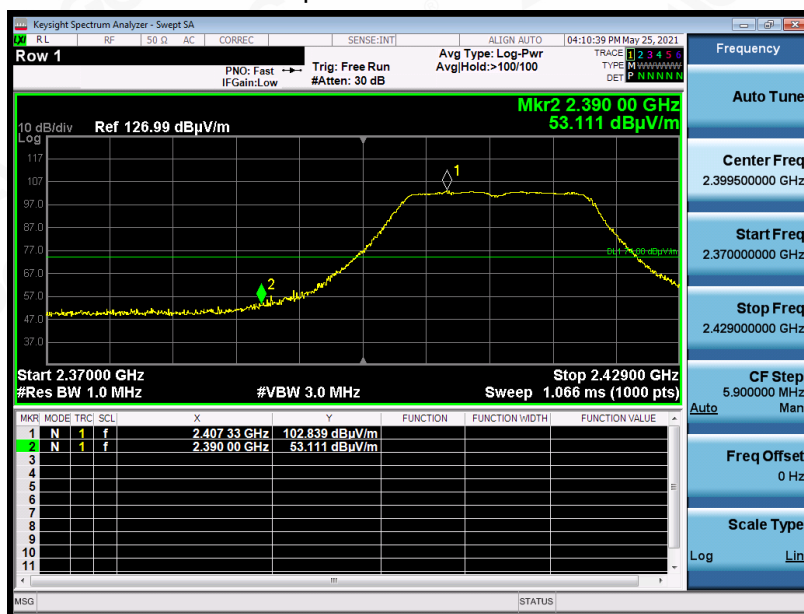

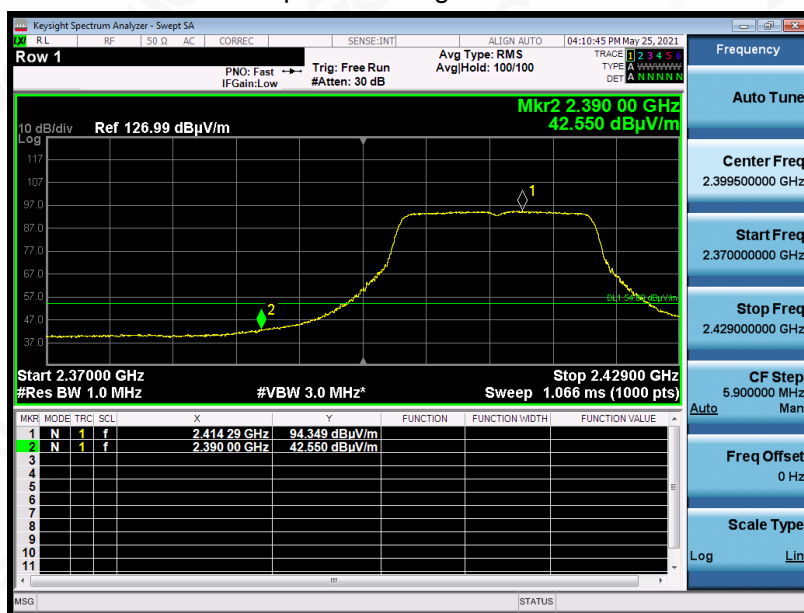

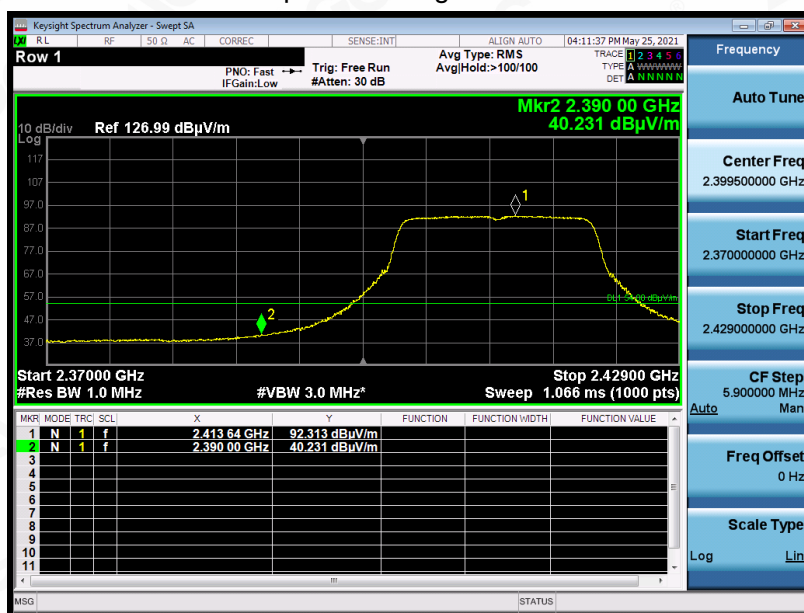

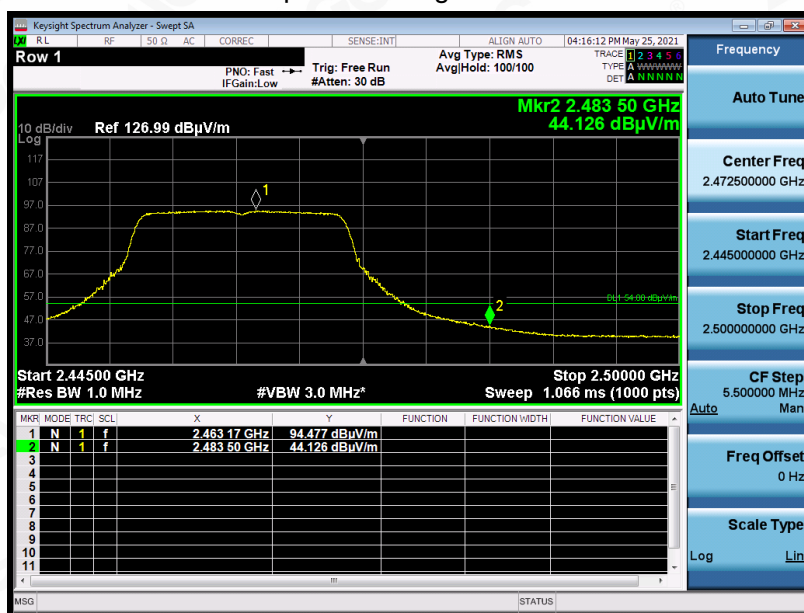

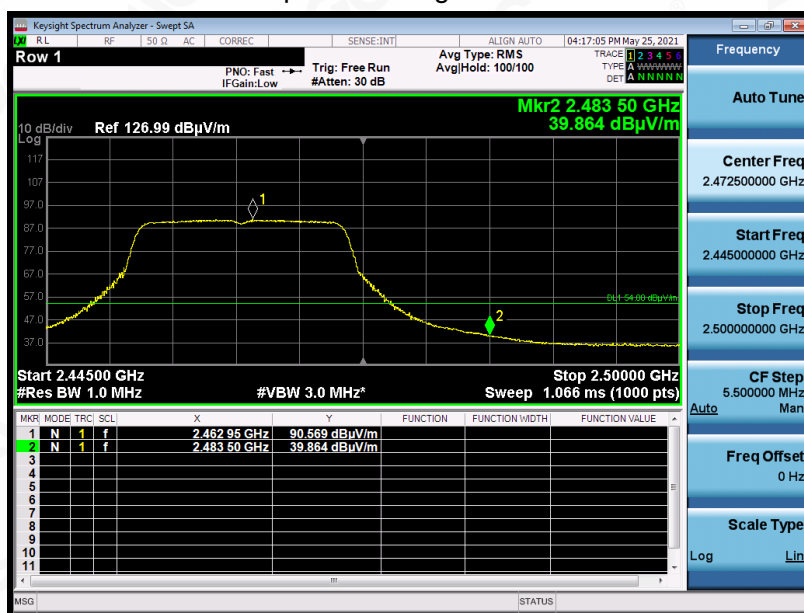

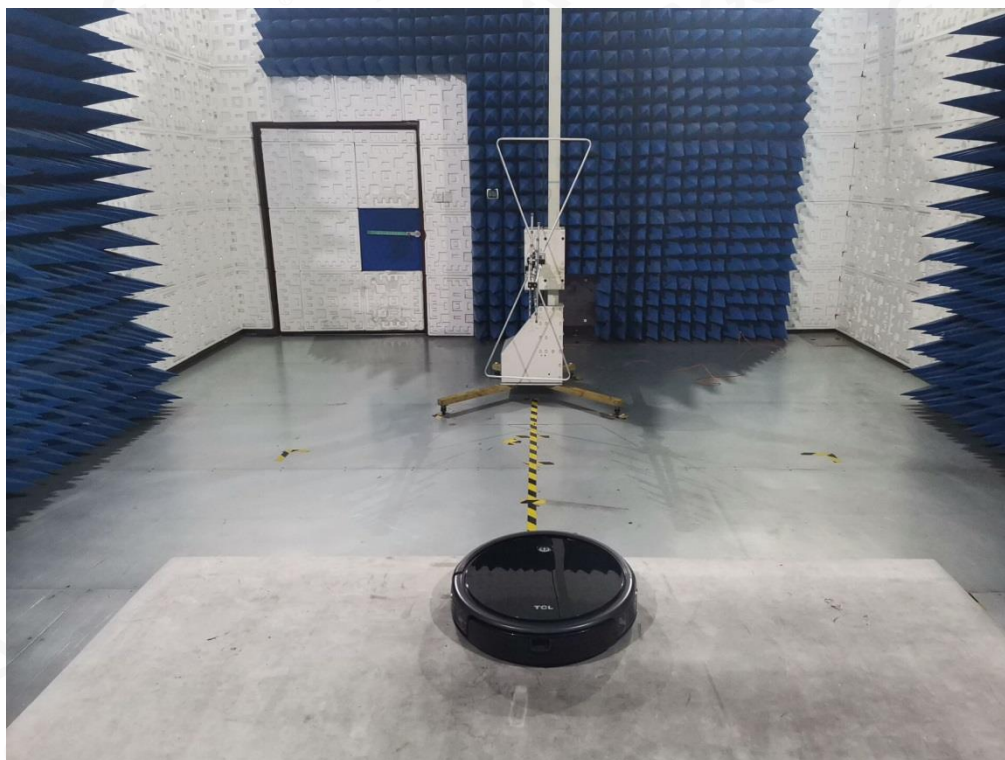

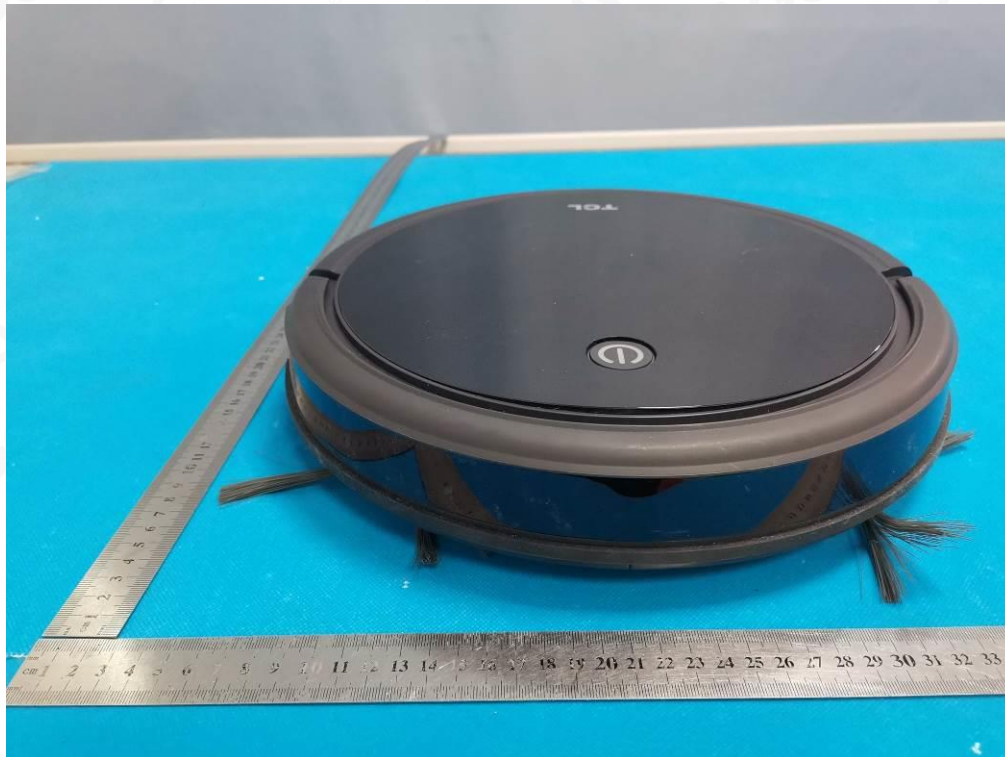




FRONT VIEW OF EUT

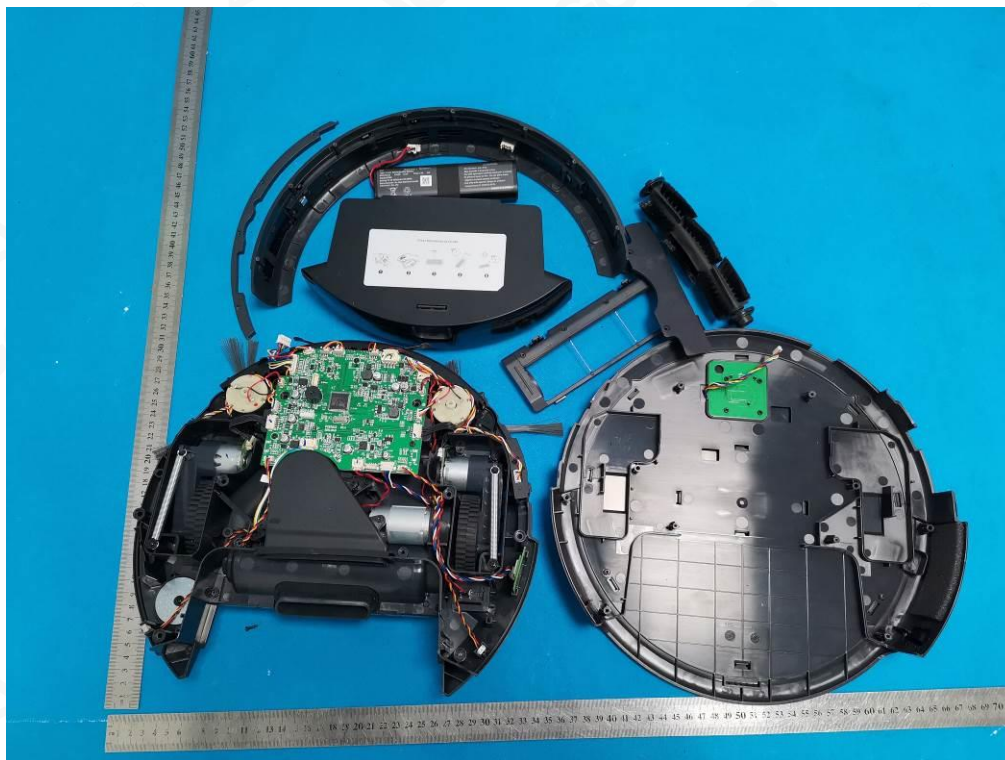
