



### Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands





Test\_Graph\_802.11b\_ANT1\_2412\_1Mbps\_Lower Band Edge Emissions




Test\_Graph\_802.11g\_ANT1\_2412\_6Mbps\_Lower Band Edge Emissions

**Test\_Graph\_802.11b\_ANT1\_2412\_1Mbps\_PSD**


