操作步骤:

1. 启动电源: 使用蓝牙时, 长按功能键直至红蓝灯亮, 并闪烁。
2. 蓝牙配对:
 - A. 长按蓝牙设备功能键不放, 当出现红蓝灯长亮时即可配对:
 - B. 启动手机蓝牙功能。
 - C. 打开蓝牙搜索功能。
3. 搜索到 **NFXSL** 型号, 点击连接, 选择该型号, 然后蓝灯闪烁即配对成功。
4. 接听电话: 手机来电时, 手机仍会响起来电铃声, 此时按蓝牙听筒功能键, 即可接听电话。
5. 结束电话: 通话完毕后, 按蓝牙听筒功能键, 放开即可以结束通话。
6. 拒接电话: 手机来电时, 长按两秒功能键, 放开即可以拒接电话。
7. 重拨: 重拨最后一个电话, 双击功能键或者长按功能键两秒实现重拨功能。
8. 关机: 长按功能键, 直至红蓝灯亮, 即关机。
9. 充电时耳机指示红灯, 当耳机充电完毕后, 红灯会熄灭蓝灯长亮, 第一次充电时间约四小时。

Manual

Use the steps:

- 1.Turn on the power: When using Bluetooth, press the function key until the blue lights and flashes.
- 2.pairing:
 - A.Press the Bluetooth device function key, when there is a long bright blue light when you can match:
 - B.Activate the phone Bluetooth function.
 - C.Open the Bluetooth search function.
- D. Search the model NFXSL, and then connect it with your phone, when the blue light flashes , it pairs successfully.
- 3.Calls: phone calls, the phone still rings ring tones, then press the Bluetooth handset function keys, can answer the call.
- 4.End the call: the call is completed, press the Bluetooth handset function keys, which can end the call.
- 5.Refused to answer the phone: phone calls, press the function key two seconds, which can refuse to answer the phone open.
- 6.TO re-pull: weight pulling the last call, double click the function key or press function key for two seconds to achieve re-drawing function.
- 7.Off: Press the function key until the red light, that is shut down.
- 8.When the charge headset indicating lamp demonstration red candle, after the earphone charge finished, the red candle can extinguish, first duration of charging approximately 4 hours.
