

**LICENSE AND EQUIPMENT IN EXCHANGE FOR RELEASE FROM OBLIGATION
AGREEMENT**

**THIS LICENSE AND EQUIPMENT IN EXCHANGE FOR RELEASE FROM
OBLIGATION AGREEMENT** (this “**Agreement**”) is entered into and made effective this 21st day of JUNE 2022 by and between **Feature Products, LTD.**, a New Hampshire corporation (“**Feature Products**”), and **Blue Tiger USA**, an organization of 2403 W Stan Schlueter Loop, 690160, Killeen, TX 76549 (“**Blue Tiger**”).

WHEREAS, on the terms and subject to the conditions set forth in this Agreement, Feature Products will waive, cancel and forgive any and all amounts owed, indebtedness, or other obligations owed to Feature Products by Blue Tiger (the “**Forgiven Debt**”) in exchange for: (i) tooling equipment as outlined in attached Exhibit A (Equipment); and (ii) a nonexclusive license to continue manufacturing the headsets according to the original Purchase Order, RF 100150, dated January 31, 2019 (attached as Exhibit B) (hereinafter summarily described as the “**Equipment and Headset License**”).

NOW, THEREFORE, in consideration of the foregoing premises, and the agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge, the parties hereto hereby agree as follows:

1. Mutual Agreement. It is acknowledged and agreed that Feature Products hereby waives, cancels, and forgives any and all payment and/or other obligation owed by Blue Tiger to Feature Products in consideration of and conditioned upon Feature Products’ receipt of the Tooling, Inventory, and Headset License. Feature Products acknowledges and agrees that Feature products may not use any Blue Tiger trademark, logo, branding, or any substantially similar tiger motif on any products manufactured or sold by Feature Products.
2. Issuance of the Equipment and Headset License. Blue Tiger hereby issues to Feature Products the ownership of the Equipment and Headset License in consideration of the mutual agreement outlined in section 1.
3. Issuance of License to Manufacture. As part of said ownership, Blue Tiger hereby issues to Feature Products a nonexclusive license to continue manufacturing the headsets according to the original Purchase Order, RF 100150, dated January 31, 2019 (attached as Exhibit B) provided any Blue Tiger logo is removed as indicated by Section 1 of this Agreement.
4. Entire Agreement. This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes any prior understanding or representation of any kind preceding the date of this Agreement. This Agreement may only be amended or modified if signed by both parties.
5. Counterparts. This Agreement may be executed in two or more counterparts, all of which when taken together shall be considered one and the same agreement and shall become effective when counterparts have been signed by each party and delivered to each other party, it being understood that the parties need not sign the same counterpart. In the event that any signature is delivered by facsimile transmission or by


e-mail delivery of a “.pdf” format data file, such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or “.pdf” signature page were an original thereof.

6. Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the parties and their successors and permitted assigns. The parties may not assign this Agreement or any rights or obligations hereunder without the prior written consent of the other party.

8. Governing Law. All questions concerning the construction, validity, enforcement and interpretation of this Agreement shall be governed by and construed and enforced in accordance with the internal laws of the State of New Hampshire, without regard to the principles of conflicts of law thereof.
