Function Operation and Features:

- 1.M
Short press for switching among BT, TF CARD, USB, LINE IN,
2.
Tap to switch the light mode
- 3.—
Play the previous music under BT, TF card and USB mode,
Play previous radio station under FM mode.
Press and hold to reduce the volume
EQ mode can reduce treble and bass
- 4./TWS
Short press for music play/pause
Long press for radio station automatic searching under mode.
Long press slave speaker's P/P button to disconnect to master speaker
Long press master speaker's P/P button to disconnect to both slave speaker and mobile phone

Support USB and can play MP3 and WAV format music in U disk
- 10.TF card Port
Support TF CARD and can play MP3 and WAV format music in CARD

- Power on the product or press MODE button to enter into BT mode.

- After the device has been paired successfully for the first time, it will connect automatically around 10 seconds to the devices which connected before when next time use.(Note: Each product could connect to one BT device only.)
