1. Product Overview

2. Environment requirement

Operation temperature: +10°C ~ +40°C.
Storage temperature: -10°C ~ 65°C.
Operating Humidity: 10% ~ 80%RH, non-condensing.
Storage Humidity: 10% ~ 85%RH, non-condensing.


3. Directions for Operation

3.1 Pairing Remote

Unplug the bed from the power source, then press and hold **HEAD DOWN** and **FLAT** Buttons simultaneously until the blue backlights of the remote control are off.



3.2 ADJUST:



The HEAD ▲▼ arrows lift and lower the head section of the foundation.



The FOOT ▲▼ arrows lift and lower the foot section of the foundation.

3.3 ONE TOUCH BUTTON:

-  One-touch flat position.
-  One-touch **ANTI-SNORE** preset position.
-  One-touch **TV** preset position.
-  One-touch **ZERO G** preset position.
ZERO G adjusts your legs to a higher level than your heart, helping to relieve pressure of the lower back and promote circulation.
-  One-touch programmable positions.

3.4 UNDERNEATH LED LIGHTING

-  One-touch underneath **LED** lighting on/off.

4. Matters needing attention:

- 4.1 The function will only work normally in proper working power conditions.
- 4.2 Remote Control needs three AAA batteries.
- 4.3 The control box is needed for proper control.
- 4.4 If problems are identified, they must be treated by professional personnel.

5. Additional attention for user:

5.1 This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules.
