## Quickstart Guide



### App Setup

Download the sun-a-wear app from the iOS App Store or Google Play Store (scan the QR code or search for sun-a-wear).

Position the tracker in direct sunlight and follow the app's guided steps for setup.

### Wearing the Tracker

Ensure the tracker has unobstructed exposure to sunlight.

Recommended placements:

- Clip onto a thin shirt collar.
- Attach to provided wristband.

## Caution

- Avoid clipping on materials thicker than 2mm to prevent clip breakage.
- Make sure the tracker is not covered by sleeves, hair, or other obstructions.
- Avoid placement in areas where collision or contact could cause loss or breakage of the tracker.
- Prevent contact with sunscreen or solvents to avoid damage and maintain accuracy.

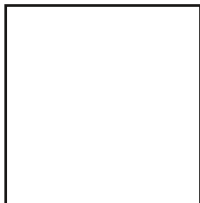
