



Replace the battery compartment cover.</div><div>3.Plug the Wireless USB Connector into your computer or device.</div><div>4.The Wireless mouse should begin to work automatically.</div></div></div>		<div><div>TROUBLE SHOOTING</div><div>If the cursor doesn't move when you move the mouse... - Check the Wireless USB Connector connection. Try inserting it into another USB port on your computer. - Take the batteries out and reinstall it. Replace the batteries with two that has a full charge.</div><div><b>IMPORTANT NOTE:</b> The battery should not be opened or burned. Exposure to the ingredients contained within or their combustion products could be harmful.</div><div><b>Storage:</b> Store in a cool, well ventilated area. Elevated temperatures can result in shortened battery life. <b>Mechanical Containment:</b> Designers of any water or air-tight device should be aware of the normal evolution of hydrogen gas from alkaline batteries.
