DH5_Ant1_Hop



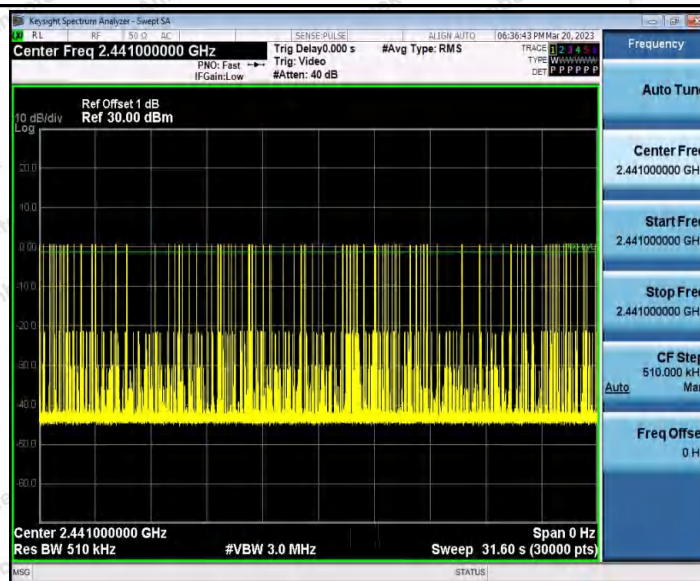

2DH5_Ant1_Hop



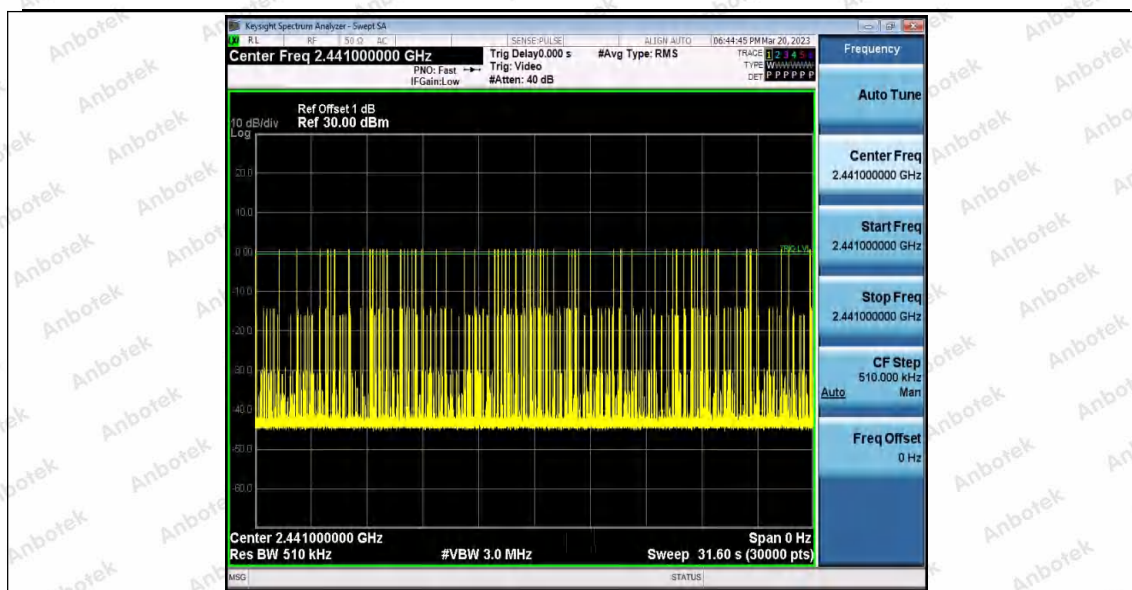

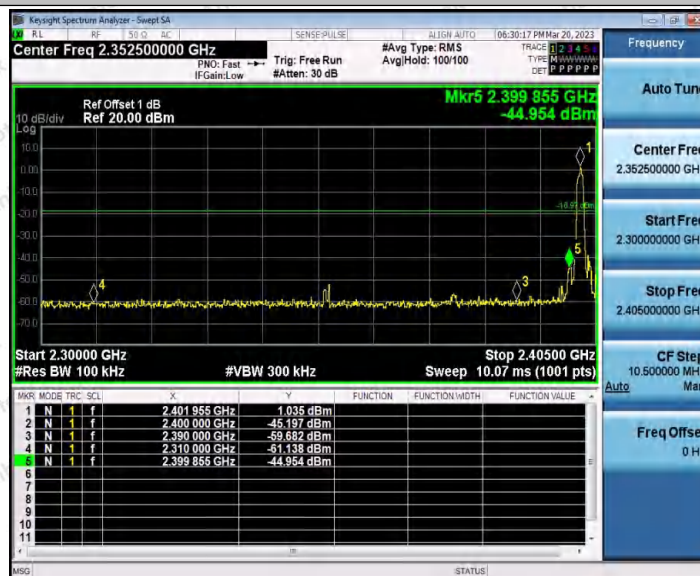




DH5_Ant1_High_Hop_2480
