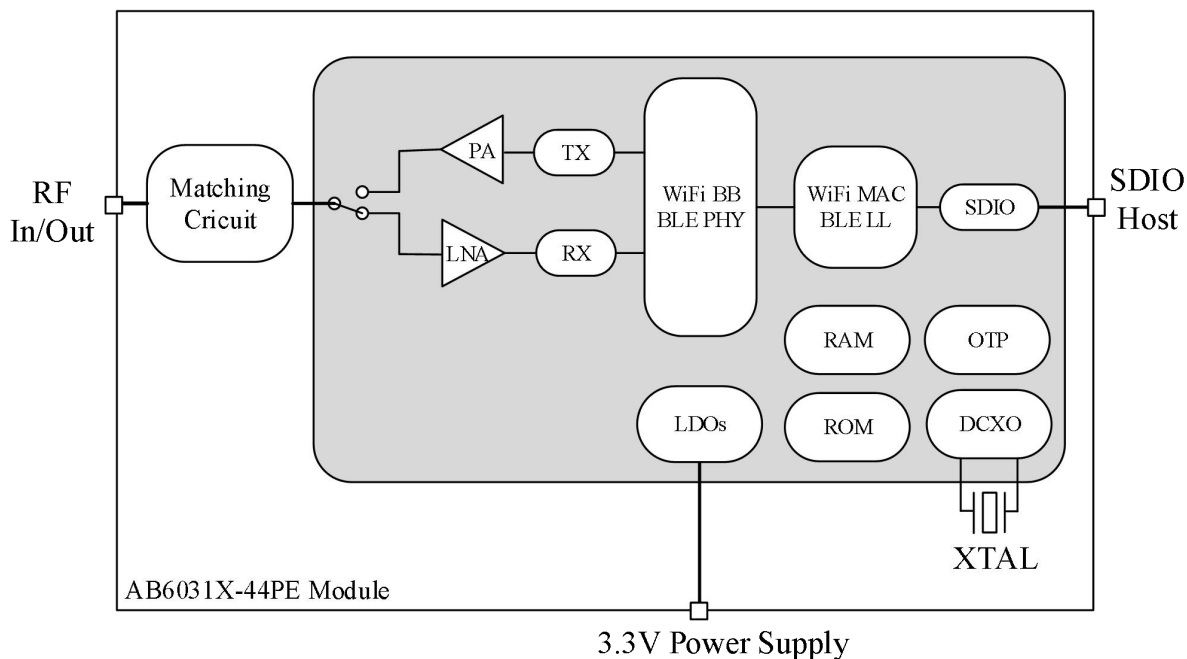

# 1 Overview

AB6031X-44PE module is a highly integrated 1T1R 2.4GHz IEEE 802.11b/g/n and Bluetooth LE v5.0 device with SDIO interface (SDIO 2.0 compliant), based on AltoBeam's ATBM6031-X IC chip. The AB6031X-44PE module can be used in IP camera, printer and smart household products that need to connect Wi-Fi networks.

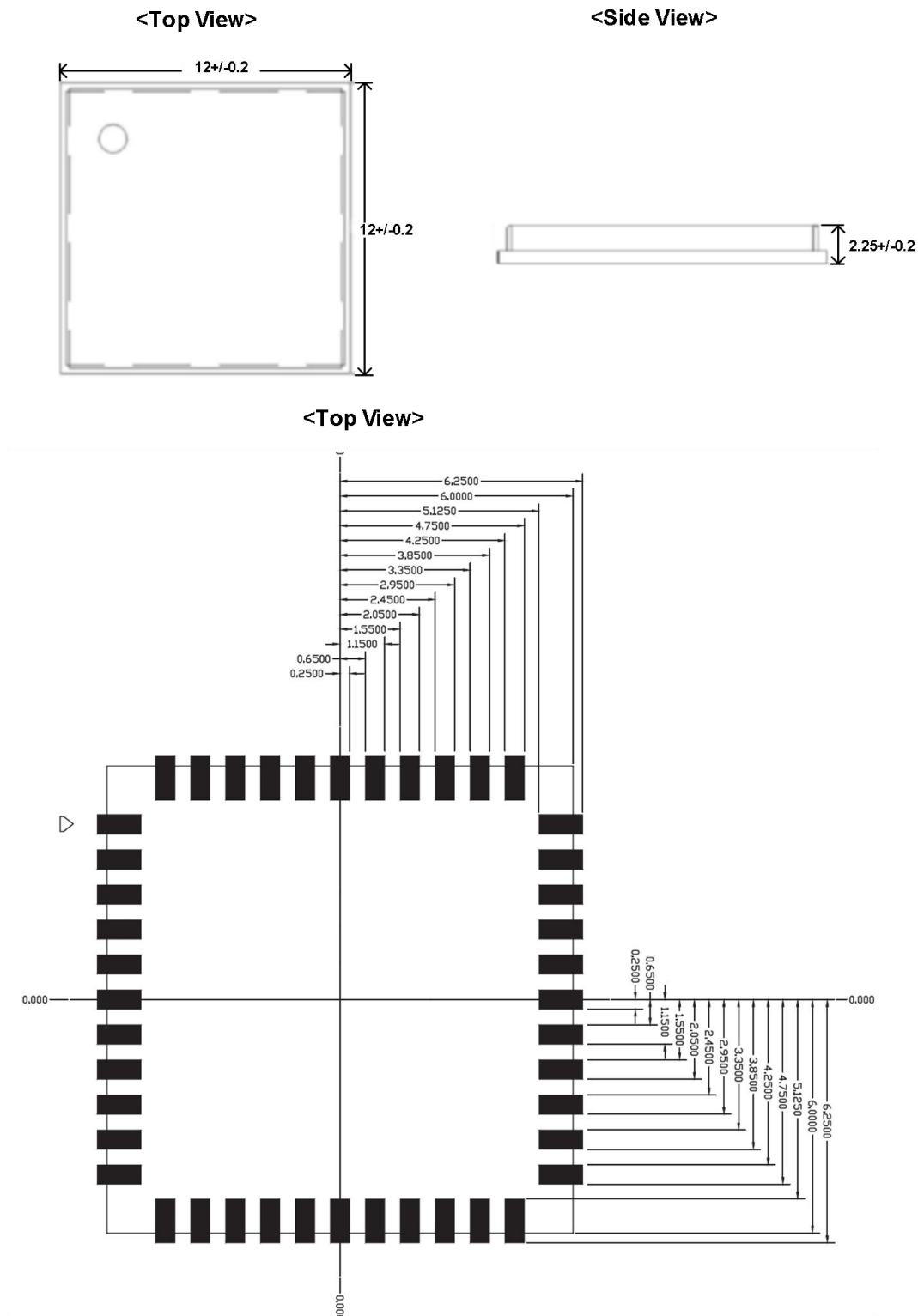
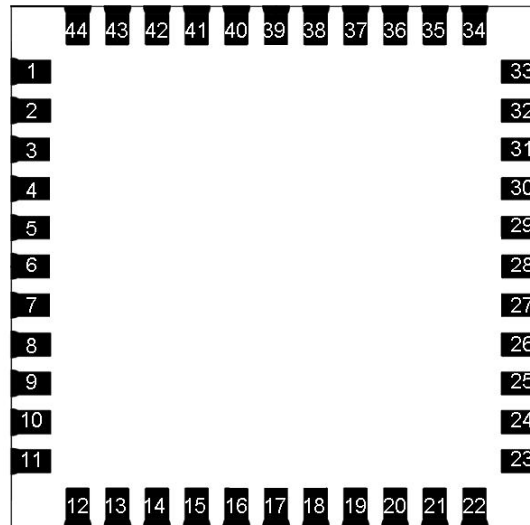


Fig. Outline drawing

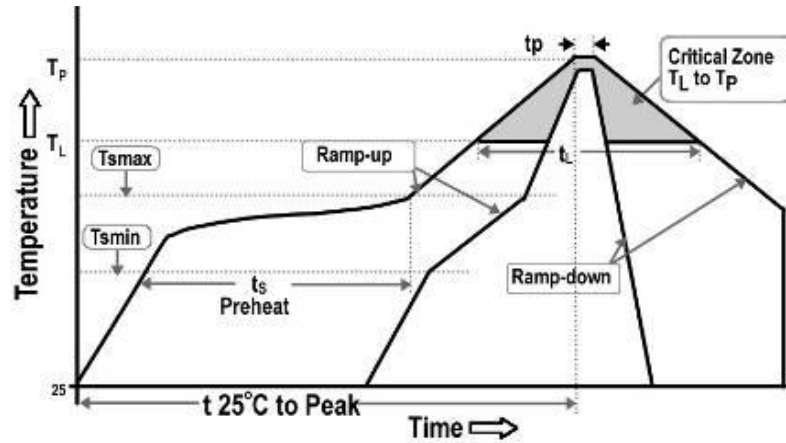
