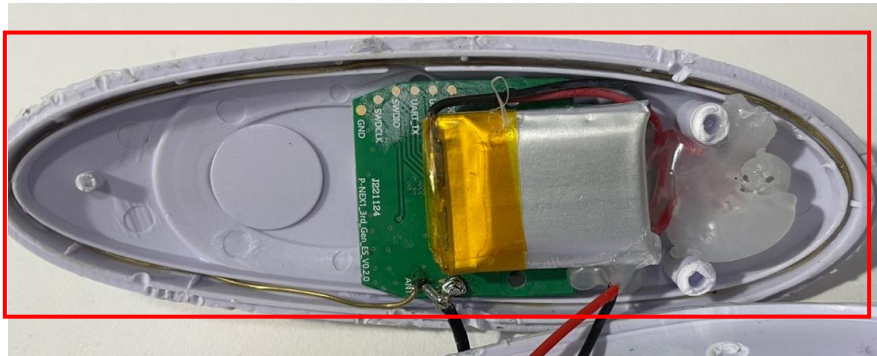

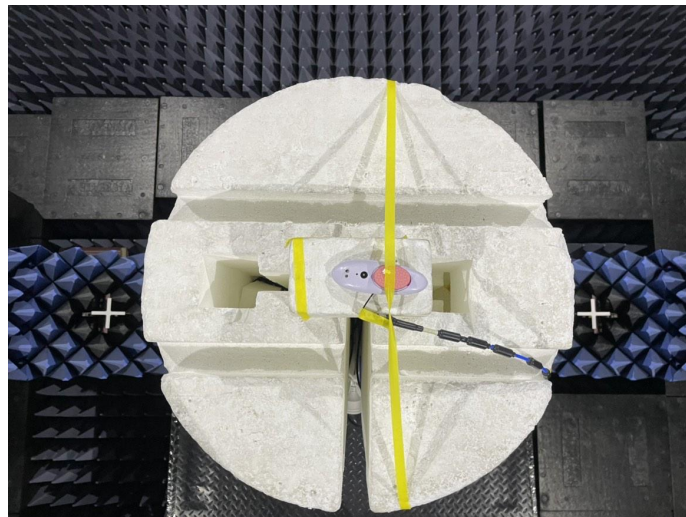

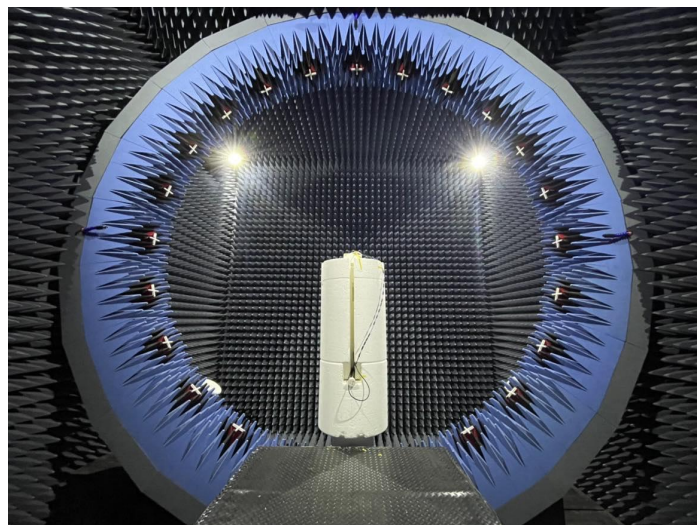

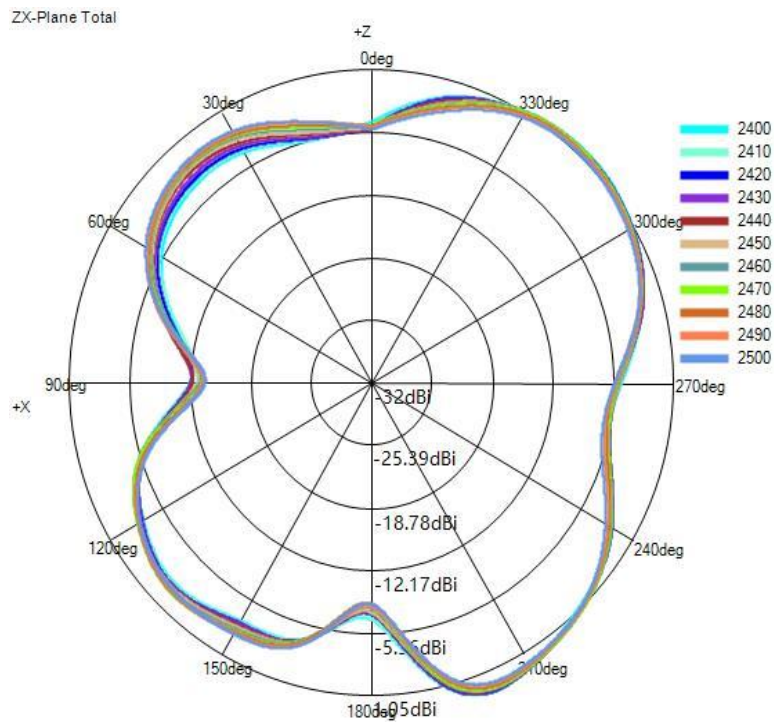

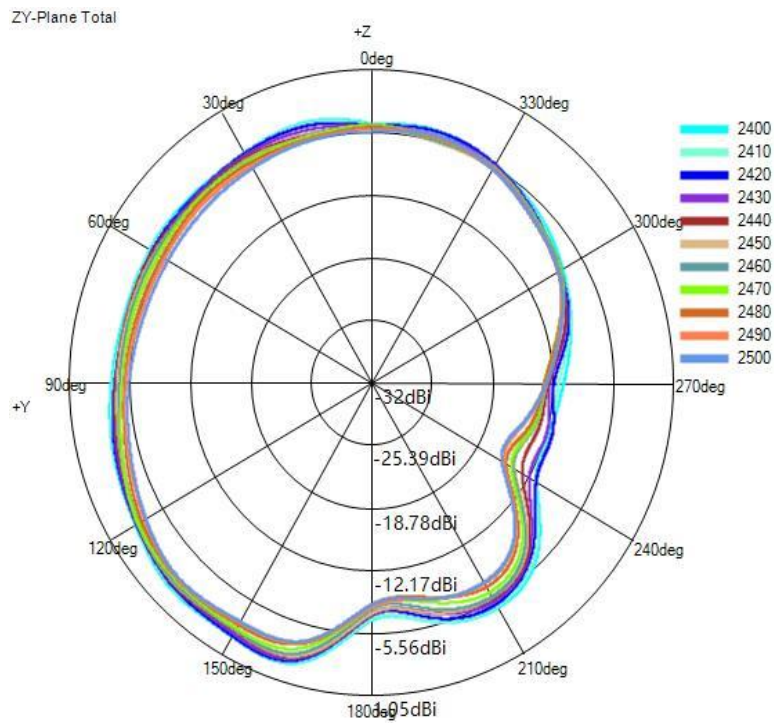

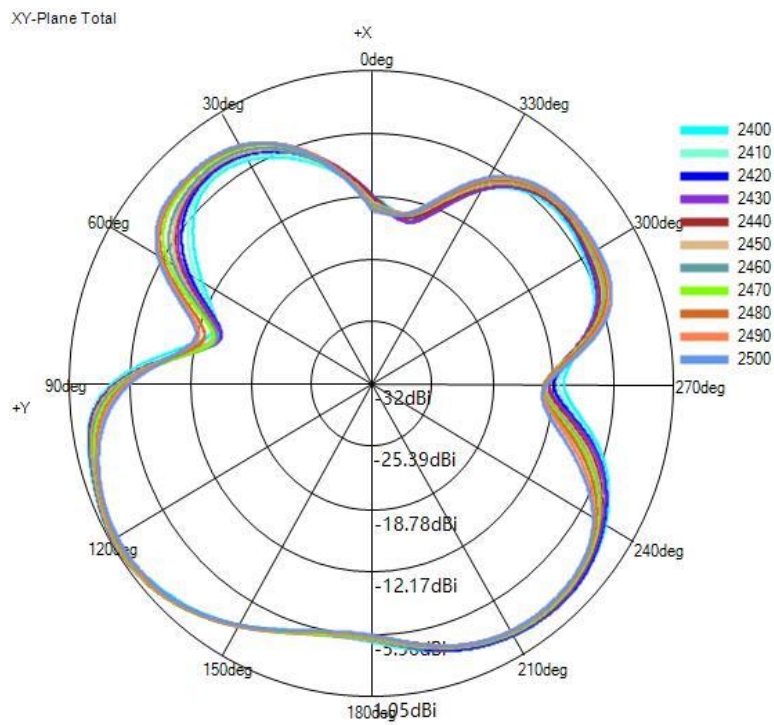
(1) X-Z Plane(unit:dBi):



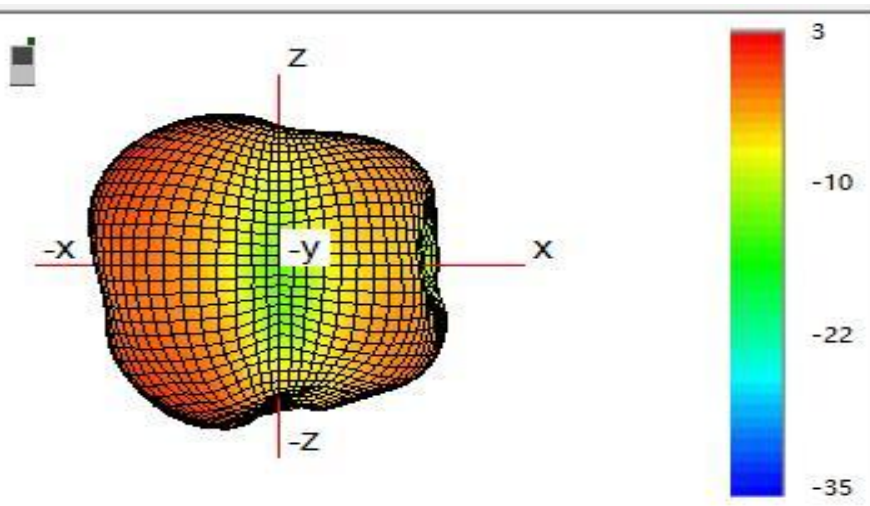
(2) Y-Z Plane(unit:dBi):
