

# Smart Watch Instructions



Please read this user manual carefully before using it

## 01. Packing List



## 02. Know Your Watch

---

Note: If long pressing the power button doesn't power on the watch, please try again after the watch is fully charged.



## 03. Install APP

---

1. Press and hold the power button to turn on the device
2. Use your phone to scan the QR code below or search for "FitCloudPro" to download and install the app.



Note:

1. For better user experience, please follow the instructions and update the app to its latest version in time.
2. The operating system should be at least Android 5.0 or iOS 9.0..

## 04. Bind Mobile Phone

---

1. Open the app on your phone, complete the information settings, and select Always Allow and Agree according to the permission prompt
2. Click to add and bind devices on the APP interface, search for device model and click connect. After the APP interface displays "Connected", the phone will pop up a pop-up window saying "Do you accept Bluetooth pairing request". Click "Pair" to call Bluetooth
3. After the Bluetooth connection and binding of the APP are successful, the watch time is displayed correctly, and the APP interface will show that the device model is connected. At the same time, the middle link symbol on the device's dropdown interface is blue, indicating successful connection. If the connection symbol color is red, it indicates unsuccessful connection. Please restart the operation.
4. After the Bluetooth connection is successful, pull down the phone icon in the bottom left corner of the interface, click to enter, open the call audio to make a call. If you need to play music or play it out, you need to turn on the media audio switch below. If you need to turn off the above functions, you can make a call.

The relevant functions are set according to the requirements.

## 05. Charge Your Watch

---

Align the magnetic charging cable with the charging port until the charging indicator appears on the watch screen. When the watch indicates low battery, please charge it in a timely manner. This device is an all-in-one machine, and the back case and battery cannot be removed



Note:

1. Please use the charger provided in the package for charging and wipe the charging port dry beforehand.
2. To charge, connect the USB port to the phone charger or a >1A computer USB port.

## 06.Precautions

---

1. Please don't use adapters with a charging power >5V and a charging current >2A. Charging time is about 120 minutes.
2. Please don't charge the watch if there are water stains.
3. The product is specifically designed for electronic monitoring scenarios; use the data as a reference only, and not as a medical reference.
4. Heart rate testing method: Please keep your body relaxed and still during the test, and please do not speak during the test;.
5. The photoelectric sensor is a highly sensitive component, so please be careful in case it is broken due to impacts with hard objects. After wearing the watch for a prolonged period of time, sweat stains and dust may stick on the surface; please clean it regularly using a soft cloth.
6. If the watch is worn while showering, swimming or sweat-inducing exercises, please clean the device in time and wipe it dry.
7. Please avoid wearing the device in sauna rooms or steam rooms to prevent the water-resistance from being compromised. Please refrain from using it in scenarios with high-speed water flows, such as diving and water skiing.
8. When the watch crashes and restarts, please check and clear the memory information of the mobile phone and try again, or quit the APP and reopen it.
