The antenna is a PCB antenna which permanently attached, and the best case gain of the antenna is 2.34dBi. It complies with the standard requirement.



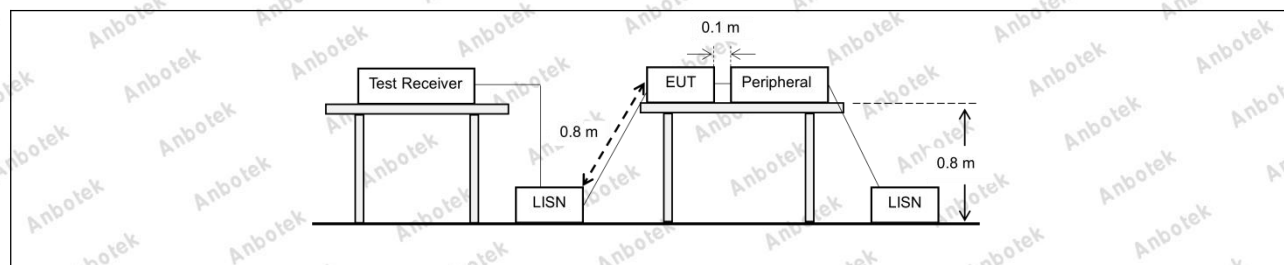
