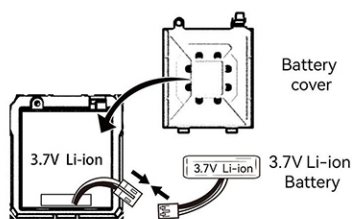

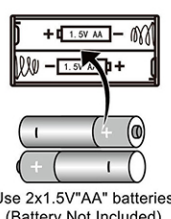


#### REMOTE CONTROL VEHICLE BATTERY INSTALLATION
