User Manual

Download and install the app

Method 1: Scan the QR code to quickly download and install it

Register login account

New users need to register an account, click on "Register Account" to enter the registration process

Select your country, enter your account name (phone number or email), and follow the prompts to register with a verification code

Existing accounts can be logged in by directly entering the account name and password

Add Camera

register

The camera is powered on, and during the startup process, the pan head will rotate for self inspection. After the startup is completed, there will be a prompt sound. (If there is no prompt sound, reset and redo the operation)

Click "Add Device" or click "+" in the upper right corner to enter the interface for selecting the method of adding devices

The selection of adding methods based on device type is mainly divided into "WiFi connection" and "hotspot connection"

Cloud storage is an online storage method to prevent the storage card and camera from being stolen and damaged, and cloud storage and TF card can simultaneously backup the recording of important video recordings (It is recommended to open cloud storage)

Click the icon to enter the cloud storage purchase interface, click the video interface, select the package type, which is mainly divided into 7 day and 30 day cycle video recording, then select the annual or monthly package, read the service terms, agree, continue and pay

Frequently Asked Questions

Q: Camera not compatible with network or offline status

1. Check if the power supply and home network broadband are normal
2. Restart the device and listen to the prompt tone for judgment
3. Press and hold the reset button for 6 seconds to reconfigure the network
4. WiFi passwords should not contain Chinese or complex symbols, and should be combined with letters and numbers as much as possible

Q: How the camera stores videos can be separately opened with cloud storage service, and the cycle recording can be automatically overwritten according to the number of days of cloud storage package
