

BEFORE FIRST USE

1. To install batteries, remove the retention screw from the compartment on the bottom of the remote and open the battery cover.
2. Install 2 (two) x AAA 1.5V alkaline batteries, following the diagram to ensure each battery is installed correctly. Put the battery cover back on the compartment and tighten the retention screw.



If you choose the IC Set, the tube lights will be in 3-color flashing mode. Then you can press the up and down keys to adjust the amount of LED.


Please note in this light setting, the tube light can only reduce the amount of lamp bead by half. After use the IC Set, please do not forget to press the ON/OFF button to confirm and implement the setting mode.

Scan the QR code

iOS and Android systems can download the " LotusLamp X " APP by scanning the QR code. Open the browser or other tools with "Scan QR code" function, scan the " LotusLamp X " QR code as below:



1. Click "Allow" to enable your Bluetooth. Switch to color and brightness interface.
2. Dimming Color Function: Adjust the brightness, color and color temperature of the light according to your preferences and needs. You can find the most suitable lighting effect for every occasion.

3. Music rhythm interface: The APP will read the local song of the phone, and the light will beat according to the music rhythm.


1: Turn on the microphone mode of the phone, the phone will recognize the surrounding sound, and the light will follow the sound. The size of the volume for rhythm, can choose different rhythm mode.

2: Turn on the microphone mode, and the speaker module of the smart string recognizes the sounds around it and beats them according to the volume. Note: The following dialog box will appear when you use the APP for the first time. Please check "Allow" and continue operation.

4. Dynamic Mode : Using excellent dimming algorithm technology, you can easily achieve the change effect of light gradient, jump and flicker.

5. Multiple scene selection: Support one click to set a variety of scene modes, such as reading, relaxing, dining or night mode, quickly draw up the ideal atmosphere.




