Who is Vuse Pro for?

1. Vuse Pro is for adult tobacco consumers of legal age. Underage sale prohibited.



What should I be careful of when using Vuse pods?

1. Keep pods out of reach of children and pets due to risk of nicotine poisoning and choking.
2. Do not use pods if they show signs of damage or tampering.
3. Do not tamper with or open pods.
4. Do not drink the Vuse pod liquid. If ingested, seek prompt medical attention.
5. Avoid pod liquid contact with eyes, skin, or clothing. In case of contact, rinse affected areas immediately and seek prompt medical advice.
6. Take care when using pods as they may leak.

What should I be careful of when storing or using the Vuse Pro device?

1. Keep out of reach of children and pets, even when locked.
2. Only for use with Vuse pods and Vuse Pro charging cables and accessories.
3. Do not use the Vuse Pro device or its charging cable if they show signs of damage or tampering.
4. Do not use the Vuse Pro device if it is wet, damaged, malfunctioning, or feels unusually warm. If this occurs, please contact the Customer Care Team at 1-877-614-VUSE.
5. Electromagnetic fields emitted by the Vuse Pro device and the paired Vuse Pro app may interfere with pacemakers, defibrillators, hearing aids, and/or other medical devices if used within a close distance. Consult your physician and medical device manufacturer for information specific to your medical device.

Vuse Pro contains a non-replaceable rechargeable lithium-ion battery.

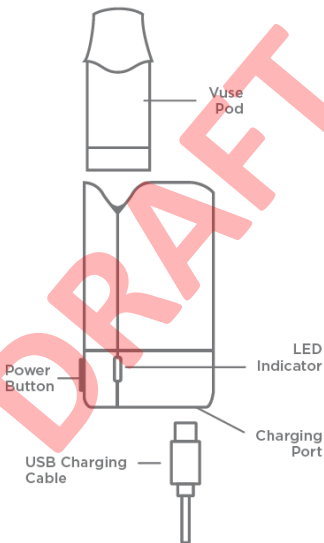
1. Do not store the Vuse Pro device in direct sunlight or in a hot vehicle. Do not expose the Vuse Pro device to heat or fire.
2. Do not attempt to replace the battery in the Vuse Pro device.
3. Do not attempt to repair the Vuse Pro device or its charging cable.
4. Intended Storing/Operating Temperature:
14°F to 113°F
5. Intended Charging Temperature:
32°F to 113°F



What should I be careful of when charging the Vuse Pro device?

1. Do not leave the Vuse Pro device unattended while it is charging.
2. Follow the safety information for the charging plug (AC/DC adapter) that you are using with the Vuse Pro charging cable.

Activating Your Vuse Pro

Vuse Pro requires age verification and device activation via Bluetooth® before use.

This is intended to help prevent underage usage.

FOLLOW THESE STEPS:

1. Scan the QR code.



2. Download the Vuse Pro App.
3. The Vuse Pro App will guide you through the remaining steps to verify your age and pair your device.
4. Enjoy using Vuse Pro.

Quick Start

After successful **age verification** and **device activation**, unlock your Vuse Pro using the Vuse Pro app, insert a pod and begin vaping.



- 1 Insert your pod into your Vuse Pro device.



- 2 Simply puff to start your vaping experience.

Tip: Fully charge your Vuse Pro before first use.

Locking/Unlocking Your Vuse Pro

You can lock and unlock your device using the Vuse Pro app.

The following light colors will show for 1.5 seconds to tell you whether the device is locked or unlocked:



**Solid Red
Locked**



**Solid Green
Unlocked**



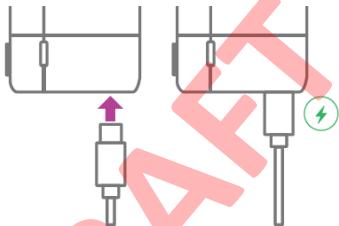
Keep out of reach of children and pets, even when locked.

Turning Your Vuse Pro ON and OFF

To power your device ON and OFF press the button 3 times in 2 seconds. Please note that doing so is different than locking and unlocking. The device will not produce vapor nor show any LED indications while in OFF state.

How to Charge Your Vuse Pro

A full charge should take **50 minutes**.



Your LED indicator will show different battery levels when charging.



Flashing Red
<10%



Solid Red
10% - 80%



Solid Green
>80%

- When the LED disappears, Vuse Pro is fully charged. Disconnect the charging cable.
- Vuse Pro will automatically stop charging after 3 hours.

Charge Level Indicators

Your LED and haptics will indicate battery level during and after puff.

During Puff:



Solid White

After Puff:

The following light colors will show for 2 seconds depending on the battery charge status:



Solid Green
100 - 30%



Solid Amber
Short Buzz @30%
30 - 10%



Solid Red
Short Buzz @10%
<10%

Additional Indications

Your device will flash blue and buzz twice if you puff in a locked state.



Your device will display the following red indicator if any of these occur:

- Device was unable to reach full charge within 3 hours.
- Device has overheated.
- Device was puffed for longer than 5 seconds.
- Issue occurred while charging or vaping.
- If the device is puffed prior to successful Age Verification.



Important Product Information

- Vuse Pro is IPX4 rated, making it splash resistant to water.
 - If water droplets get on Vuse Pro, gently dry it with a piece of cloth.
 - If Vuse Pro becomes fully wet or immersed in water, do not use. If this occurs, please contact the Customer Care Team at 1-877-614-VUSE.
- Be aware of the risk of device terminals being short-circuited by a foreign object. The device has an overvoltage, overcurrent, and a short-circuit protection function.
- When puffed, if a short circuit is detected, the LED will flash red 3 times and the device will cut the power to the pod and the vapor production will stop.

Important Product Information

- Rated input for charging cable: 5VDC, 2.0A.
- This product should only be connected to a safety extra-low voltage (SELV) circuit rated at 5VDC, 1.1A. Using an AC adaptor with a current output lower than this will result in a slower charge time.
- This product is not intended for use by persons with reduced sensory, physical, or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning use of the product by a person responsible for their safety.
- The device has a reset function. To reset the device navigate to "Reset Pro Device to Factory Settings" in the Vuse Pro App.

A security feature that helps prevent underage usage.



Device Lock

The Vuse Pro App gives you options to lock your device so no one but you has access.

1. **Manual Lock:** Allows you to lock and unlock your device with a swipe on the home screen.

2. **Auto-Lock:** Allows you to set a countdown timer that will automatically lock your device. The timer starts once your device goes out of Bluetooth® range.

Find my vape

The Vuse Pro App can be used to ping your Vuse Pro device. If you are within Bluetooth® range and connected to the App, your Vuse Pro device will vibrate and flash white.



Battery Recharge Reminders

Set the battery level you want to be alerted at so your device can always stay charged.
