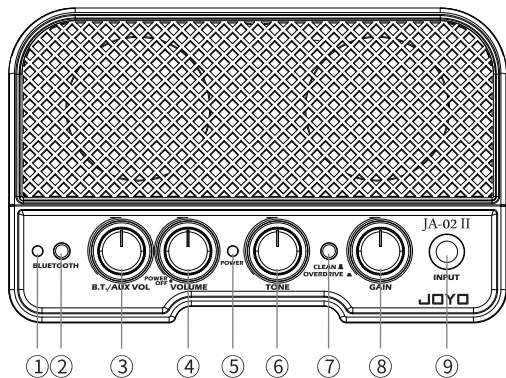

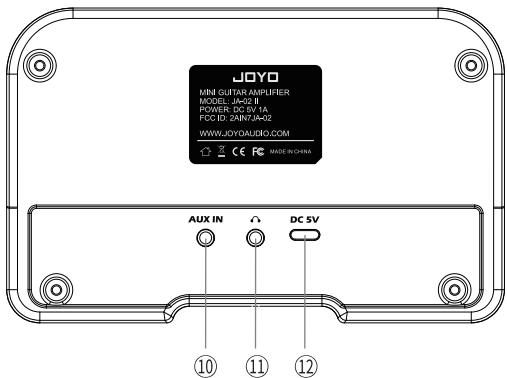
一、注意事项

- 1.切勿擅自拆卸、改装、修理机器, 以免发生短路。
- 2.勿在高温、潮湿、污浊、强烈震动处使用机器。
- 3.勿将机器摔落, 或落在坚硬物体表面, 以免机器操作失常。
- 4.勿用酒精等稀性液体擦拭机器表面, 以免机器受损。
- 5.为节省电源, 机器不使用时, 请将电源关闭。
- 6.如使用中本产品自动关机, 表明电池电量不足, 请及时为本产品充电。
- 7.在使用耳机听音时音量应从小开始调节, 以免太大音量下损坏耳机或损伤耳朵。
- 8.产品应尽量远离可能有铁屑的地方, 以免喇叭吸入铁屑影响音质。

三、使用说明

1. 旋转VOLUME旋钮来打开产品电源, 打开后电源指示灯点亮为红色。
2. 将吉他接入INPUT插孔, 并通过CLEAN / OVERDRIVE开关选择合适的音色, 并使用GAIN, TONE及VOLUME来调整音色细节。
3. JA-02 II内建有蓝牙通信单元(5.0), 您可以使用带有蓝牙功能的设备与JA-02 II进行连接并播放音乐。要使用本功能, 您可以按照下面的方式来操作您的JA-02 II。
 - ① 按下蓝牙开关来打开蓝牙, 此时, 蓝牙灯亮起。
 - ② 打开移动设备的蓝牙功能, 在设备列表中找到“JA-02 II”, 并进行配对。成功配对后, 蓝牙指示灯将保持常亮状态。
 - ③ 您还可以通过AUX IN接口以有线的方式连接外部音源来播放音乐, 并在需要时连接耳机到耳机插孔进行静音演奏或练习。
5. 充电: 本产品内置有锂电池, 您可使用附带的USB Type-C充电线为本产品充电。如果电池电量过低, 本产品将会自动关机, 您需要及时为本产品充电, 长期低电保存会对电池造成不可逆的损伤。注意, 电源指示灯只会在关机时指示充电状态, 正常使用时, 电源指示灯为恒定的红色。在关机充电期间, 电源指示灯为黄色, 电池充满后, 电源指示灯熄灭, 表示电池已经充满。

***注意:**本产品只附带USB Type-C充电线一条, 您可以使用已有的任何5V充电器为本产品充电。如果您不知道如何匹配充电器, 您只使用您的手机充电器即可。请确保充电器的额定输出电流大于等于1A (通常手机充电器都满足这个要求)。

***注意:**由于内置有锂电池, 请勿自行拆卸本产品。

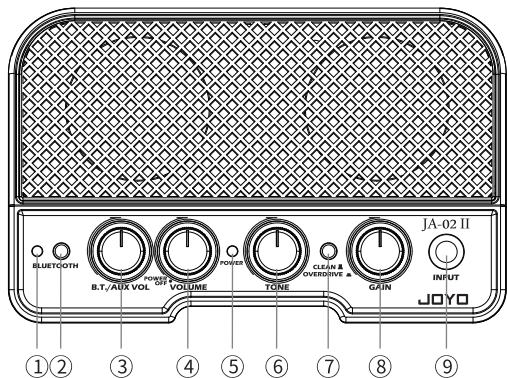

Thank you for purchasing our products, please read it carefully before operating.

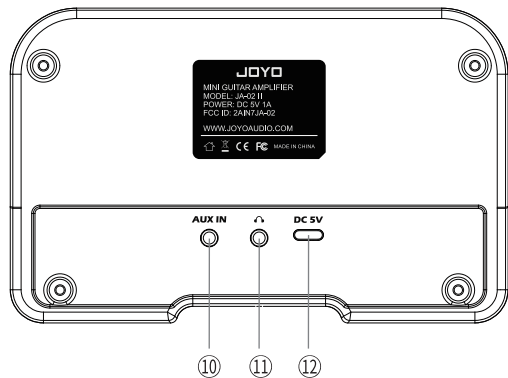
I. Warning

1. Don't disassemble or repair this product by yourself.
2. Don't use or store it near any heat sources, damp and dusty areas. Avoid violent vibration or shock.
3. Don't drop this product otherwise it may malfunction.
4. Don't use alcohol or other cleaning fluids to clean this product.
5. Pls turn off the unit when it's not in use.
6. If the unit shuts down automatically during use, it means the battery runs out, pls charge it in time.
7. Don't turn up the VOLUME too much suddenly while using the headphones, otherwise it may damage the headphones or impair your hearing.
8. Pls keep it away from place that has iron flings, so as to prevent iron flings to be attracted by speaker and thus affect the sound quality.

II. Panel description



- ① Bluetooth Status Indicator
- ② Bluetooth switch
- ③ Bluetooth/AUX Volume Knob
- ④ Guitar Volume/Power switch
- ⑤ Power Indicator
- ⑥ Guitar Tone Control Knob



- ⑦ Guitar sound selection switch (CLEAN/OVERDRIVE)
- ⑧ Guitar Gain Control Knob
- ⑨ Guitar Input Jack
- ⑩ AUX IN Jack
- ⑪ Headphone Output Jack
- ⑫ USB Type-C Charging port

III. How to use JA-02 II?

1. Turn on the unit by turning up the VOLUME knob a little, the power indicator is in red once it's turned on.
2. Connect your guitar to INPUT Jack and select a suitable sound by the CLEAN/OVERDRIVE switch, and you can also adjust the nuance by the GAIN, TONE and VOLUME knobs.
3. JA-02 II features built-in Bluetooth communication units (Bluetooth version:5.0), you can connect it to devices with Bluetooth function to play music. For details, pls operate according to the following procedures.
 - ① Press Bluetooth switch and turn on Bluetooth, now the Bluetooth indicator is on;
 - ② Turn on portable device's Bluetooth function, find JA-02 II in the device list, and start to pair up. When they're paired up successfully, the Bluetooth indicator is in blue.
4. You can also play music by connecting to external audio source via the AUX IN Jack, and connect the headphones to Headphone Jack to practice quietly if you want.
5. How to charge the unit?
JA-02 II has built-in lithium battery, you can charge it with the attached USB Type-C charger cable. If its battery is quite low, JA-02 II will shut down automatically. Remember to charge it in time, low battery for a long time will cause irreversible loss to the battery capacity. Pls note that the power indicator only indicates the charging status when it's been turned off, the power indicator is on and in red during normal use. The power indicator is in yellow when it's been turned off and charging, the power indicator goes out once it's fully charged.

***Note:** JA-02 II has only one USB Type-C charger cable in the package contents, you can use any 5V battery charger. If you're not sure which one is correct, just use your smart phone charger to charge it. Pls make sure the charger's Rated Output Current \geq 1A. (Nearly all smart phone chargers meet this requirement.)

***Note:** As it has built-in lithium battery, don't dismantle JA-02 II.
