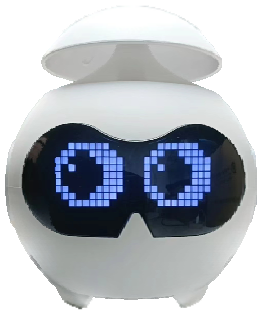
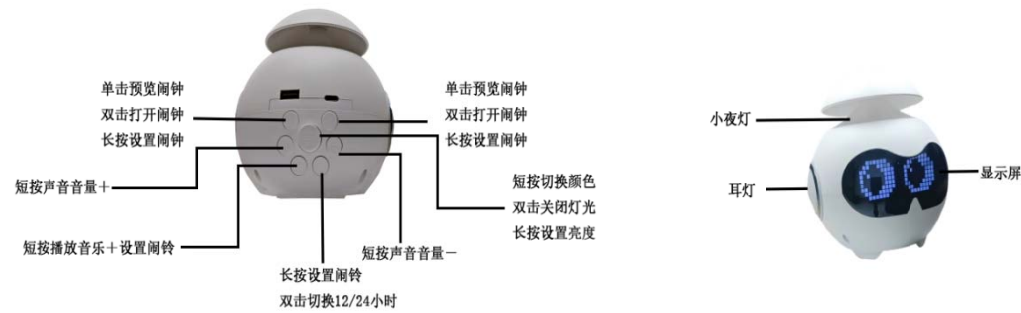

 插入5V电源打开闹钟时 屏幕跳出转眼珠眨眼睛表情	 音量调节图标	 闹铃图标显示	 时间显示
 在显示时间时, 拍一拍它或者震动触发产品可随机切换跳出各种不同的表情后自动转到时钟显示, 间隔五秒后, 再拍一拍或震动可重复上述显示。

使用说明

1、供电模式

产品可通过 5V-2A USB 线连接适配器或者电脑供电, 插上电源时产品进入正常工作状态, 显示屏显示眨眼表情。

2、时间设置

设置顺序: 时 -> 分 -> 退出;

长按 “” 按键, 等待显示屏幕 时 位显示闪烁, 按 “” 或 “” 对 时 位进行调节设置, 再次单击 “” 按键切换到 分 位显示闪烁, 按 “” 或 “” 对 分 位进行调节设置, 设置, 再次单击 “” 按键, 退出时钟调节设置功能, 时 位和 分 位不闪烁, 且观察屏幕上显示的时间为新设置的时间, 即设置成功。
(如若设置途中错误操作导致设置失败, 需重新按照上述方式重新进行一次调节)

3、12/24 小时制显示切换

双击 “” 按键对时间进行切换，AM 表示上午时间，PM 表示下午。

4、闹钟设置

设置顺序：时 -> 分 -> 退出；

长按 “” 按键，等待显示屏幕 时 位显示闪烁，按 “” 或 “” 对 时 位进行调节设置，再次单击 “” 按键切换到 分 位显示闪烁，按 “” 或 “” 对 分 位进行调节设置，设置，再次单击 “” 按键，退出时钟调节设置功能，时 位和 分 位不闪烁，且观察屏幕上显示的时间为新设置的时间，即设置成功。 注：闹钟 2 的设置方法同闹钟 1。
(如若设置途中错误操作导致设置失败，需重新按照上述方式重新进行一次调节)

5、查看闹钟，开启/关闭闹钟

单击 “” 按键，查看所设置的闹钟 1 时间信息，双击打开/关闭闹钟 1。
(显示屏幕闹钟 1 图标亮起即闹钟 1 定时已开启，熄灭则为闹钟 1 定时已关闭，闹钟 2 同理)

6、铃声设置

单击 “” 按键，循环切换播放 4 首闹钟铃声，期间单击 “” 或 “” 按键可对音量调节。

7、LED 调节

单击 “” 按键，调节切换灯光的颜色，双击打开/关闭 LED 灯光；当 LED 灯光处于关闭状态时，双击 “” 按键，可直接进入声控模式，此时灯光会根据音乐的频率进行律动闪烁。

8、蓝牙音乐

本产品作蓝牙小音响使用，打开手机蓝牙功能搜索蓝牙名称“TS-002”的设备进行配对即可播放手机里的音乐，播放音乐时，灯光会随着音乐节奏律动同时七彩灯光挑变。

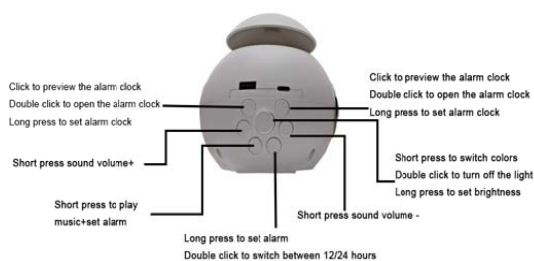

Instructions for use

1.Power supply mode

The product can be connected to an adapter or powered by a 5V-2A USB cable. When the power is plugged in, the product enters a normal working state and the display screen displays a blinking expression.

2.time setting

Setting sequence: hour ->minute ->exit;

Long press and hold the "" button, wait for the time display on the display screen to flash, press"

 "or " "Adjust and set the time slot, click the " " button again to switch to the flashing display

of the split position,Press " " or " " to adjust and set the quantile,Click the " " button again to exit the clock adjustment setting function. The time and minute positions do not flash, and observe that the time displayed on the screen is the newly set time, indicating successful setting.

(If the setting fails due to incorrect operation during the process, it needs to be adjusted again according to the above method)

3.12/24 hour display switching

Double click the " " button to switch time, where AM represents morning time and PM represents afternoon.

4.Alarm settings

Setting sequence: hour ->minute ->exit;

Long press and hold the " " button, wait for the display screen to display flashing time, press " " or " " to adjust and set the time, click the " " button again to switch to flashing quantile display, press " " or " " to adjust and set the quantile, and click the " " button again to exit the clock adjustment setting function. The time and quantile do not flash, And observe that the time displayed on the screen is the newly set time, indicating successful setting. Note: **The setting method for Alarm 2 is the same as Alarm 1.**

(If the setting fails due to incorrect operation during the process, it needs to be adjusted again according to the above method)

5.View alarm clock, turn it on/off

Click the " " button to view the set alarm 1 time information, and double-click to turn alarm 1 on/off.

6.Ringing tone settings

Click the " " button to cycle through the playback of 4 alarm tones. During this time, click the " " or " " buttons to adjust the volume.

7.LED adjustment

Click the " " button, adjust the color of the switching light, and double-click to turn on/off the LED light; When the LED light is turned off, double-click the " " button to directly enter voice control mode. At this time, the light will flicker rhythmically according to the frequency of the music.

8.Bluetooth Music

This product is used as a Bluetooth mini speaker. By turning on the Bluetooth function of the phone, search for devices with the Bluetooth name "TS-002" and pair them to play music on the phone. When playing music, the lights will move according to the rhythm of the music and the colorful lights will change.
