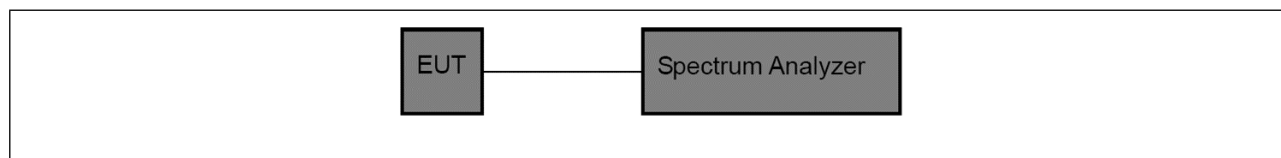
3. Duty Cycle
