Where:

 $Pd = power density in mW/cm^2$,

Pout = output power to antenna in mW;

G = gain of antenna in linear scale,

 $\pi = 3.14;$

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm2. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

EIRP=EMeas+20log(dmeas)-104.7

EIRP is the equivalent isotropically radiated power,

Emeas in dBmis the field strength of the emission at the measurement distance, in dB u V/m

dmeas is the measurement distance, in m
