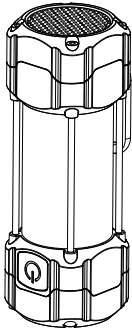

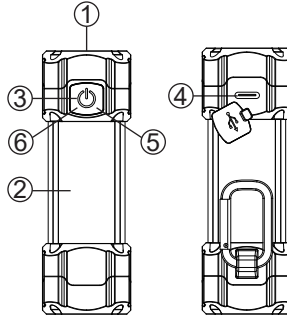

### Operation Instructions

1. Power On: Long press the power button to turn on the speaker, you will hear a tone.
2. Pairing: Once speaker is turned on, open your mobile device, search the wireless devices, and select wireless ID '20113', it will pair automatically. The Bluetooth LED indicator will blink in pairing and illuminate a solid blue after paired successfully.
3. Flashlight/LED lamp: Tap the function button cyclically to Flashlight Level 1- Flashlight Level 2- Flashlight blink- LED lamp ON- LED lamp SOS- turn off.
4. Charging: Use the Type-C cable included to connect the speaker to a certified computer or adaptor, the LED indicator will flash. When the speaker is fully charged, the LED indicator will illuminate a solid red.
5. Power Off: Long press the power button to turn off the speaker.
