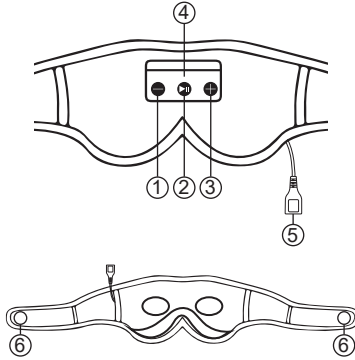

Operation Instructions

1. **Power On:** Long press the power button to turn on the Mask, you will hear a tone. The LED indicate will flash red and blue.
2. **Pairing:** Once Mask is turned on, open your mobile device, search the wireless devices, and select wireless ID '25341', It will pair automatically.
3. **Play/Pause/ Answer/End/Redial call:** Short press the button to play or pause the music. When phone call is incoming, short press the button to answer the call, short press again to end call, double press the button to redial the number you last called.
4. **Next track/Vol+:** Short press to next track, long press to increase volume.
5. **Previous track/Vol -:** Short press to last track, long press to decrease volume.
6. **Switch Bluetooth and White noise mode:** Double press the mode button.
7. **Charging:** Use the Type-C cable included to connect the mask to a computer or adaptor,

the LED indicator will illuminate a solid red. When the Mask is fully charged, the LED will illuminate blue.

8. **White noise mode:** Short press the next /previous button to switch different sounds.
9. **Shutdown timer:** Double press timer button cyclically to set 1 and 2 hours continuously play time or turned off, the product will automatically shut down when the time is reached.
10. **Power Off:** Long press the power button to turn off the mask.

Caution:

1. Please enjoy music with an appropriate volume, which will avoid to damage your hearing and sound system.
2. Please avoid exposure, rain, water droplets, avoid prolonged exposure to high temperature, high humidity environment.
3. During use, please make it away from heat, high pressure, and prevent children from playing with this product.
4. Please use the power which meets the requirements.
5. Do not drop or bump and applied heavy pressure to avoid damage to the product.
6. Place finger inside the fabric lining. Slowly and gently remove the headphones &

controller. Be careful not to stretch or pull on the cables, move the ear phone rather than pull the cable.

7. Hand wash cover material using warm water (30° C Max).
8. The whole product is not waterproof. Only the outside sleep mask can be washed. The headphones need to be removed before cleaning.
