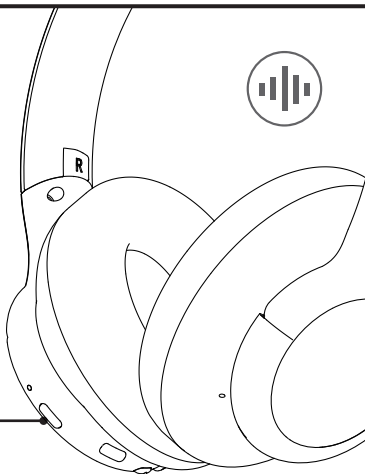

NOISE CANCELLING

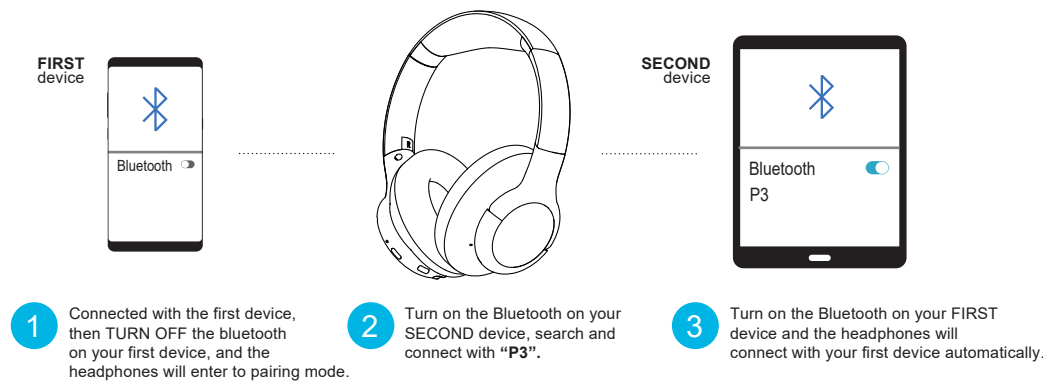
- ANC ON**

- Press once to cycle 3 Noise Control Modes

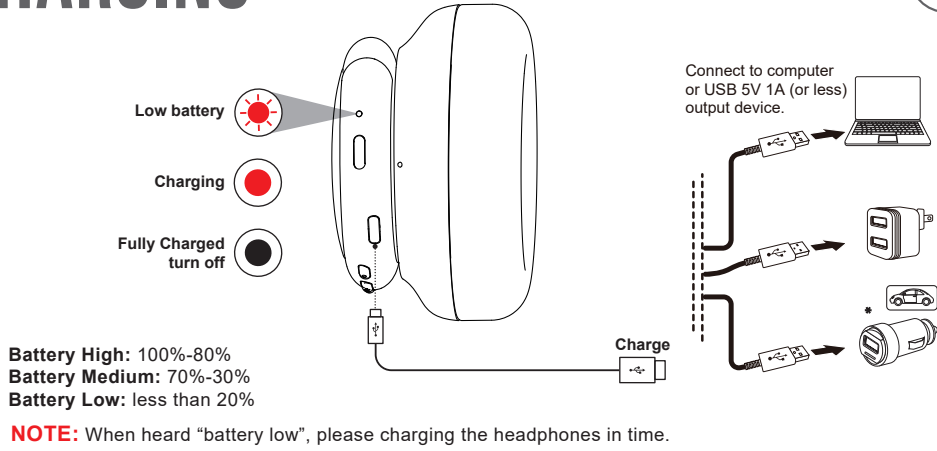

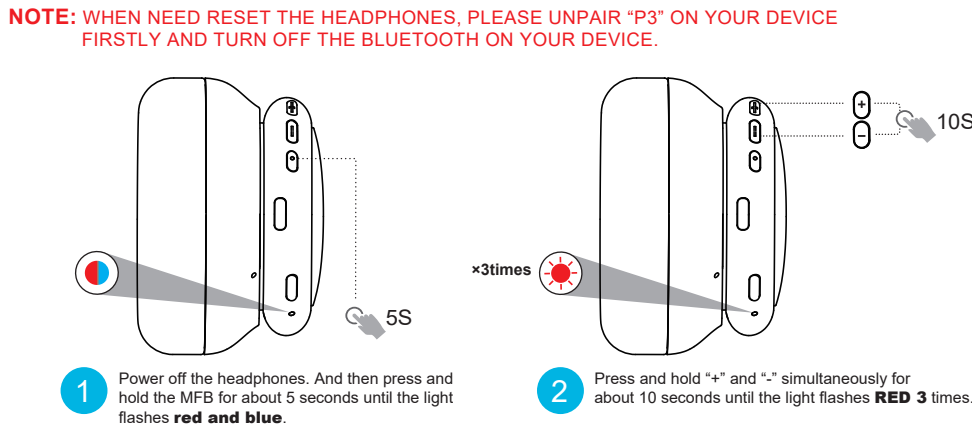
