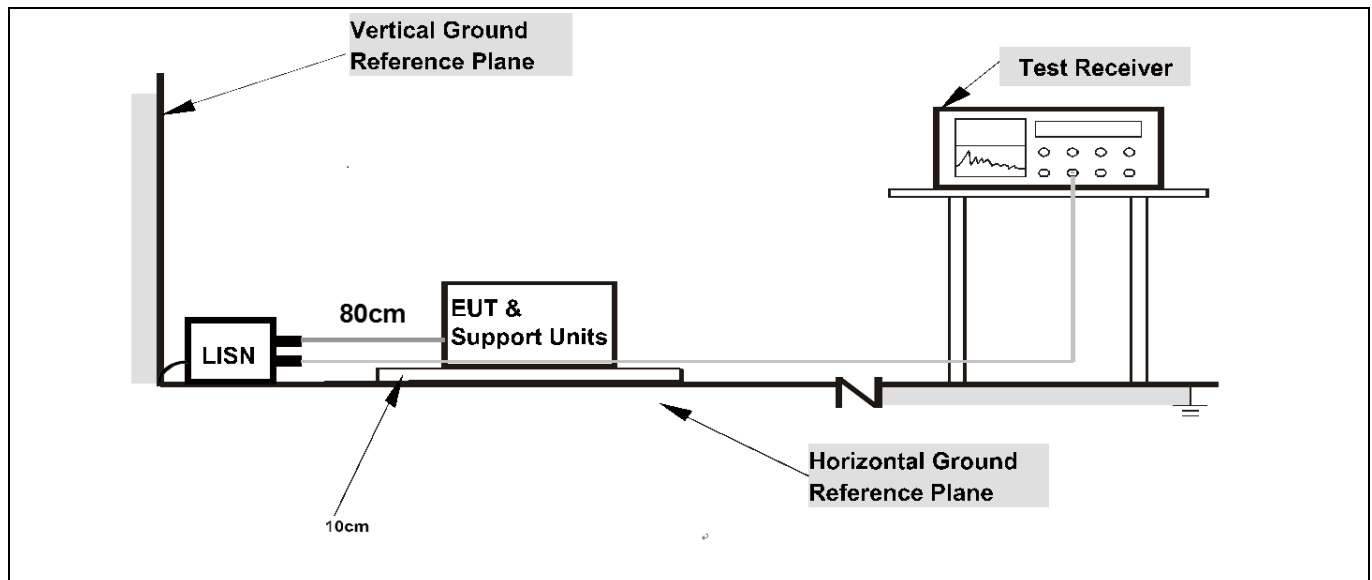

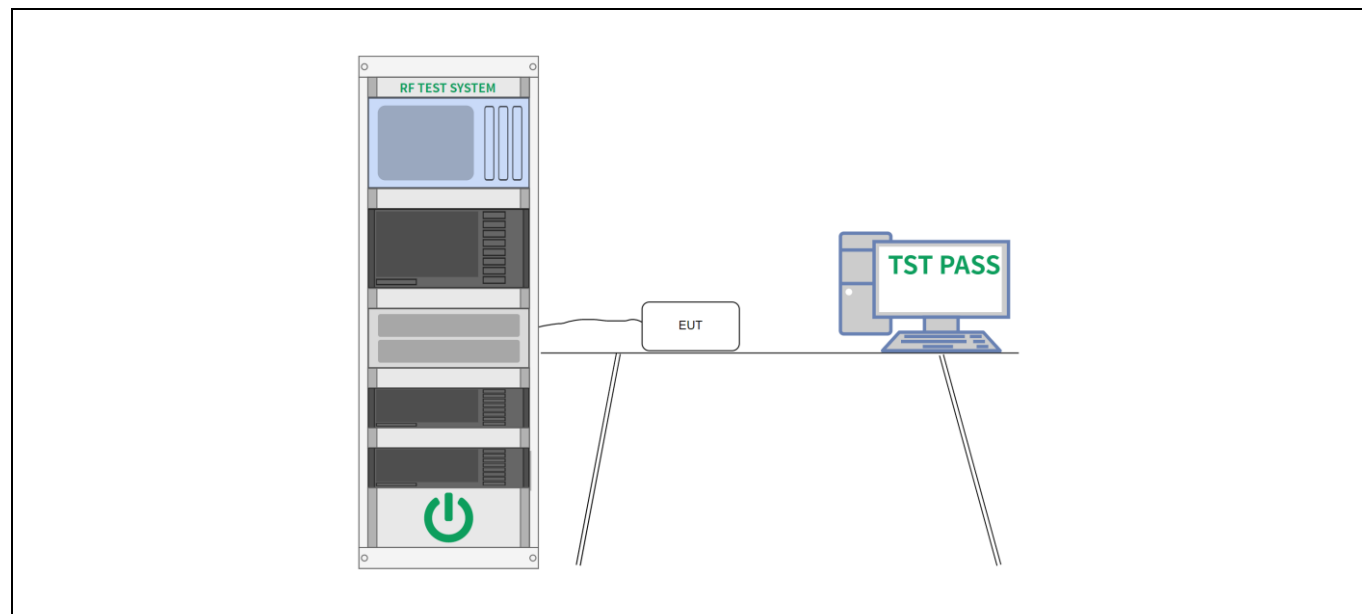

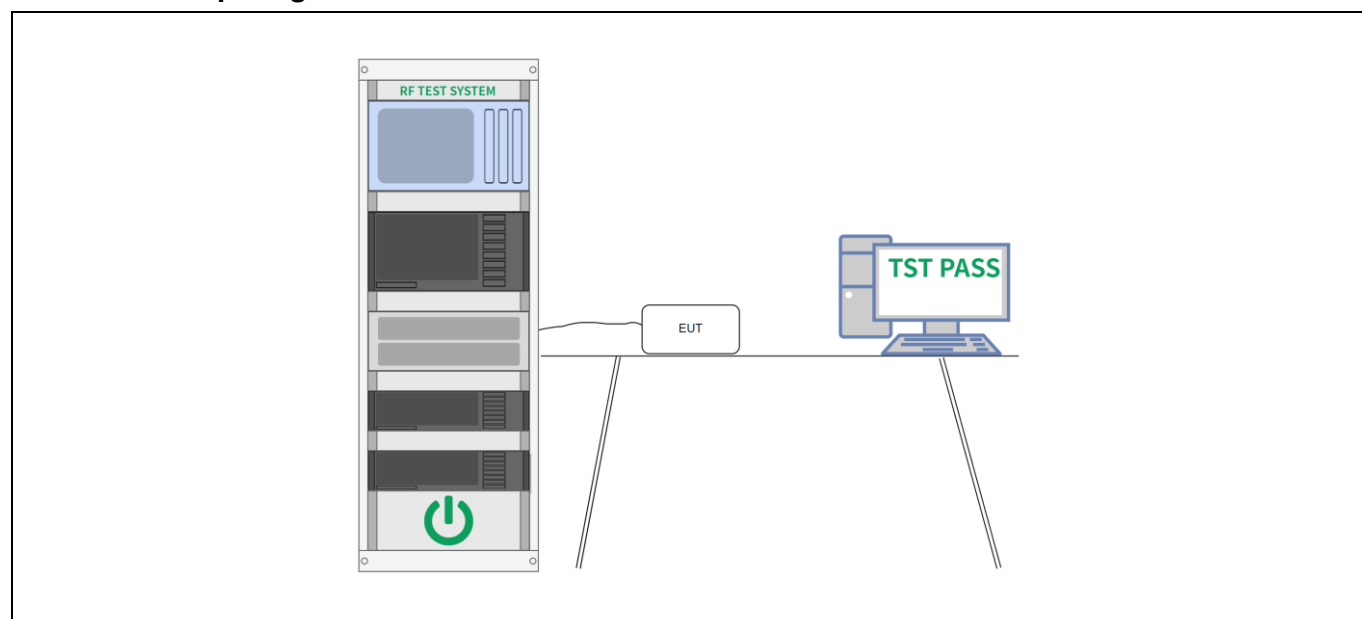
6.3 Maximum Conducted Output Power

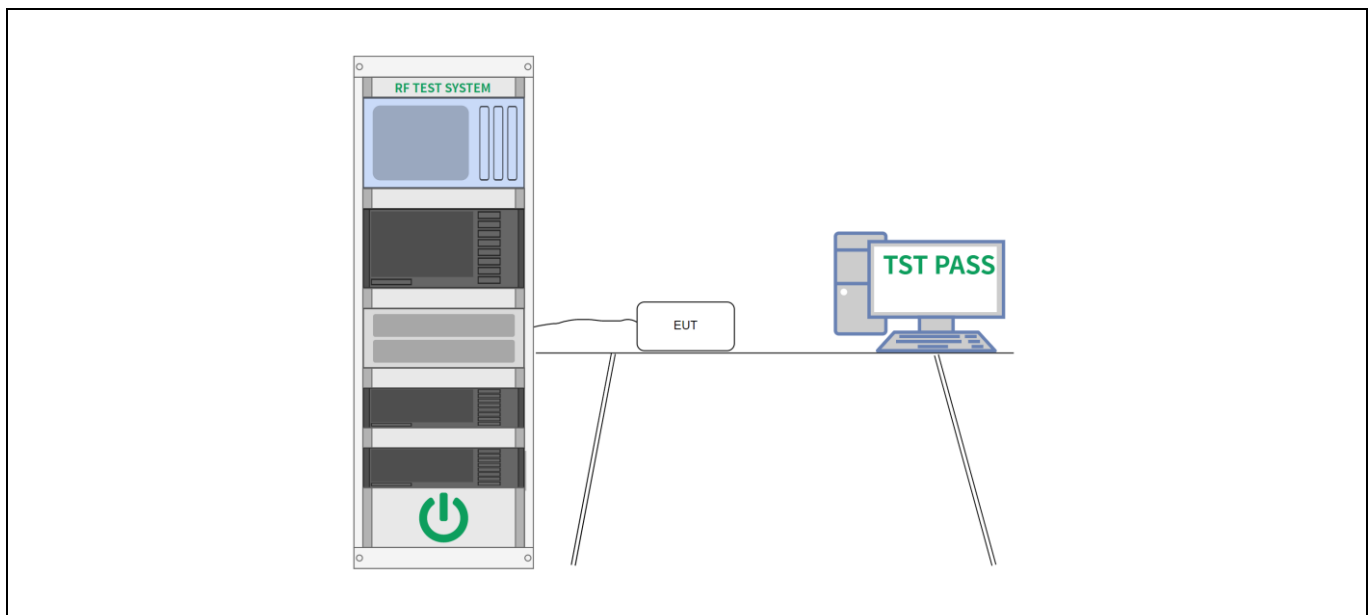

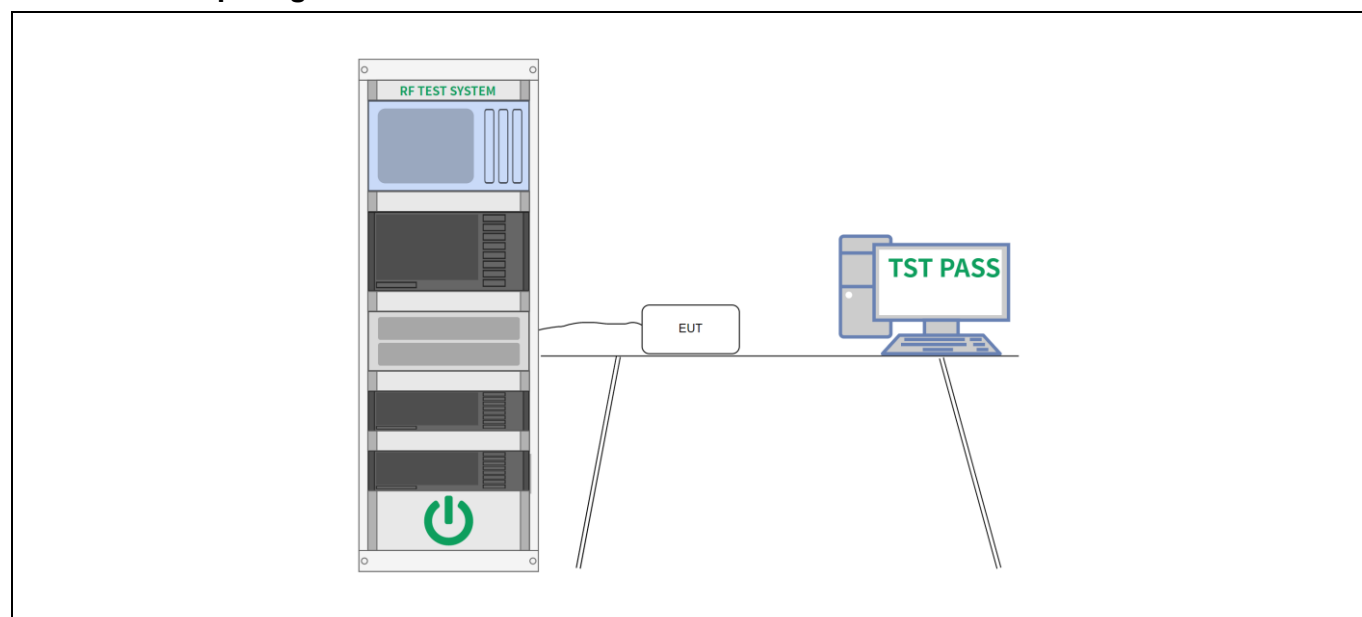
6.5 RF conducted spurious emissions and band edge measurement

Test Requirement:	47 CFR 15.247(d)

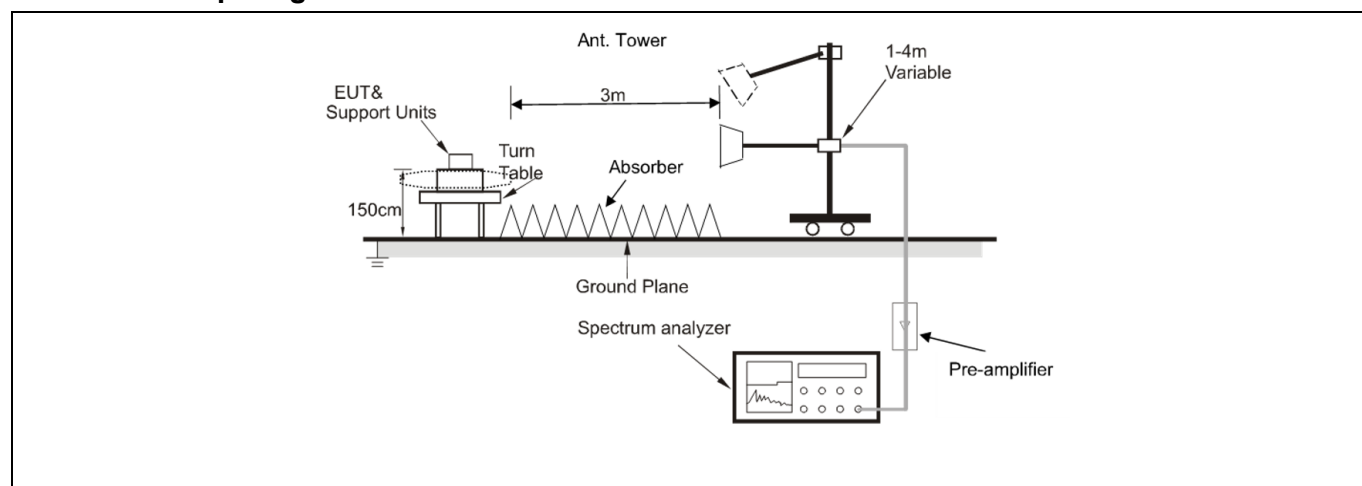

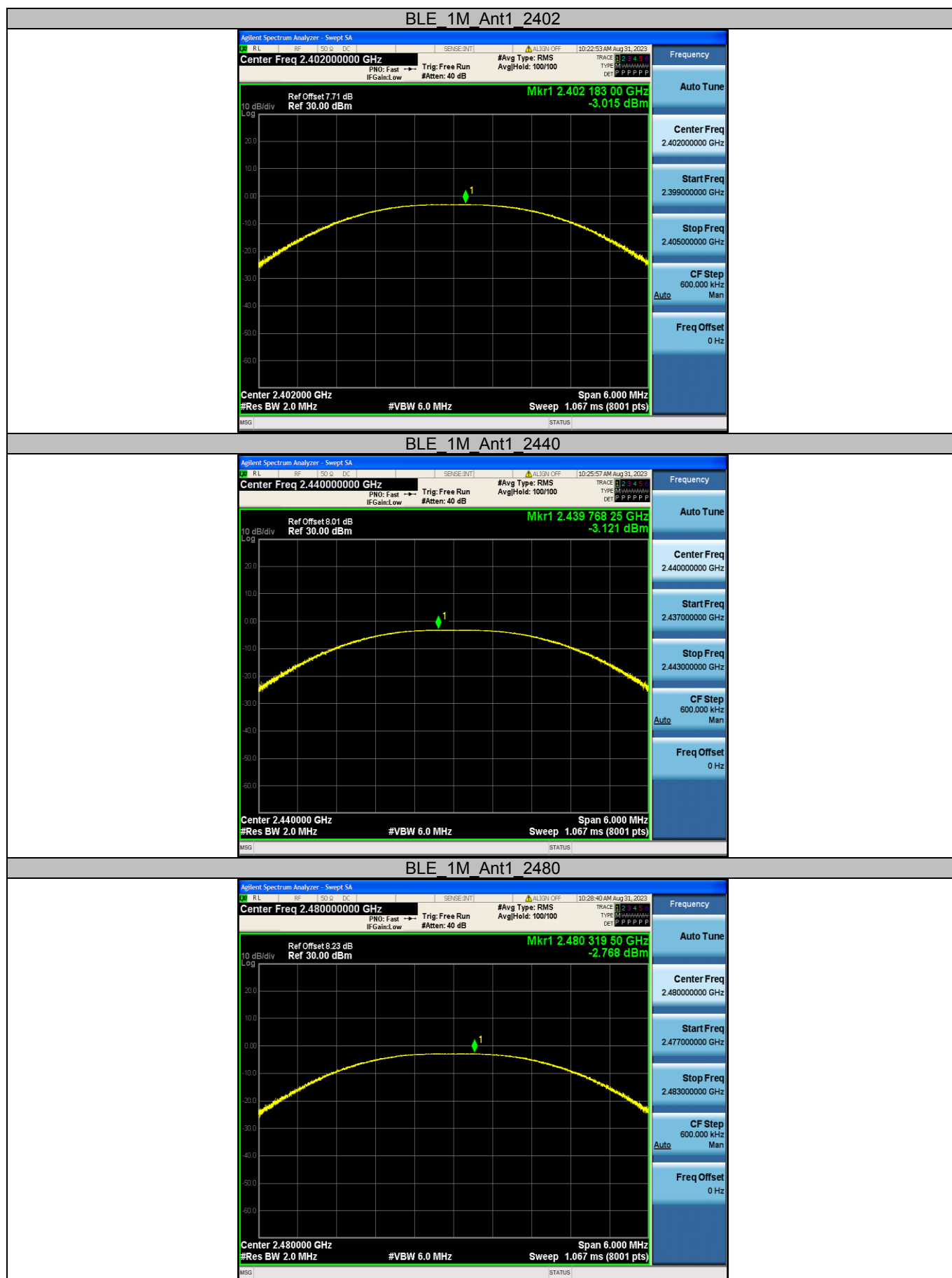

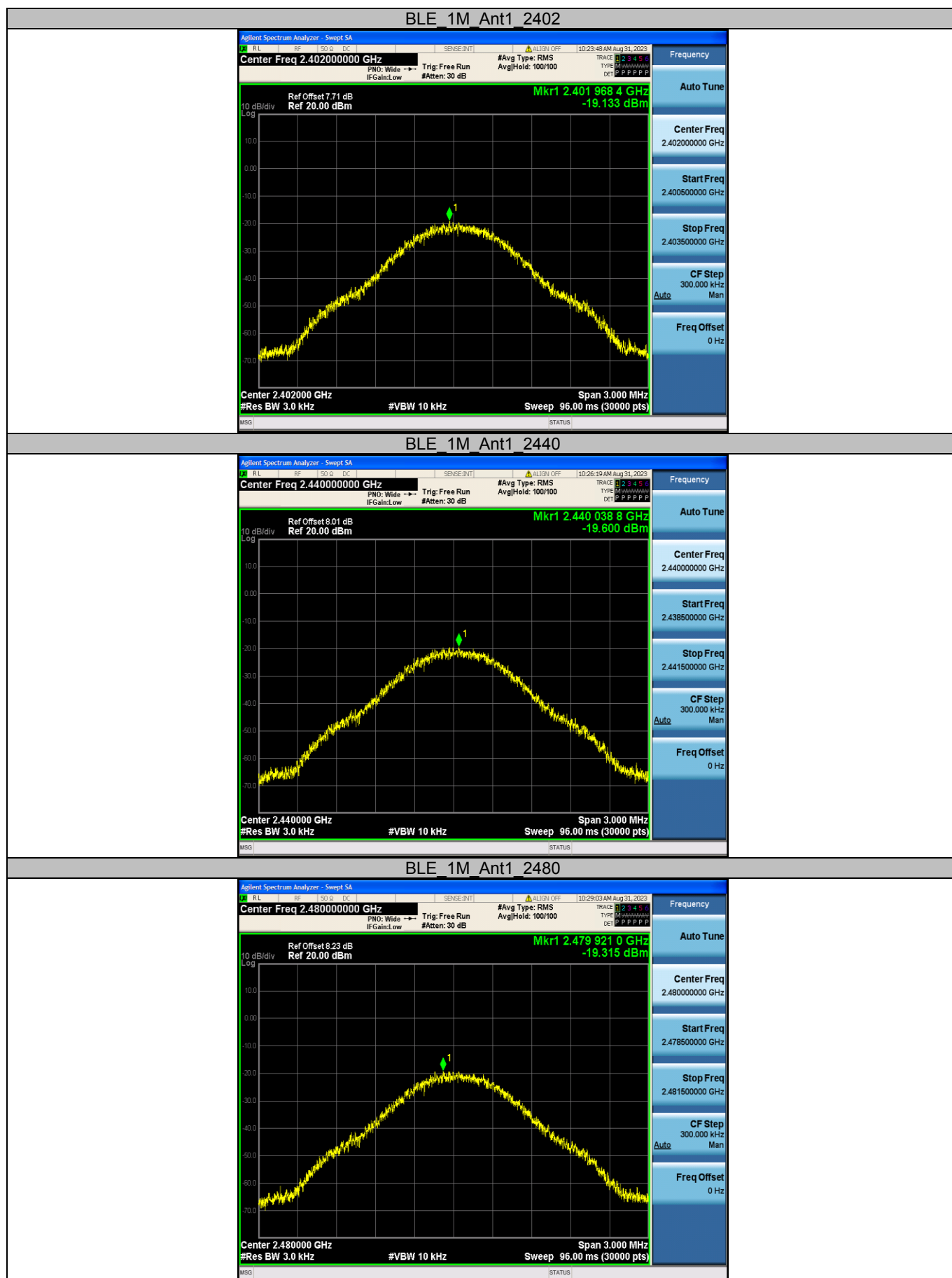

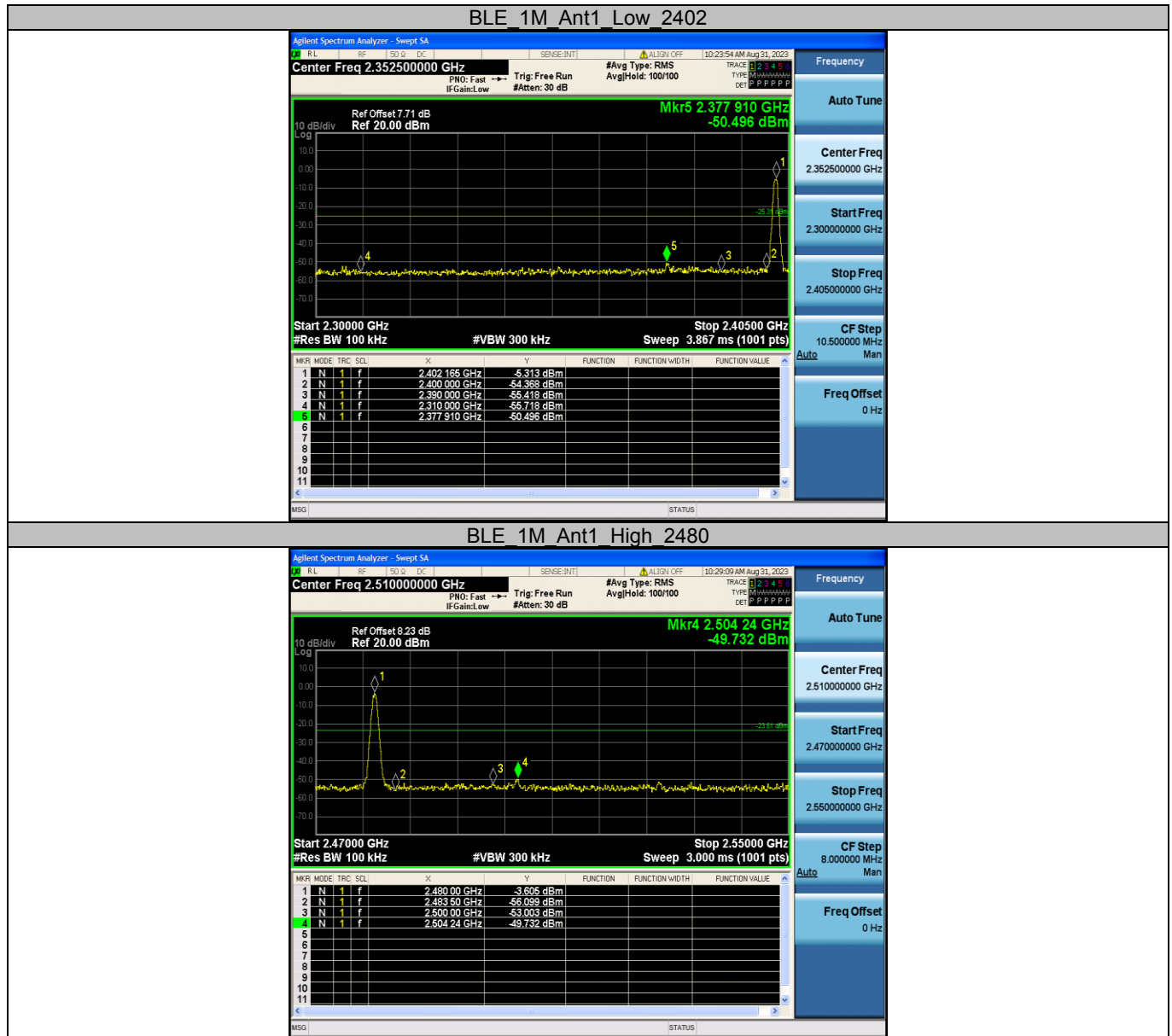

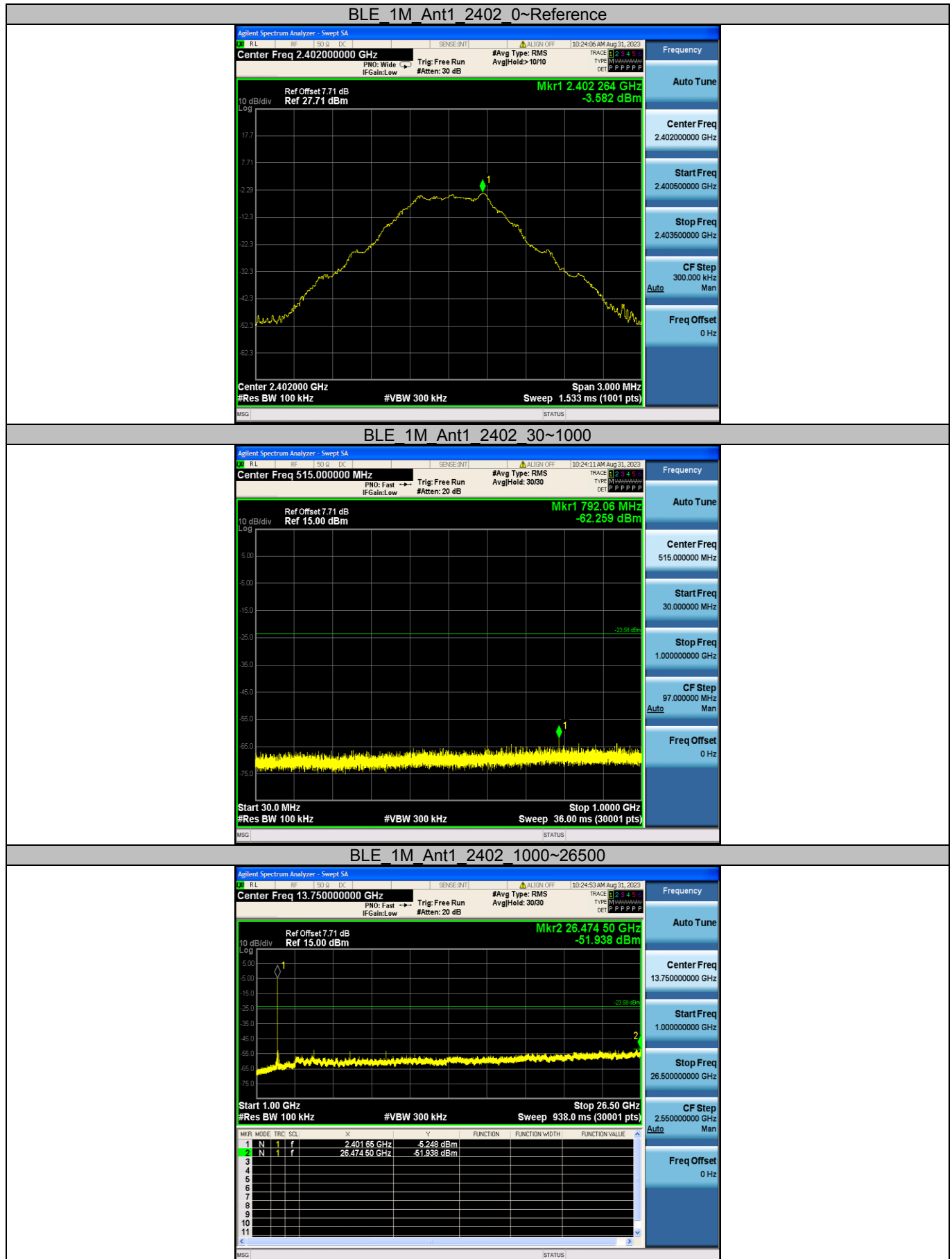

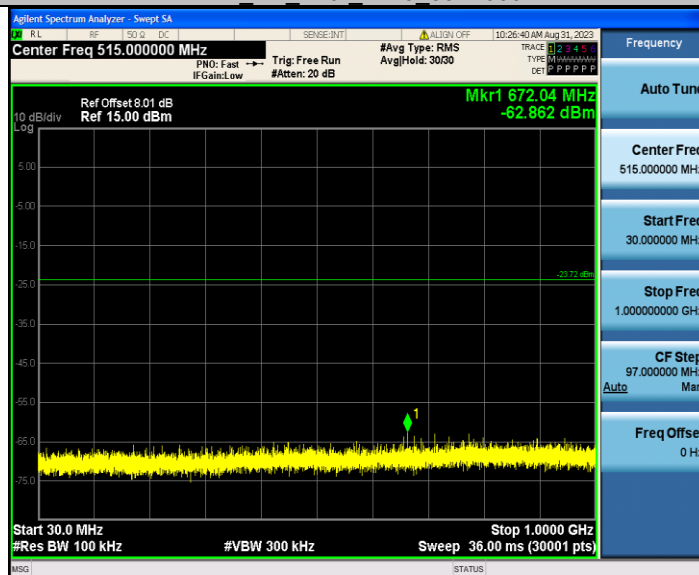

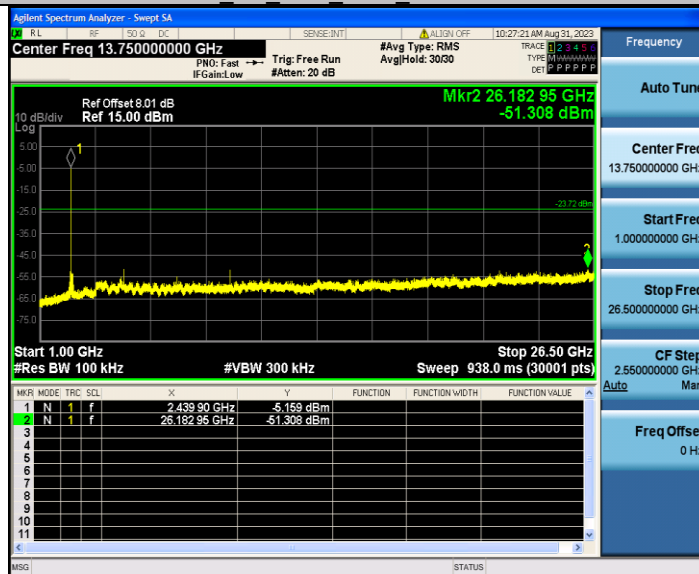
BLE 1M Ant1 2440 0~Reference



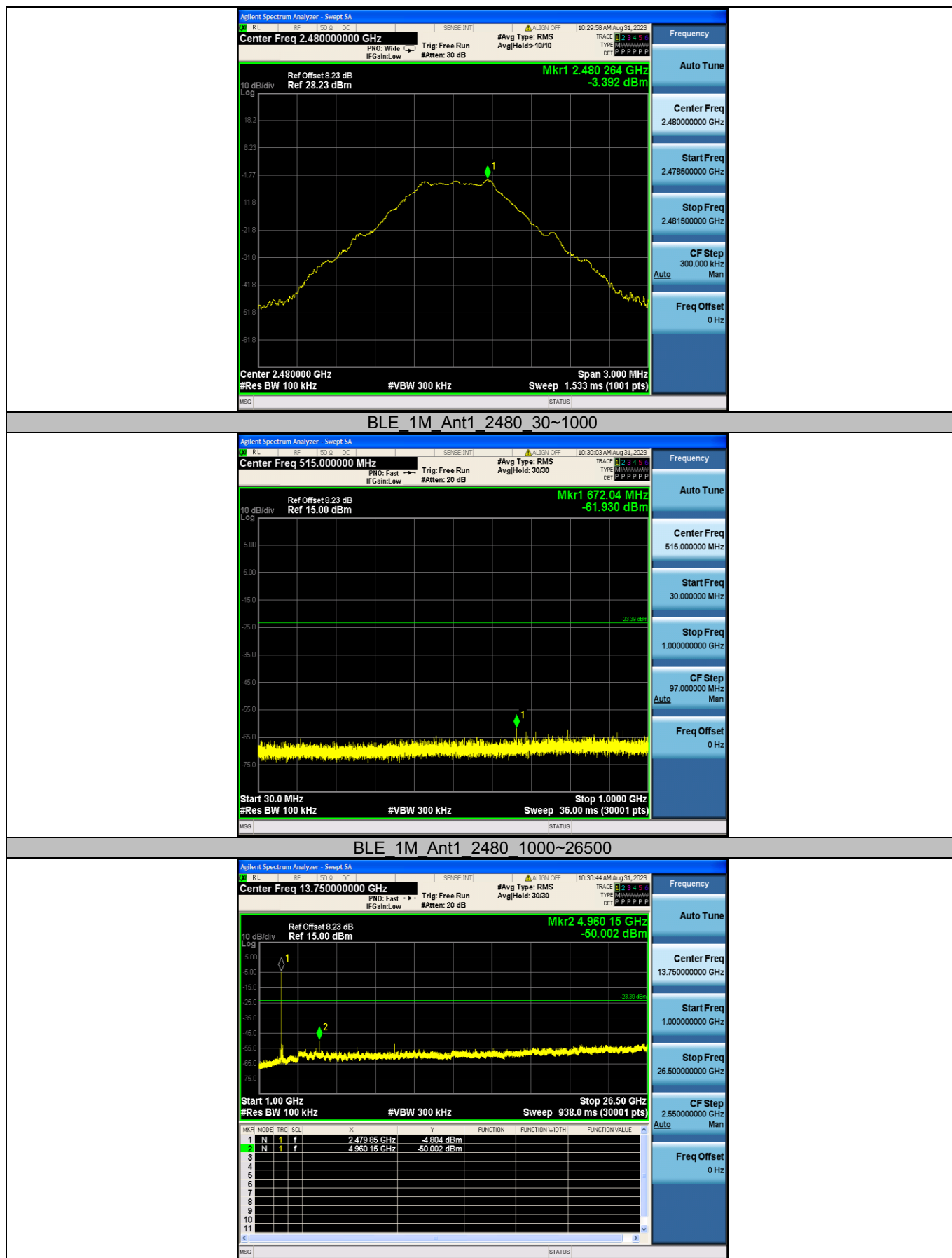
BLE 1M Ant1 2440 30~1000
