2.0 General Description

2.1 Product Description

The equipment under test (EUT) is a Wireless Ear Buds Case Heart with Bluetooth 5.0 function operating in 2402-2480MHz. The EUT is powered by DC 3.7V rechargeable battery or DC 5V through charging box. For more detail information pls. refer to the user manual.

Antenna Type: Integral antenna

Modulation Type: GFSK, $\pi/4$ -DQPSK and 8-DPSK

Antenna Gain: 1.5dBi Max

Bluetooth Version: 5.0 (Single Mode EDR)

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

Both the right and the left ear buds are same from the electrical circuit design and component layout perspective.

The Model: 1018035, 101XXXX (where XXXX can be digits 0000-9999 which represent different customers) is the same as the Model: 1015033 in hardware aspect. The difference in model number serves as marketing strategy.

2.2 Related Submittal(s) Grants

This is an application for certification of a transceiver for the Wireless Ear Buds Case Heart which has Bluetooth function, and related report for FCC SDOC is subjected to report number: 240207020SZN-002.

2.3 Test Methodology

Radiated emission measurements were performed according to the procedures in ANSI C63.10 (2013). Radiated emission measurement was performed in Semi-anechoic chamber. For radiated emission measurement, preliminary scans were performed in the semi-anechoic chamber only to determine the worst-case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application. All other measurements were made in accordance with the procedures in part 2 of CFR 47.

2.4 Test Facility

The Semi-Anechoic chamber used to collect the radiated data is **Intertek Testing Services Shenzhen Ltd. Longhua Branch** and located at 101, 201, Building B, No. 308 Wuhe Avenue, Zhangkengjing Community, GuanHu Subdistrict, LongHua District, ShenZhen, P.R. China. This test facility and site measurement data have been fully placed on file with the FCC (Registration Number: CN1188).

3.0 System Test Configuration

3.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.10 (2013).

The EUT is powered by DC 3.7V rechargeable battery during the test. Due to both the right and the left ear buds are the same from the electrical circuit design and component layout perspective, only the right ear buds were tested, only the worst-case data was shown in the report.

All packets DH1, DH3 & DH5 mode in modulation type GFSK, $\pi/4$ -DQPSK and 8-DPSK were tested and only the worst data was reported in this report.

For maximizing emissions below 30 MHz, the EUT was rotated through 360°, the centre of the loop antenna was placed 1 meter above the ground, and the antenna polarization was changed. For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Section 4.

The unit was operated standalone and placed at the center of table.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was placed on a turn table, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

3.2 EUT Exercising Software

The EUT exercise program (provided by client) used during testing was designed to exercise the various system components in a manner similar to a typical use.

4.0 Emission Results

Data is included worst-case configuration (the configuration which resulted in the highest emission levels).

4.1 Radiated Test Results

A sample calculation, configuration photographs and data tables of the emissions are included.

4.1.1 Field Strength Calculation

The field strength is calculated by adding the reading on the Spectrum Analyzer to the factors associated with preamplifiers (if any), antennas, cables, pulse desensitization and average factors (when specified limit is in average and measurements are made with peak detectors). A sample calculation is included below.

$$FS = RA + AF + CF - AG + PD + AV$$

Where

- FS = Field Strength in dB μ V/m
- RA = Receiver Amplitude (including preamplifier) in dB μ V
- CF = Cable Attenuation Factor in dB
- AF = Antenna Factor in dB
- AG = Amplifier Gain in dB
- PD = Pulse Desensitization in dB
- AV = Average Factor in -dB

In the radiated emission table which follows, the reading shown on the data table may reflect the preamplifier gain. An example of the calculations, where the reading does not reflect the preamplifier gain, follows:

$$FS = RA + AF + CF - AG + PD + AV$$

Assume a receiver reading of 62.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted. The pulse desensitization factor of the spectrum analyzer was 0 dB, and the resultant average factor was -10 dB. The net field strength for comparison to the appropriate emission limit is 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

$$\begin{aligned} RA &= 62.0 \text{ dB}\mu\text{V} \\ AF &= 7.4 \text{ dB} \\ CF &= 1.6 \text{ dB} \\ AG &= 29.0 \text{ dB} \\ PD &= 0 \text{ dB} \\ AV &= -10 \text{ dB} \\ FS &= 62 + 7.4 + 1.6 - 29 + 0 = 42 \text{ dB}\mu\text{V/m} \end{aligned}$$

$$\text{Level in } \mu\text{V/m} = \text{Common Antilogarithm } [(42 \text{ dB}\mu\text{V/m})/20] = 125.9 \mu\text{V/m}$$

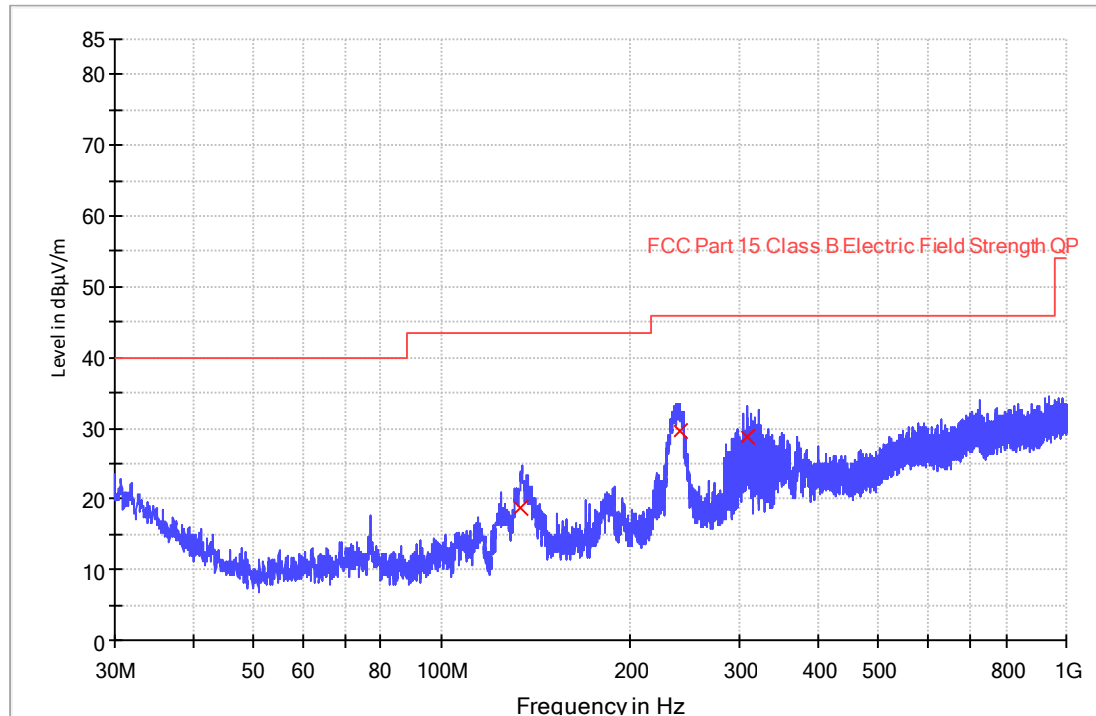

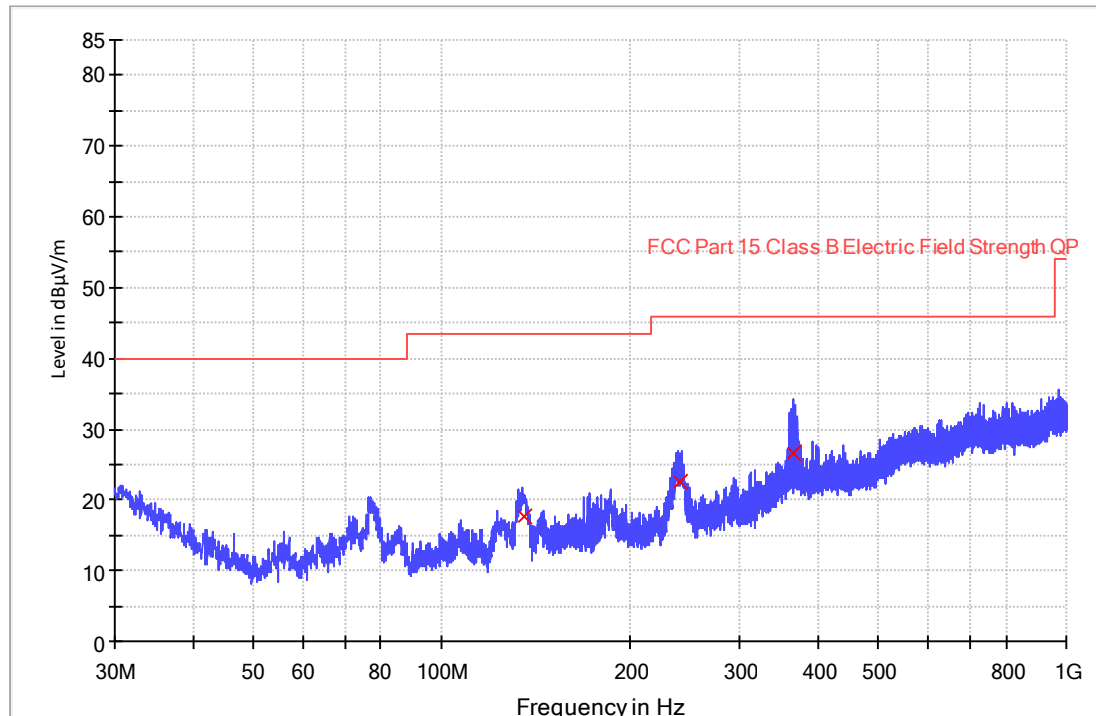

This miscellaneous information includes details of the measured bandedge, 20dB Bandwidth, the test procedure and calculation of factor such as pulse desensitization.

9.1 Bandedge Plot

The test plots are attached as below. From the below plots, the field strength of any emissions outside of the specified frequency band are attenuated to the general radiated emission limits in section 15.209. It fulfils the requirement of 15.249(d).

Peak Measurement

Bandedge compliance is determined by applying marker-delta method, i.e (Bandedge Plot).

(i) Lowest frequency channel (2402MHz):

Peak Resultant field strength = Fundamental emissions (peak value) – delta from the bandedge plot

$$\begin{aligned} &= 85.7 \text{ dB}\mu\text{V/m} - 49.44 \text{ dB} \\ &= 36.26 \text{ dB}\mu\text{V/m} \end{aligned}$$

Average Resultant field strength = Fundamental emissions (average value) – delta from the bandedge plot

$$\begin{aligned} &= 63.2 \text{ dB}\mu\text{V/m} - 49.44 \text{ dB} \\ &= 13.76 \text{ dB}\mu\text{V/m} \end{aligned}$$

(ii) Highest frequency channel (2480MHz):

Peak Resultant field strength = Fundamental emissions (peak value) – delta from the bandedge plot

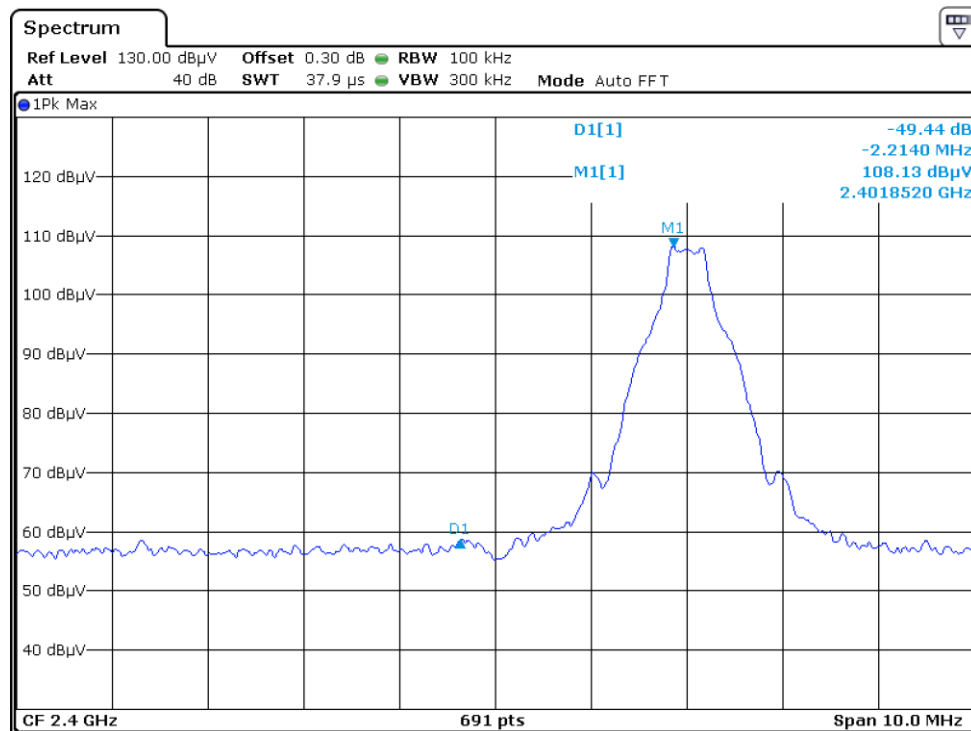
$$\begin{aligned} &= 85.5 \text{ dB}\mu\text{V/m} - 48.97 \text{ dB} \\ &= 36.53 \text{ dB}\mu\text{V/m} \end{aligned}$$

Average Resultant field strength = Fundamental emissions (average value) – delta from the bandedge plot

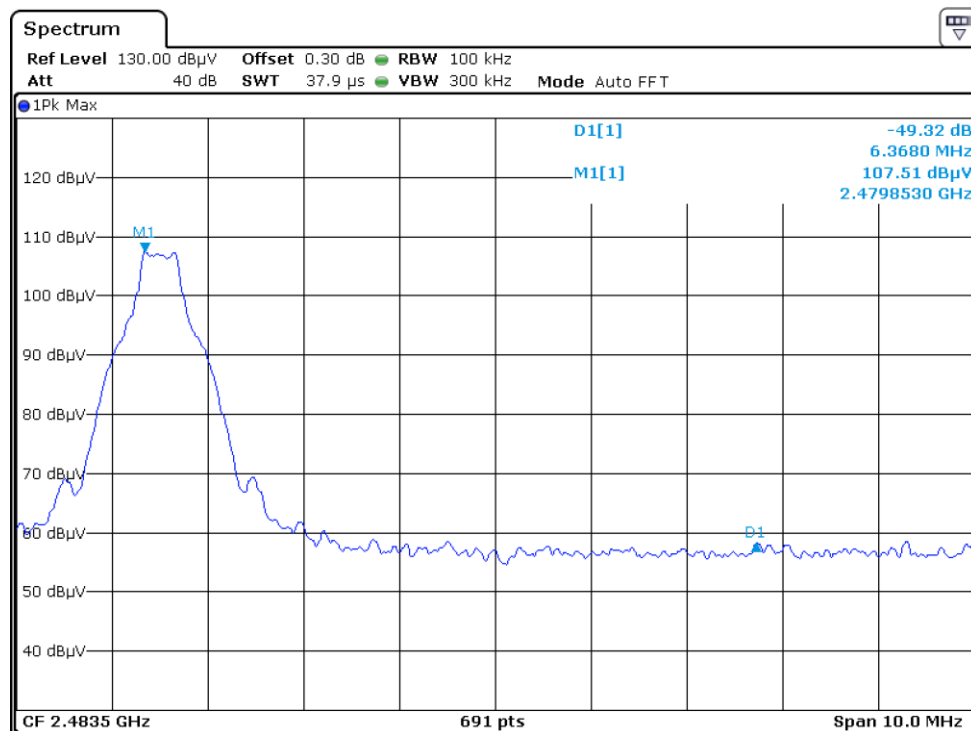
$$\begin{aligned} &= 63.0 \text{ dB}\mu\text{V/m} - 48.97 \text{ dB} \\ &= 14.03 \text{ dB}\mu\text{V/m} \end{aligned}$$

The resultant field strength meets the general radiated emission limit in section 15.209, which does not exceed 74dB μ v/m (Peak Limit) and 54dB μ v/m (Average Limit).

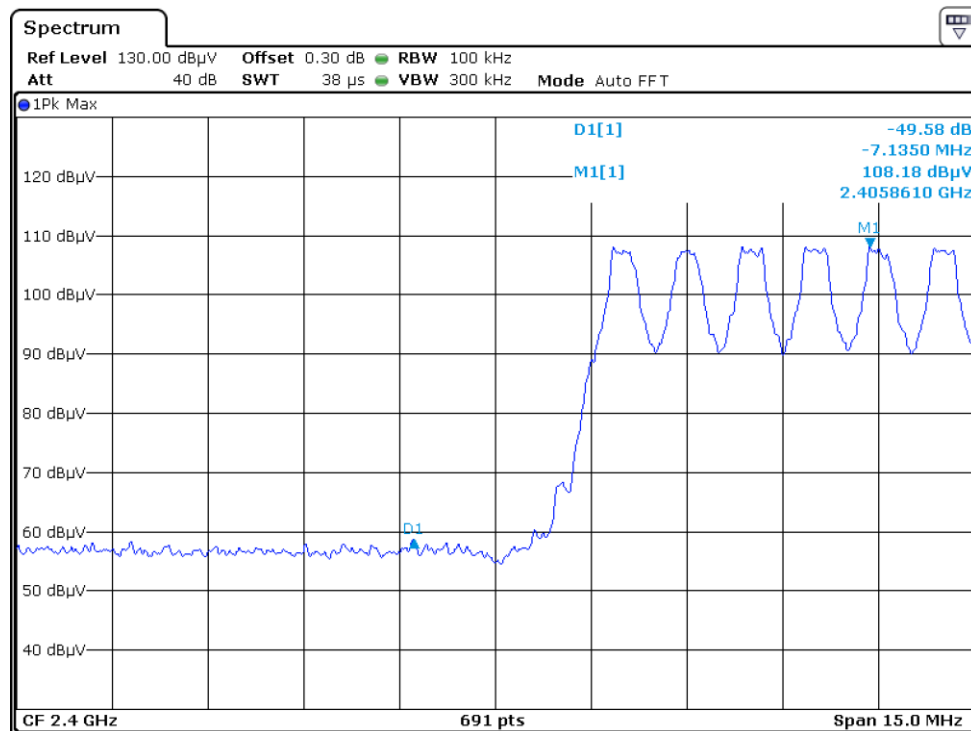
Hopping function off
Lowest frequency Channel



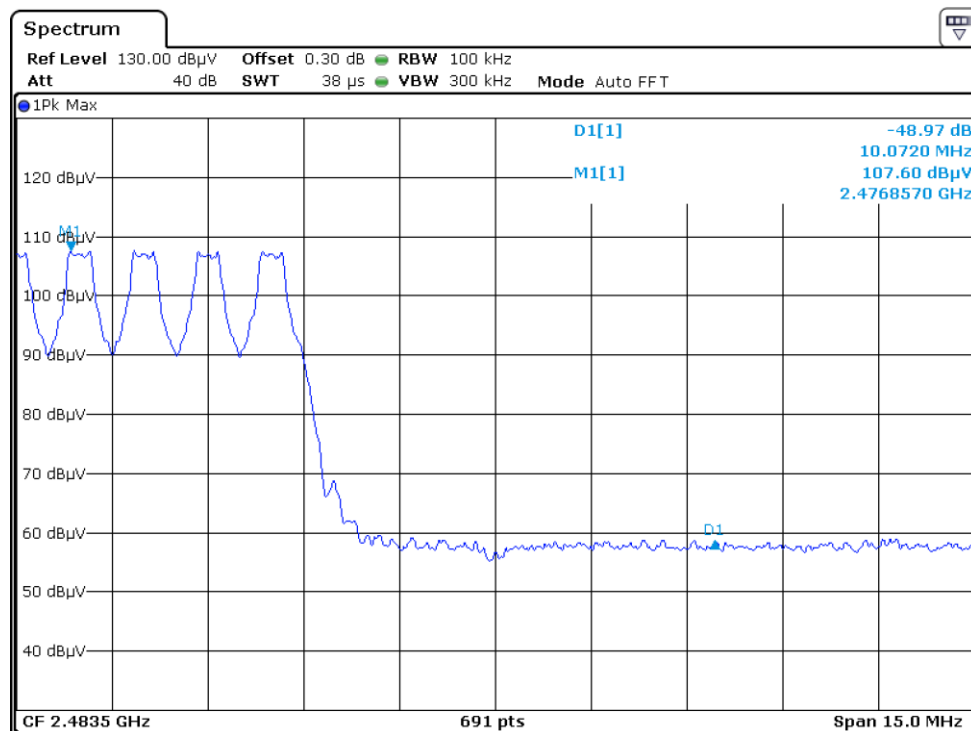
Highest frequency Channel



Hopping function on Lowest frequency Channel

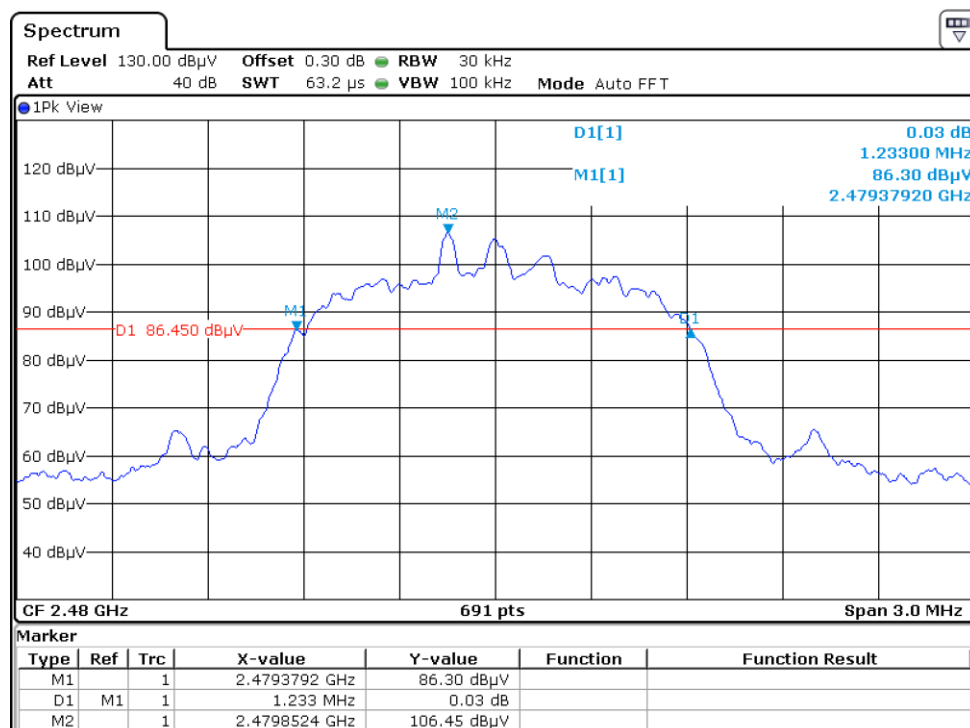
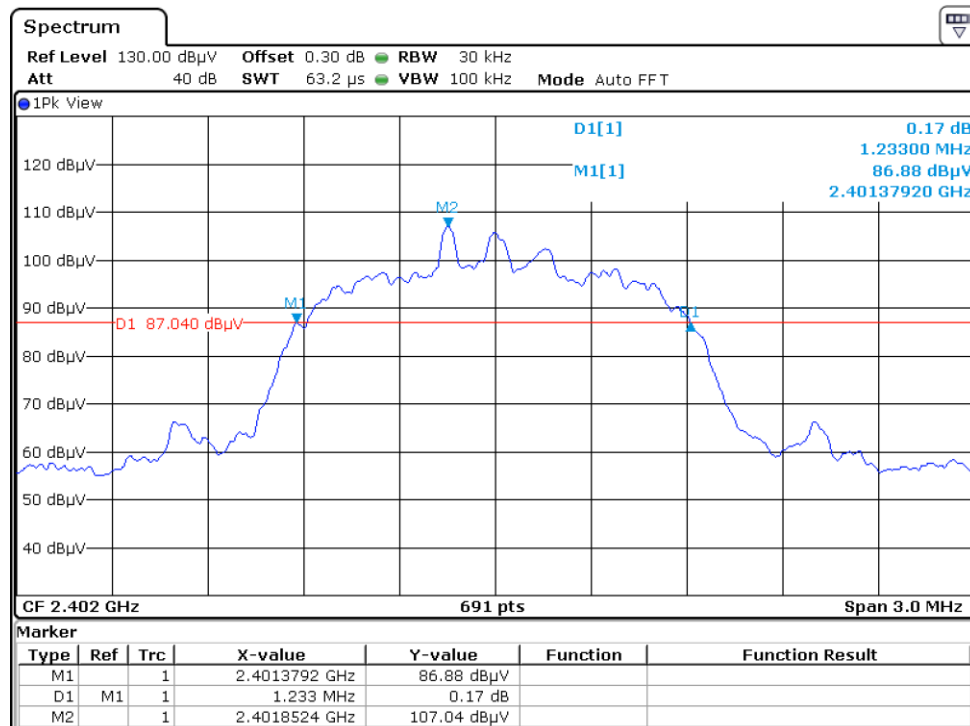


Highest frequency Channel



9.2 20dB bandwidth

Pursuant to FCC part 15 Section 15.215(c), the 20dB bandwidth of the emission was contained within the frequency band designated (mentioned as above) which the EUT operated. The effects, if any, from frequency sweeping, frequency hopping, other modulation techniques and frequency stability over excepted variations in temperature and supply voltage were considered. The test plots are reported as below.



9.3 Discussion of Pulse Desensitization

Pulse desensitivity is not applicable for this device. The effective period (T_{eff}) is approximately 625 μ s for Bluetooth. With a resolution bandwidth (3dB) of 1MHz, so the pulse desensitivity factor is 0dB.

9.4 Calculation of Average Factor

Based on the Bluetooth Specification Version 5.0 (without BLE) and worst case AFH mode, transmitter ON time is independent of packet type (DH1, DH3 and DH5) and packet length, the AFH mode Duty cycle connection factor as below:

Channel hop rate = 800 hops/second (AFH Mode)

Adjusted channel hop rate for DH5 mode = 133.33 hops/second

Time per channel hop = $1 / 133.33 \text{ hops/second} = 7.5 \text{ ms}$

Time to cycle through all channels = $7.5 \times 20 \text{ channels} = 150 \text{ ms}$

Number of times transmitter hits on one channel = $100 \text{ ms} / 150 \text{ ms} = 1 \text{ time(s)}$

Worst case dwell time = 7.5 ms

Duty cycle connection factor = $20\log_{10} (7.5\text{ms} / 100\text{ms}) = -22.5 \text{ dB}$

9.5 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services in the measurements of transmitters operating under Part 15, Subpart C rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.10 - 2013.

The transmitting equipment under test (EUT) is placed on a styrene turntable which is four feet in diameter and approximately 0.8 meter up to 1GHz and 1.5 meter above 1GHz in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjust through all three orthogonal axes to obtain maximum emission levels. The antenna height and polarization are varied during the testing to search for maximum signal levels.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in section 9.4.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

9.5 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

The IF bandwidth used for measurement of radiated signal strength was 10 kHz for emission below 30 MHz and 120 kHz for emission from 30 MHz to 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. Above 1000 MHz, a resolution bandwidth of 1 MHz is used (RBW 3MHz used for fundamental emission).

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the restricted bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, but those measurements taken at a closer distance are so marked.
