The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. Test Graph_GFSK 1Mbps Duty Cycle:



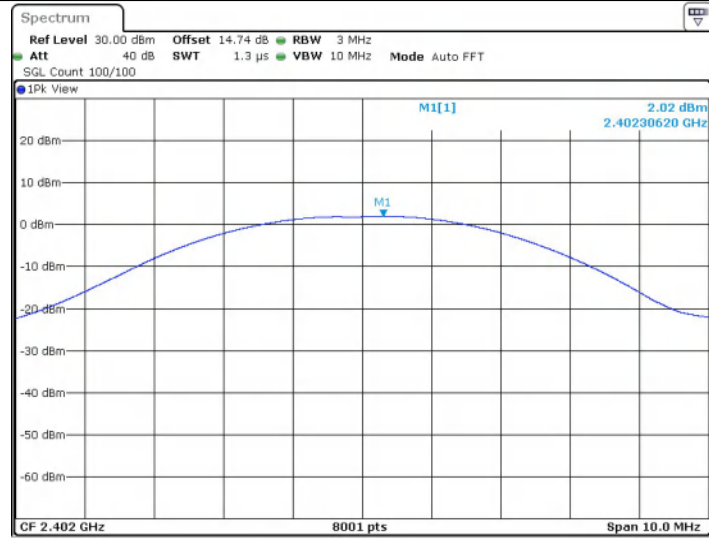
Test Graph_GFSK 2Mbps Duty Cycle:



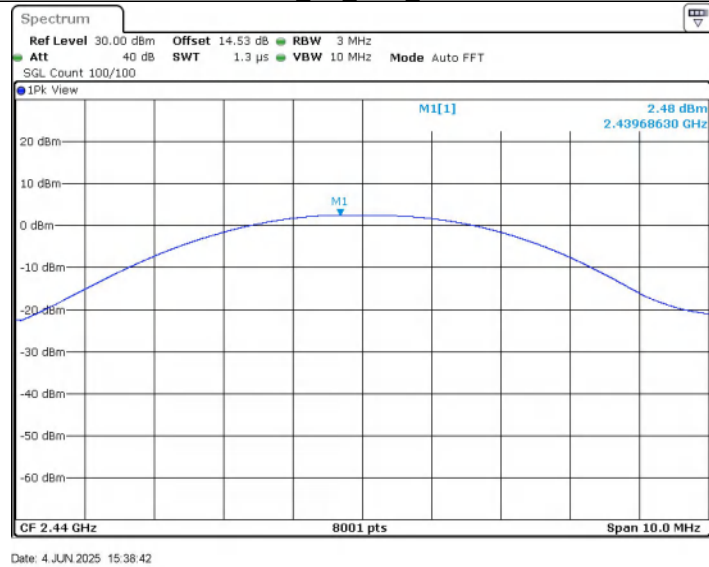

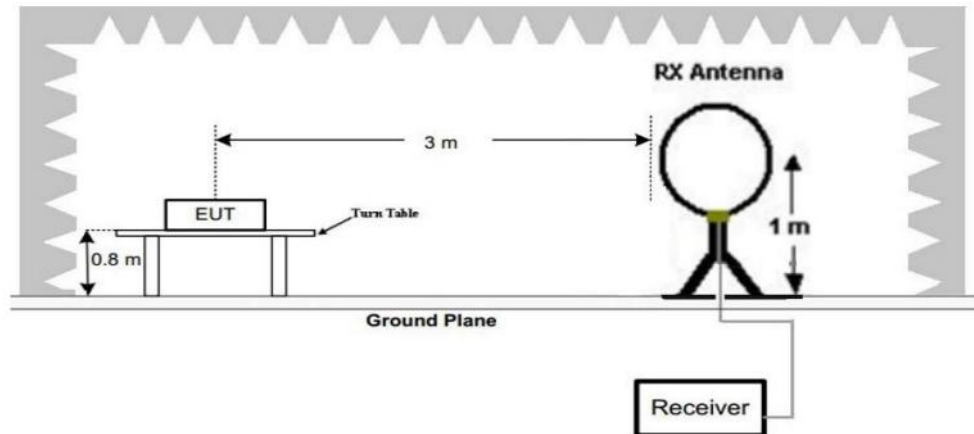


Figure 1. Below 30MHz

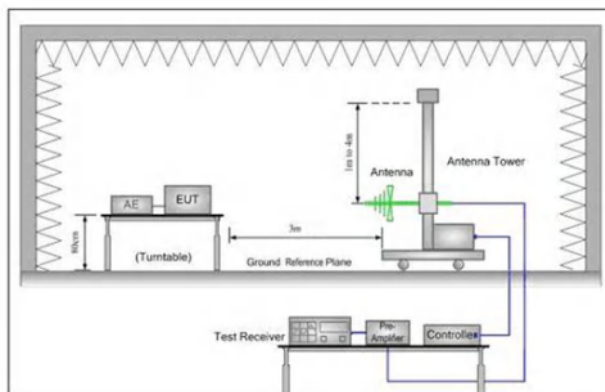


Figure 2. 30MHz to 1GHz

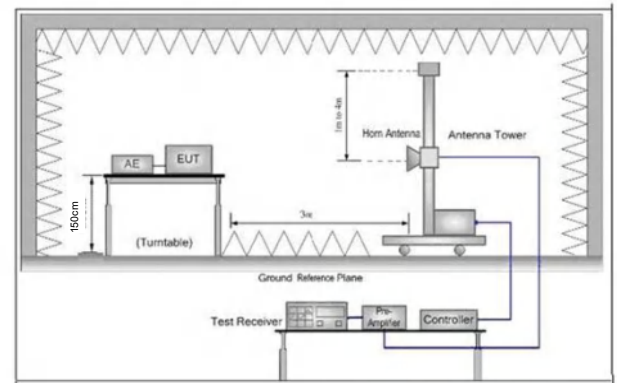


Figure 3. Above 1 GHz
