## 2.5 Receiver Input Bandwidth

The input bandwidth of the receiver is 1.3MHz, in every connection one Bluetooth device is the master and the other one is slave. The master determines the hopping sequence. The slave follows this sequence. Both devices shift between RX and TX time slot according to the clock of the master. Additionally, the type of connection (e.g. single or multi slot packet) is set up at the beginning of the connection. The master adapts its hopping frequency and its TX/RX timing according to the packet type of the connection. Also, the slave of the connection will use these settings. Repeating of a packet has no influence on the hopping sequence. The hopping sequence generated by the master of the connection will be followed in any case. That means, a repeated packet will not be send on the same frequency, it is send on the next frequency of the hopping sequence.

## 2.6 Equally Average Use of Frequencies And Behaviour

The generation of the hopping sequence in connection mode depends essentially on two input values:

1. LAP/UAP of the master of the connection.
2. Internal master clock.

The LAP (lower address part) are the 24 LSB's of the 48 BD\_ADDRESS. The BD\_ADDRESS is an unambiguous number of every Bluetooth unit. The UAP (upper address part) are the 24MSB's of the 48BD\_ADDRESS

The internal clock of a Bluetooth unit is derived from a free running clock which is never adjusted and is never turned off. For behavior action with other units only offset is used. It has no relation to the time of the day. Its resolution is at least half the RX/TX slot length of 312.5us. The clock has a cycle of about one day(23h30). In most case it is implemented as 28 bits counter. For the deriving of the hopping sequence the entire. LAP (24 bits),4LSB's(4bits) (Input 1) and the 27MSB's of the clock (Input 2) are used. With this input values different mathematical procedures (permutations, additions, XOR-operations) are performed to generate the Sequence. This will be done at the beginning of every new transmission.

Regarding short transmissions the Bluetooth system has the following behavior:

The first connection between the two devices is established, a hopping sequence was generated. For Transmitting the wanted data the complete hopping sequence was not used. The connection ended.

The second connection will be established. A new hopping sequence is generated. Due to the fact the Bluetooth clock has a different value, because the period between the two transmission is longer (and it Cannot be shorter) than the minimum resolution of the clock(312.5us). The hopping sequence will always differ from the first one.



## 2.7 Pseudorandom Frequency Hopping Sequence


The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONEs; i.e. the shift register is initialized with nine ones.

- Number of shift register stages: 9
- Length of pseudo-random sequence:  $2^9 - 1 = 511$  bits
- Longest sequence of zeros: 8 (non-inverted signal)



Linear Feedback Shift Register for Generation of The PRBS Sequence

An example of Pseudorandom Frequency Hopping Sequence as follow:



Each frequency used equally on the average by each transmitter.

The system receivers have input bandwidths that match the hopping channel bandwidths of their Corresponding transmitters and shift frequencies in synchronization with the transmitted signals.







## 6. RF Output Power Measurement

### 6.1 Provisions Applicable

The maximum out power permissible output power is 1 Watt for all frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels.

The maximum out power permissible output power is 0.125 watts for all other frequency hopping systems in the 2400-2483.5 MHz band.

### 6.2 Measurement Procedure

For peak power test:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Span: Approximately five times the 20 dB bandwidth, centered on a hopping channel.
3. RBW > 20 dB bandwidth of the emission being measured.
4. VBW  $\geq$  RBW.
5. Sweep: Auto.
6. Detector function: Peak.
7. Trace: Max hold.


8. Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission.  
The indicated level is the peak output power, after any corrections for external attenuators and cables.

For Average power test:

Measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Since this measurement is made only during the ON time of the transmitter, no duty cycle correction is required

For Average power test setup







## Test Graphs of Conducted Output Power





## Test Graphs of Occupied Bandwidth and -20 Bandwidth







## 8. Conducted Band Edge and Out-of-Band Emissions

### 8.1 Provisions Applicable


In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

### 8.2 Measurement Procedure

The testing follows the ANSI C63.10 Section 6.10.4 and 7.8.8:

- Reference level measurement
  1. Span = Wide enough to capture the peak level of the emission operating on the channel closest to the band edge, as well as any modulation products which fall outside of the authorized band of operation.
  2. RBW = 100kHz
  3. VBW = 300kHz
  4. Detector = Peak
  5. Sweep time = Auto couple
  6. Trace mode = Max hold
  7. Allow the trace to stabilize. Set the marker on the emission at the band edge, or on the highest modulation product outside of the band, if this level is greater than that at the band edge. Enable the marker-delta function, then use the marker-to-peak function to move the marker to the peak of the in-band emission.
- Emission level measurement
  1. Span = Wide enough to capture the peak level of the in-band emission and all spurious emissions (e.g., harmonics) from the lowest frequency generated in the EUT up through the 10th harmonic. Typically, several plots are required to cover this entire span.
  2. RBW = 100kHz
  3. VBW = 300kHz
  4. Detector = Peak
  5. Sweep time = Auto couple
  6. Trace mode = Max hold
  7. Trace was allowed to stabilize
  8. Set the marker on the peak of any spurious emission recorded. The level displayed must comply with the limit specified in this section.



### Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands





## 9. Radiated Spurious Emission

### 9.1 Measurement Limits

15.209 Limit in the below table has to be followed

Note: All modes were tested for restricted band radiated emission, the test records reported below are the worst result compared to other modes.

### 9.2 Measurement Procedure

1. The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emission, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz RBW and 3MHz VBW for peak reading. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average

8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High - Low scan is not required in this case.





### 9.3 Measurement Setup (Block Diagram of Configuration)


Radiated Emission Test Setup 9KHz-30MHz

















## 10. Number of Hopping Frequency Measurement

### 10.1 Provisions Applicable


This frequency hopping system must employ a minimum of 15 hopping channels.

### 10.2 Measurement Procedure

The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:

1. Span = The frequency band of operation. Depending on the number of channels the device supports, it may be necessary to divide the frequency range of operation across multiple spans, to allow the individual channels to be clearly seen.
2. RBW: To identify clearly the individual channels, set the RBW to less than 30% of the channel spacing or the 20 dB bandwidth, whichever is smaller.
3. VBW  $\geq$  RBW
4. Sweep time = Auto couple
5. Detector = Peak
6. Trace mode = Max hold
7. Allow the trace to stabilize



## 11. Time of Occupancy (Dwell Time) Measurement

### 11.1 Provisions Applicable


The maximum permissible time of occupancy is 400ms within a period of 400ms multiplied by the number of hopping channels employed.

### 11.2 Measurement Procedure

The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:

1. Span = Zero span, centered on a hopping channel.
2. RBW shall be  $\leq$  channel spacing and where possible RBW should be set  $\gg 1 / T$ , where T is the expected dwell time per channel.
3. VBW  $\geq$  RBW
4. Sweep time = As necessary to capture the entire dwell time per hopping channel
5. Detector = Peak
6. Trace mode = Free Run
7. Use the marker-delta function to determine the transmit time per hop. If this value varies with different modes of operation (data rate, modulation format, number of hopping channels, etc.), then repeat this test for each variation in transmit time. An oscilloscope may be used instead of a spectrum analyzer. The EUT shall show compliance with the appropriate regulatory limit for the number of hopping channels. A plot of the data shall be included in the test report.





Test\_Graph\_BR\_HOP\_ANT1\_NA\_1Mbps\_2402\_Number of Bursts




Test\_Graph\_BR\_HOP\_ANT1\_NA\_1Mbps\_2402\_Time per Burst


